# FAQ

**I don't hear “received network configuration information,connecting to the network now,please wait a moment”when I pair the monitor.**

Setup routers to a 2.4GHz Wi-Fi network

QR code cannot be recognized, the possible reasons are as follows:

- 1). Screen is too dark
- 2). Too far or too close from the lens
- 3). Reflection

## **How to RESET the Cheego YM300 BU?**

Press and hold the RESET button on the monitor for 5 seconds, then follow the "Reset Device Step by Step" instructions in the Simsky App, completing each step as directed.

## **What should I do if mobile phone cannot receive the notification?**

Go to mobile “setting”→“simsky”→“Allow notification”

## **What should I do if there's an echo during intercom?**

During intercom, keep the mobile phone at least 33 feet away from the device to minimize echo and howling, which are normal occurrences.

## **What should I do if the Cheego YM300 BU goes offline (device icon gray)?**

### **Suggestions:**

- 1). Please shut down your device and then reboot it.
- 2). If you have changed your Wi-Fi network, please refer to the RESET instructions to reset your monitor.

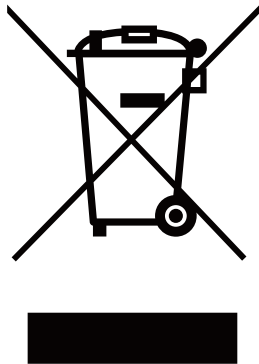
