
#### Product description:

This product is a portable charging device that can provide wired charging and wireless charging for mobile phones, tablets, e-books, game machines and other famous products. The product has the characteristics of wired charging and wireless charging in one, magnetic suction positioning, power digital display, 100W PD fast charging, three output (including wireless output), 15W wireless fast charging, etc. Product built-in FOD, overcharge, over discharge, temperature protection and other safety protection circuit.

#### Key operation instructions:

##### When checking the power:

Press the key once to start the power output function to check the remaining power of the power supply. The power display will automatically turn off after about 30 seconds.



#### When charging mobile power:

When connecting to the charging line matching the mobile power interface, the number of electric quantity display will jump, which means that the connection is normal and the power supply is charged. If there is no jump in the power indicator after connecting the charging line, it means that the connection fails and there is no charging. Please check whether the charging line is connected normally.

#### Operation instruction of wired charging and outputting:

Connect the USB charging cable to the corresponding output port of the power supply, and the power supply will automatically turn on the output. Due to compatibility problems, some smart phones need to press the key to turn on the power output function, which is a normal phenomenon and **no need to doubt**. Press the key once to supply power to the external equipment.

#### Wireless charge and output operation Instructions:

Press the key once, and the power digital display will be on. At this time, the mobile phone that supports wireless charging **will start charging** within 30 seconds. Place the mobile phone in the wireless charging area to charge the mobile phone wirelessly. If there is no wireless load access within 30 seconds, the product will automatically turn off the wireless charging function.

#### Wireless charging tips:

Wireless charging mobile phone needs to place the wireless charging area of the product (see the illustration for the wireless charging coil emission area) for wireless charging. The charging distance of this product is within 2mm. If the wireless charging distance exceeds 2mm, the wireless charging cannot be carried out. Please adjust the wireless charging distance of the mobile phone within the wireless charging range.



#### Charge the product:

Use the power adapter / computer USB port to charge the local wireless charging mobile power supply. The type-C charging cable can be used to plug into the type-C input port of the wireless charging mobile power supply to charge the mobile power supply. Connect the one connector to the charge or the USB port of the computer, and the number of the power indicator will start to jump, indicating that the product is being charged. When it is fully charged, the digital display will display "100".

#### Use this product to charge mobile phones or other digital devices:

1. Check whether the charging voltage of the digital product matches the output voltage of the power supply. The type-C charging cable can be used to plug into the type-C input port of the wireless charging mobile power supply to charge the mobile power supply. 2. Select the original charging cable of the digital product, one end is connected with the digital product, and the other end is connected with the output port of the product. The wired output terminal of the product will automatically turn on to charge the mobile phone or other digital products, and the digital display screen will always be on. 3. Charge the mobile phone with wireless charging function, press the key once, and the digital display will light up. At this time, wireless charging can be supported. Put the mobile phone with wireless charging function in the center of wireless charging of mobile power supply, and the mobile phone can be charged at this time, and the digital display will be always on.

#### Reminder:

Please read all instructions and warnings before using this product. Improper use will damage the product or personal safety.

1. Please make sure that the charging contact surface on the back of the mobile phone does not contain metal substances, such as iron sheet, ring, metal protective case, etc. 2. When the mobile phone is charging, if intermittent charging or serious heating is found, it is likely that the receiving coil of the mobile phone is not fully aligned with the wireless charging coil, and there are metal foreign bodies in the protective sleeve of the mobile phone. Please try to cool the mobile phone, remove the protective sleeve, and then align it in the normal position. 3. This product has over-current protection function. If the product is used improperly, it will turn off or reduce the output power to reduce the charging speed and ensure safety. Please check whether the equipment is used improperly or not.
