Requirement of Public Notice 15.212	Reference to P301-D.
1. The modular transmitter must have its own RF shielding.	The module have its own RF shielding. Please see external photo.pdf
2. The modular transmitter must have buffered modulation/data inputs.	The modular has buffered data inputs, it is integrated in chip U9106. Please see schematic.pdf
3. The modular transmitter must have its own power supply regulation.	All power lines derived from the host device are regulated before energizing other circuits internal to the U9106. Please see schematic.pdf
4. The modular transmitter must comply with the antenna requirements of Section 15.203 and 15.204(c).	The P301-D meets the FCC antenna requirements. The device is unique 'antenna connector, and type is IPEX. For details, see the external photo file.
5. The modular transmitter must be tested in a stand-alone configuration, i.e., the module must not be inside another device during testing.	The P301-D was tested in a stand-alone configuration via a PCMCIA extender. Please see conducted set-up photo.pdf and spurious set-up.
6. The modular transmitter must be labeled with its own FCC ID number, and, if the FCC ID is not visible when the module is installed inside another device, then the outside of the device into which the module is installed must also display a label referring to the enclosed module.	The label position of P301-D is clearly indicated. If the FCC ID of the module cannot be seen when it is installed, then the host label must include the text: Contains FCC ID: 2A9XO-ARLINK-P301-D. The modular transmitter must comply with any specific rule or operating requirements applicable to the transmitter and the manufacturer must provide adequate instructions along with the module to explain any such requirements. A copy of these instructions must be included in the application for equipment authorization.	The P301-D is compliant with all applicable FCC rules. Detail instructions are given in the Users Manual.
8. The modular transmitter must comply with any applicable RF exposure requirements.
