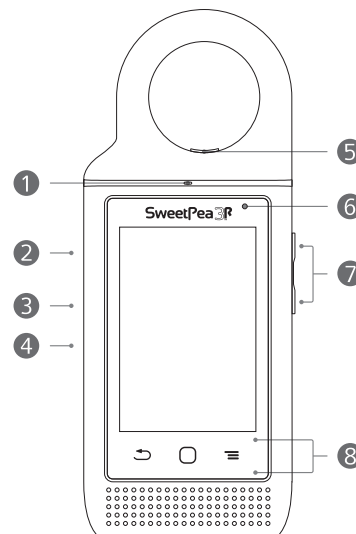

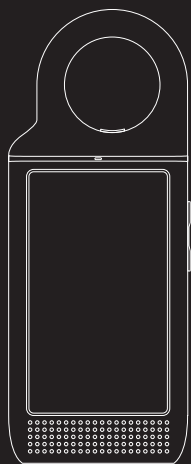

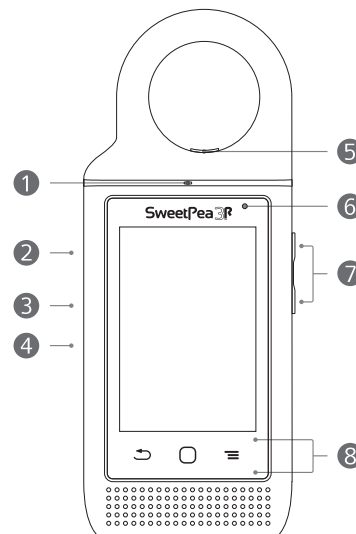

# Safety and Warranty

This product complies with the radio interference requirements of the European Union.

The model and production numbers can be found on the back of the unit.

### Hearing Safety

The SweetPea3R speaker volume levels are safe during normal operation. Prolonged exposure to the speaker at very close proximity could lead to hearing damage now or later in your child's life.

- Do not allow your child to sleep holding the SweetPea3R. The speaker could fall too close to the ear for a prolonged period.
- Do not allow your child to hold the speaker directly to their ear for a prolonged period of time.
- Do not use headphones for children under age 6. Older children may use headphones occasionally for very short lengths of time (less than 20 minutes).
- Do not allow your child to use headphones if the maximum headphone volume is set higher than 6. Settings higher than 6 are not intended for use by children. Using headphones at a high volume can impair you or your child's hearing. This product can produce sounds in decibel ranges that may cause hearing loss, even for exposure less than a minute. The higher decibel ranges are offered for those that may have already experienced some hearing loss. The default maximum volume setting shipped with the player does not produce harmful sounds. Use extreme care when increasing the maximum volume setting.
- Sound can be deceiving. Over time your hearing comfort level adapts to higher volumes of sound. So after prolonged listening, what sounds normal can actually be loud and harmful to your hearing. To guard against this, set your volume to a safe level before your hearing adapts and leave it there.
- To establish a safe volume level, set your volume control at a low setting. Slowly increase the sound until you can hear it comfortably and clearly. Set this volume to the maximum volume from within the settings menu.
- Prolonged exposure to sound, even at normally safe levels, can also cause hearing loss.

### General Safety

- Do not allow children under age 6 to use headphones because they may not hear warning sounds in their environment.
- Do not allow your child to play with the SweetPea3R while it is plugged into a USB port or charger.
- Do not expose the battery to excessive heat, such as in parked cars on hot days, direct sunlight or open flame.
- Do not impede the ventilation openings of the SweetPea3R with blankets or similar objects. Allow a clearance of 10cm around the SweetPea3R.
- Keep the SweetPea3R away from liquids. Avoid direct spray of liquids.
- Do not allow your child to play with the SweetPea3R in water such as a bath or pool
- Clean with a mild detergent and a soft damp cloth. Never use solvents.
- Do not open the SweetPea3R. There are no user serviceable parts inside.
- Follow proper battery disposal according to local regulations.

# FCC Information

# Warranty

### WHO IS COVERED

SweetPea Toy Company (SPTC) warrants the product to the original purchaser or the person receiving the product as a gift against defects in materials and workmanship as based on the date of original purchase ("Warranty Period") from an authorized dealer. The original sales receipt showing the product name and the purchase date from an authorized retailer is considered such proof.

### Body-worn Operation

This device was tested for typical body-worn operations. To comply with RF exposure requirements, a minimum separation distance of 5mm must be maintained between the user's body and the handset, including the antenna. Third-party belt-clips, holsters, and similar accessories used by this device should not contain any metallic components. Body-worn accessories that do not meet these requirements may not comply with RF exposure requirements and should be avoided. Use only the supplied or an approved antenna.

### WHAT IS COVERED

The warranty covers new products if a defect in material or workmanship occurs and a valid claim is received by SPTC within the Warranty Period. At its option, SPTC will either (1) repair the product at no charge, using new or refurbished replacement parts, or (2) exchange the product with a product that is new or which has been manufactured from new, or serviceable used parts and is at least functionally equivalent or most comparable to the original product in the SPTC current inventory, or (3) refund the original purchase price of the product. SPTC warrants replacement products or parts provided under this warranty against defects in materials and workmanship from the date of the replacement or repair for 1 year. When a product or part is exchanged, any replacement item becomes your property and the replaced item becomes SPTC's property. When a refund is given, your product becomes SPTC's property.

**Note: Any product sold and identified as refurbished or renewed carries a 90 day limited warranty.**

Replacement product can only be sent if all warranty requirements are met. Failure to follow all requirements can result in delay.
