

### Operating Procedures

#### Step1. Batteries

Properly insert one AAA battery into the pen.

#### Step2. Power on

Hold down the power button for three seconds. When the green power light illuminates, the device is on.

#### Step3. Mode

There are two modes: IRS and MOD. The mode is changed each time the mode button is pressed. The pen is automatically set to IRS when the pen is turned on.

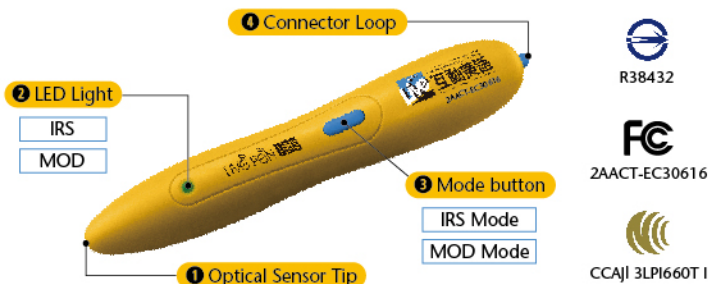
#### Step4. Setting

Use the setting card to do ID setting. The pen will emit a beeping sound after the new settings have been made.

#### Step5. Power off

Hold down the power button for three seconds. When the power light goes off, the device has shut down.

### Feature Explanation



- Optical Sensor Tip:** The pen contains a high-quality optical sensor tip. Do not strike or touch the pen tip
- Indicator Light:** LED light indicates the mode and battery level

- Mode button:** One mode button for both settings

### Operating Procedures

#### Batteries

- Please use rechargeable or alkaline batteries for best performance.
- To prevent leakage, remove batteries when the device will be out of use for an extended period of time.
- Batteries should be changed by an adult or under the supervision of an adult to prevent harm to children.

#### Use

- For best performance, hold the pen tip against the book cover or page at a 70 degree angle.
- Sensor points are located on the covers and pages of books in the LivePen series. Do not scratch, stain or mark these areas.

#### Storage

- Properly store the device when not in use to prevent accidental damage.
- Do not place the pen in hot or damp areas or allow liquids to come into contact with the pen tip.
- The optical pen tip contains high-tech precision components. Do not place objects inside the pen tip or puncture the tip with sharp objects.
