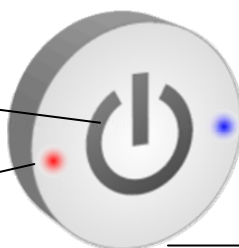
Status Indicator

Status	LED Lights	Buzzer
ON/OFF	Red & Blue LED flash once.	Single Beep once
Waiting	Blue LED flashes rapidly	No
Connected	Blue LED flashes slowly and intermittently.	No
Disconnected	Red and Blue LED flash rapidly, continue for 10 sec.	Double Beep repeatedly
Low battery	Red LED flashes rapidly, and it lasts for 20 sec then power off.	Triple Beep once
Charging	Red LED stays power on till charging completed.	No

ON/OFF Button:

- Press and hold 5 sec. for power on/off;
- Press once to turn off the buzzer sound.

Turn on Remind.U device also the Bluetooth function of your mobile phone, search for a device named "**Remind.U**" and then click to establish connection. Some phones may request PIN code, please enter "**0000**" to complete the devices pairing for the very first time, and afterwards require no more pairing.
