

- a). End User Devices may operate only if they can positively receive and decode an authorization signal transmitted by a CBSD, including the frequencies and power limits for their operation.
- b). An End User Device must discontinue operations, change frequencies, or change its operational power level within 10 seconds of receiving instructions from its associated CBSD.

### **6.4 Test Procedure**

Following procedure can be done by applying WINNF-TS-0122-V1.0.1 CBRS CBSD Test Specification, use the certified Baicell CBSD (FCC ID: 2AG32PBS3101S) as companion device to show compliance with Part 96.47 requirement for End User Device (EUD):

1. Setup with frequency 3590-3610MHz and power level 18dBm/MHz;
2. Enable CBSD service;
3. Check EUD Tx Frequency and power;
4. Disable AP service;
5. Check EUD stops transmission within 10seconds;
6. Setup with 3610-3630MHz & power level 8dBm/MHz;
7. Enable CBSD service;
8. Check EUD Tx Frequency and power;
9. Disable CBSD service;
10. Check EUD stops transmission within 10seconds.







[Step 5] EUD stops transmission within 10 seconds of receiving instructions from its associated CBSD.




