**Battery Installation**

1. Take off the battery cover of R/C car, instal 7.4V rechargeable battery pack, fasten the cover, turn the switch to 'on'
2. Open the battery cover of transmitter, instal 2x1.5V "AA" batteries, close the cover.
3. The charging time is about 2.5 hours support about 20 minutes playing.

**The Basic Operation of The Products**


2. Push or pull the trigger of the transmitter to make the car drive forward or backward. (Push or pull it slowly in order to prevent the car runs out abruptly).



3. Turn the steering wheel clockwise, the car will flip and roll to right.




4. Turn the steering wheel counterclockwise, the car will flip and roll to left.

BATTERY SAFETY

- (1) The placement or replacement of batteries is to be performed by an adult.
- (2) Remove the rechargeable battery from the chassis before charging.
- (3) Always remove exhausted batteries from the car and the transmitter.
- (4) Make sure the main switch is set to OFF before installing the battery pack into the car body.
- (5) Batteries must be inserted with the correct polarity.
- (6) Non-chargeable batteries shall not be recharged.
- (7) Do not short-circuit the batteries.
- (8) Always remove the batteries from the car and the transmitter after playing.
- (9) Never throw the batteries into fire to avoid explosion or leakage.
- (10) Do not mix batteries from different producers or new and old batteries.
- (11) You should only use batteries of the same or equivalent types as recommended.
- (12) Check the batteries on a regular basis to avoid leakage.
