5 SAR Evaluation

5.1 RF Exposure Compliance Requirement

5.1.1 Standard Requirement

According to KDB447498D01 General RF Exposure Guidance v05r02

4.3.1. Standalone SAR test exclusion considerations

Unless specifically required by the published RF exposure KDB procedures, standalone 1-g head or body and 10-g extremity SAR evaluation for general population exposure conditions, by measurement or numerical simulation, is not required when the corresponding SAR Exclusion Threshold condition, listed below, is satisfied.

5.1.2 Limits

At frequencies below 100 MHz, the following may be considered for SAR test exclusion:

- a) The power threshold at the corresponding test separation distance at 100 MHz in below step 1) is multiplied by $[1 + \log(100/f(MHz))]$ for test separation distances > 50 mm and < 200 mm
- b) The power threshold determined by the equation in a) for 50 mm and 100 MHz is multiplied by $\frac{1}{2}$ for test separation distances \leq 50 mm.
- 1) [Power allowed at numeric threshold for 50 mm in step 1) + (test separation distance 50 mm)·(f(MHz)/150)] mW, at 100 MHz to 1500 MHz

5.1.3 EUT RF Exposure

The maximum conducted output power specified is -43.0dbm=0.5*10⁻⁴ mW

The source- based time-averaging conducted output power

=0.00005 * Duty Cycle mW= 0.000016mW

The SAR Exclusion Threshold Level for 27.145MHz when the minimum test separation distance is < 50mm:

- = 474 * [1 + log(100/f(MHz)]/2
- = 371.2mw

Since the source-based time-averaging conducted output power is well below the SAR low threshold level, so the EUT is considered to comply with SAR requirement without testing.
