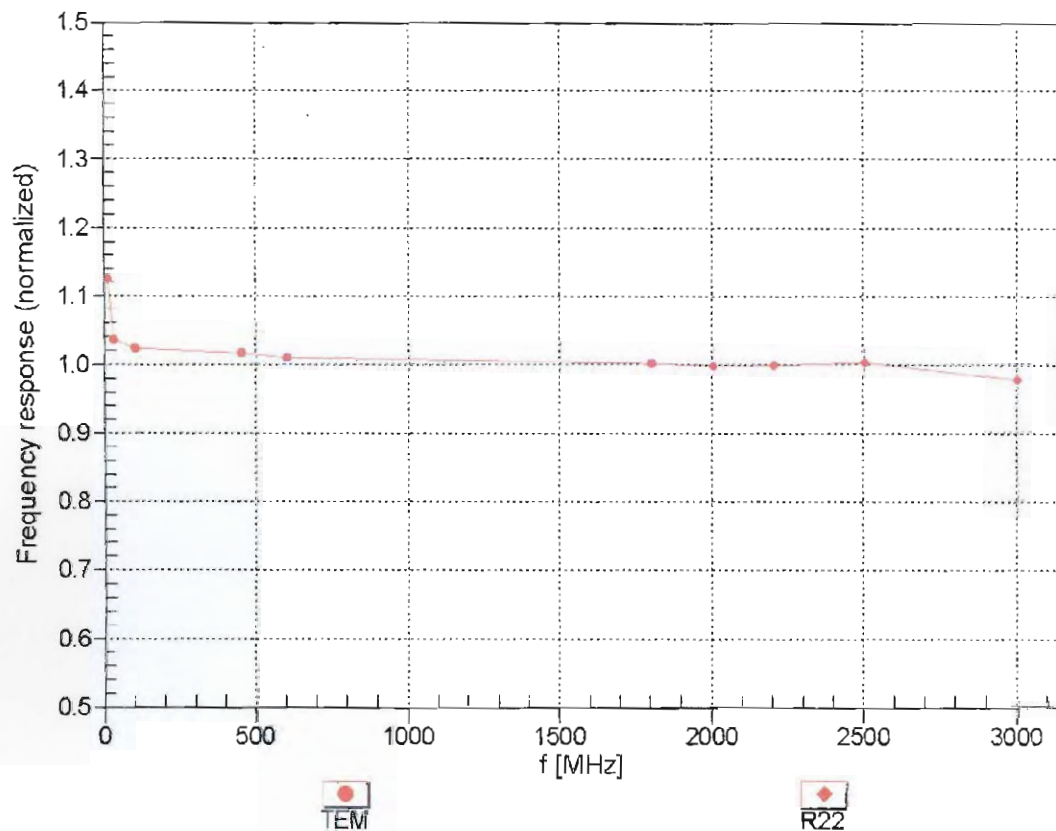

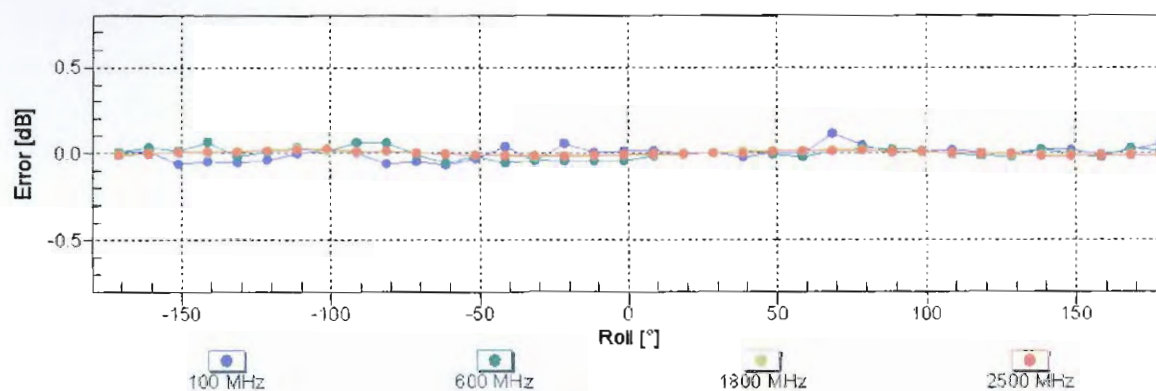
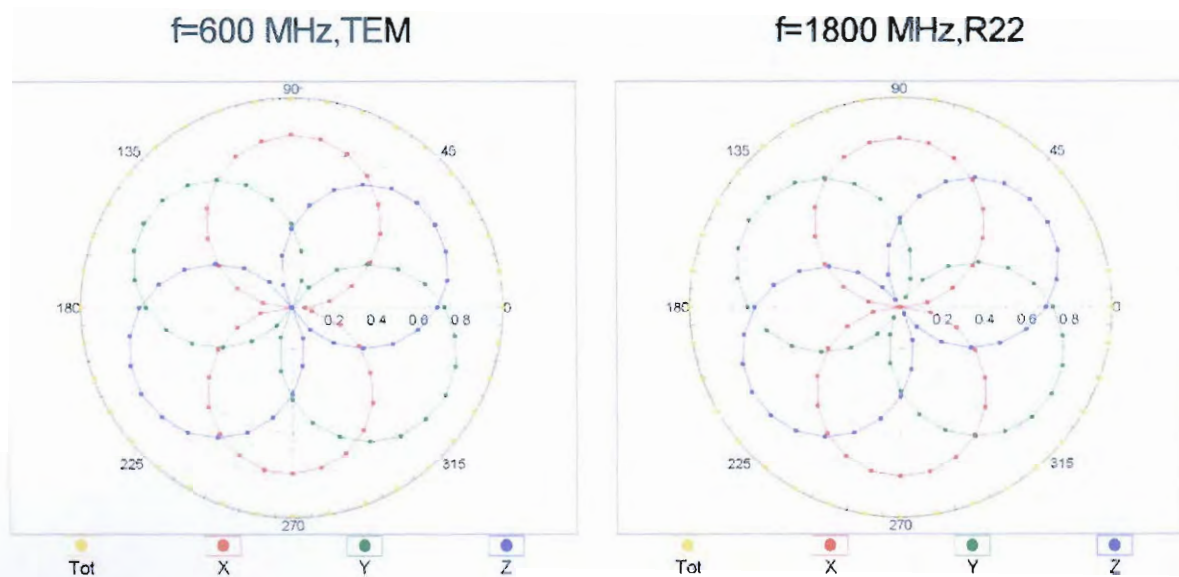
## Frequency Response of E-Field

## Receiving Pattern ( $\phi$ ), $\theta = 0^\circ$

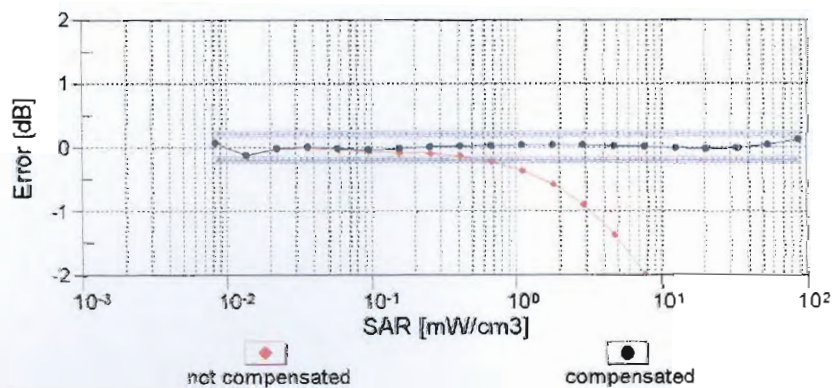
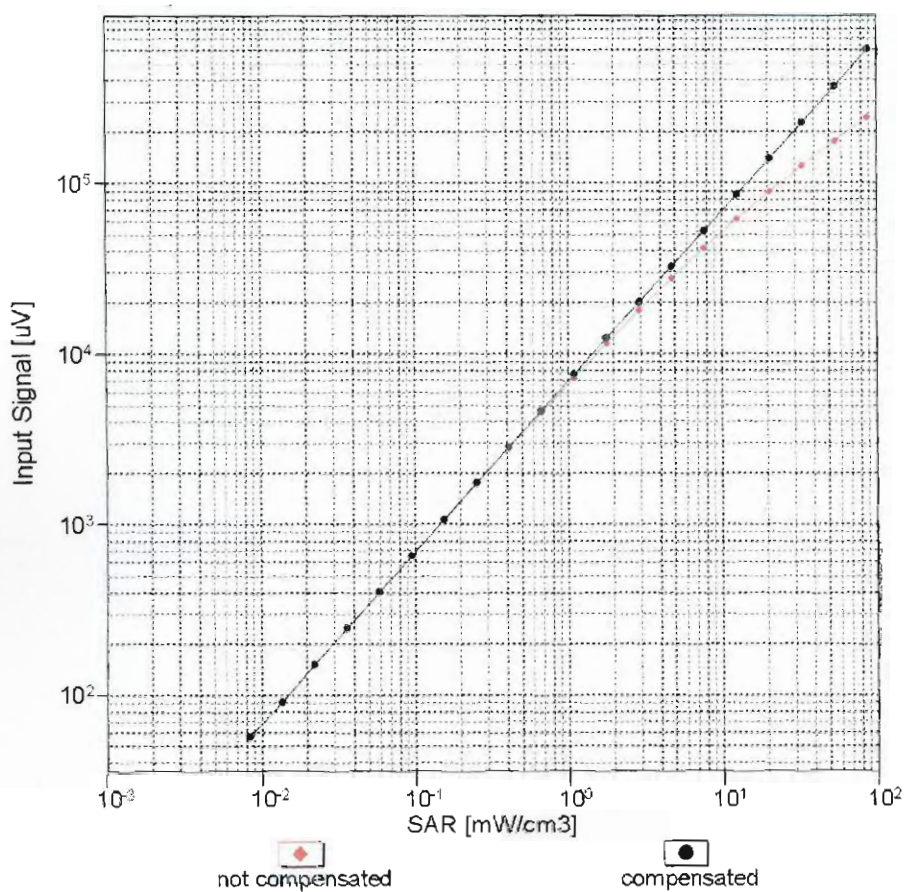


**Uncertainty of Axial Isotropy Assessment:  $\pm 0.5\%$  ( $k=2$ )**



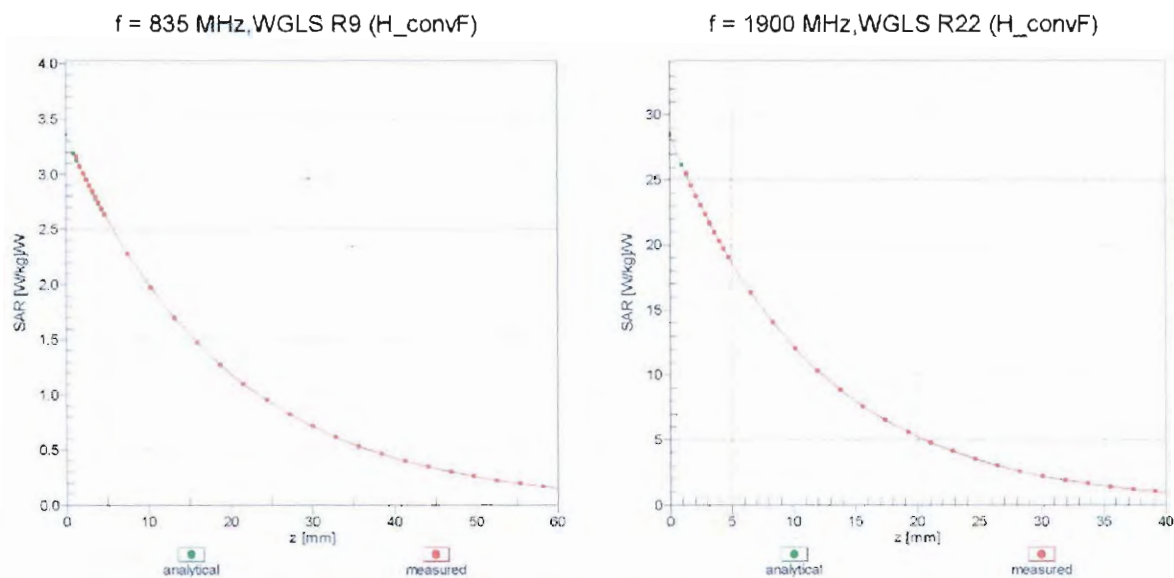
## Dynamic Range f(SAR<sub>head</sub>)

(TEM cell , f = 900 MHz)



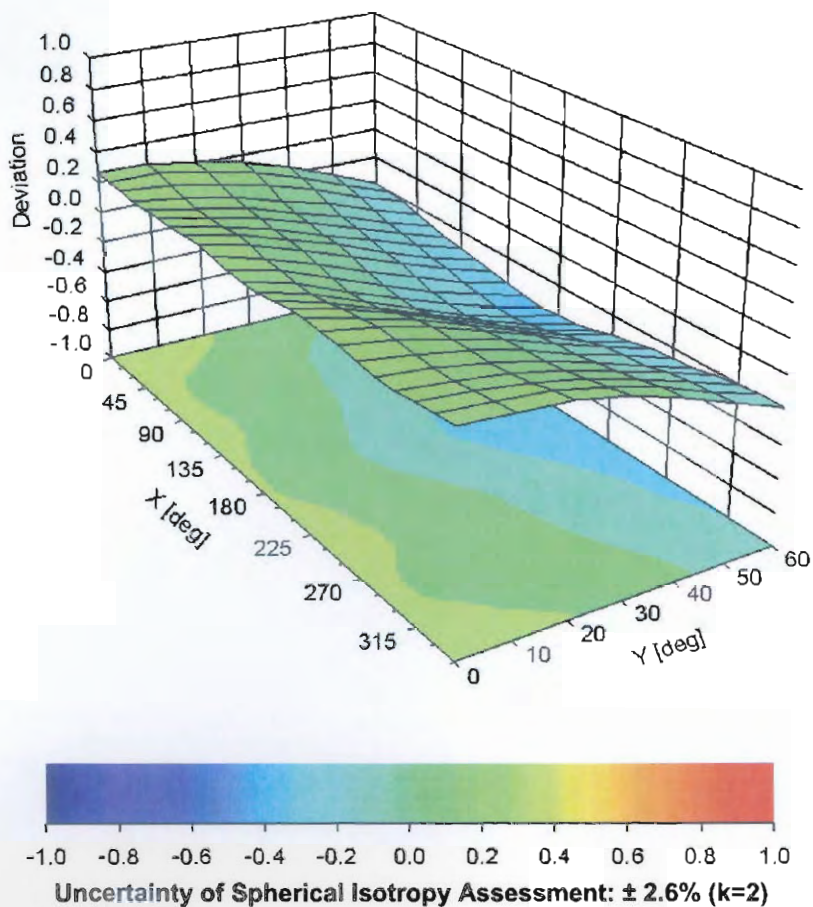
Uncertainty of Linearity Assessment:  $\pm 0.6\%$  (k=2)

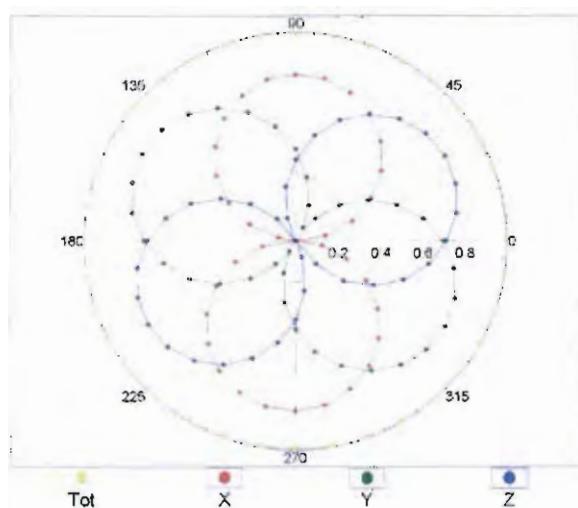

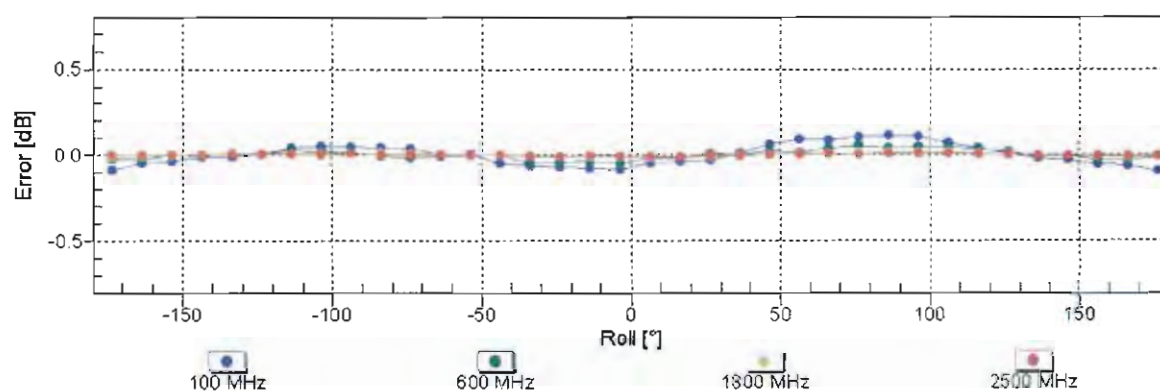
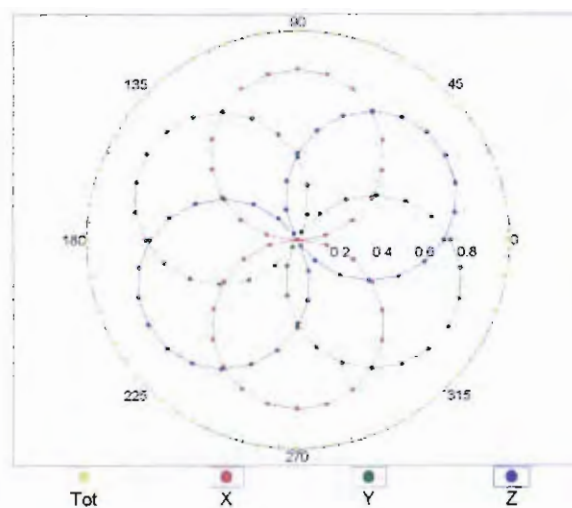
Uncertainty of Frequency Response of E-field:  $\pm 6.3\%$  ( $k=2$ )

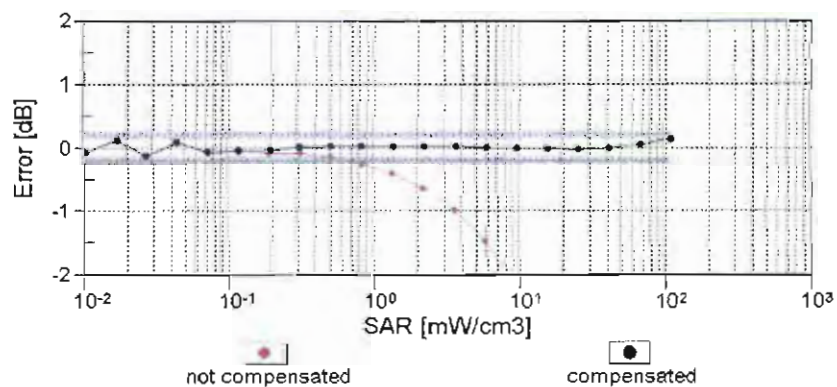
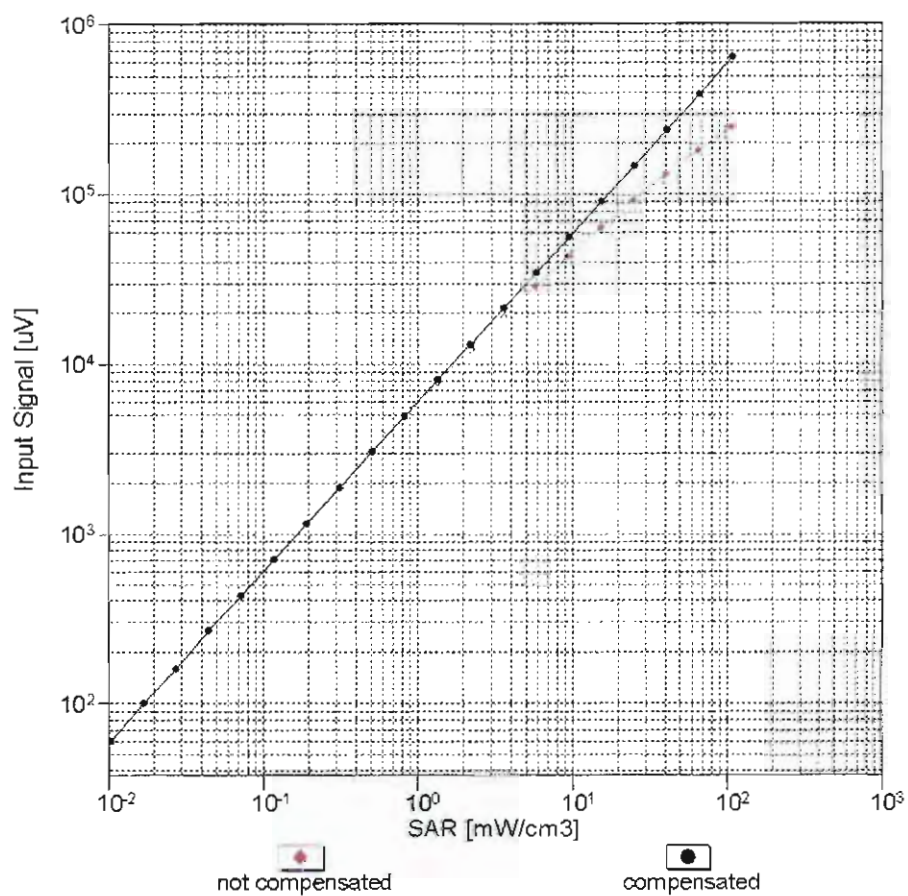

Uncertainty of Axial Isotropy Assessment:  $\pm 0.5\%$  ( $k=2$ )

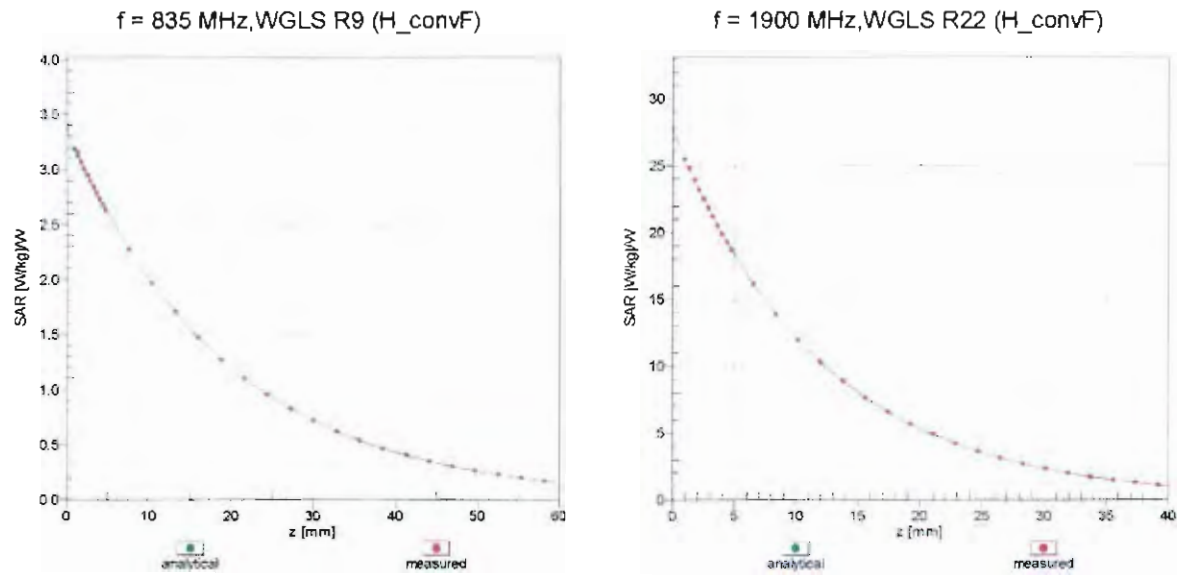
## Dynamic Range $f(\text{SAR}_{\text{head}})$ (TEM cell , $f = 900 \text{ MHz}$ )



Uncertainty of Linearity Assessment:  $\pm 0.6\%$  ( $k=2$ )

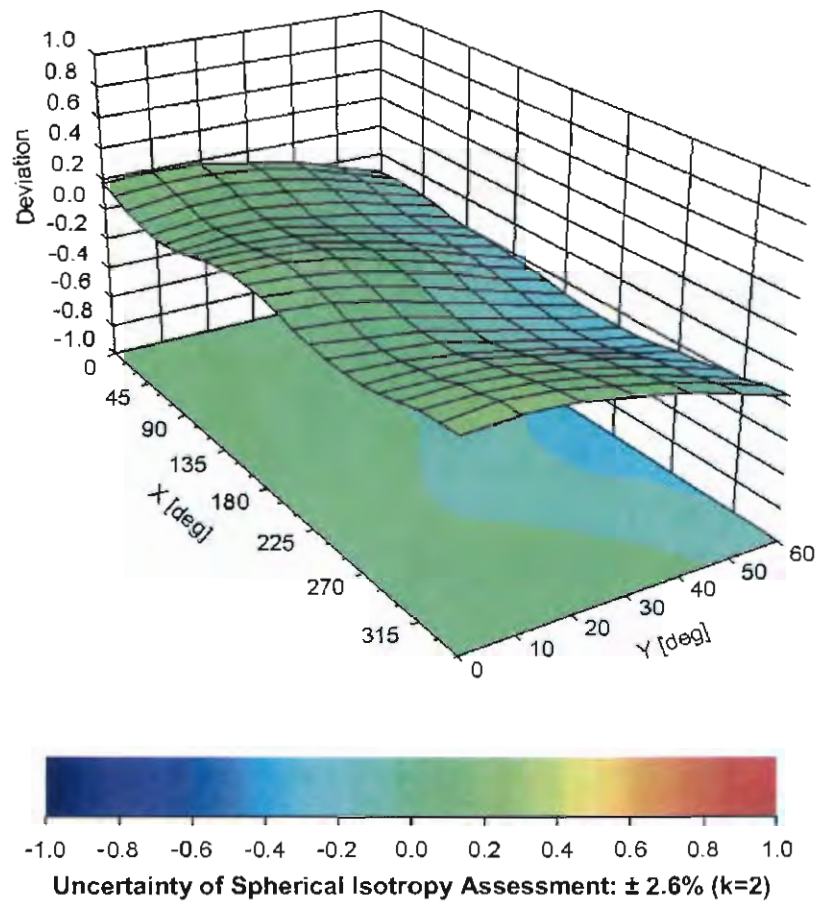

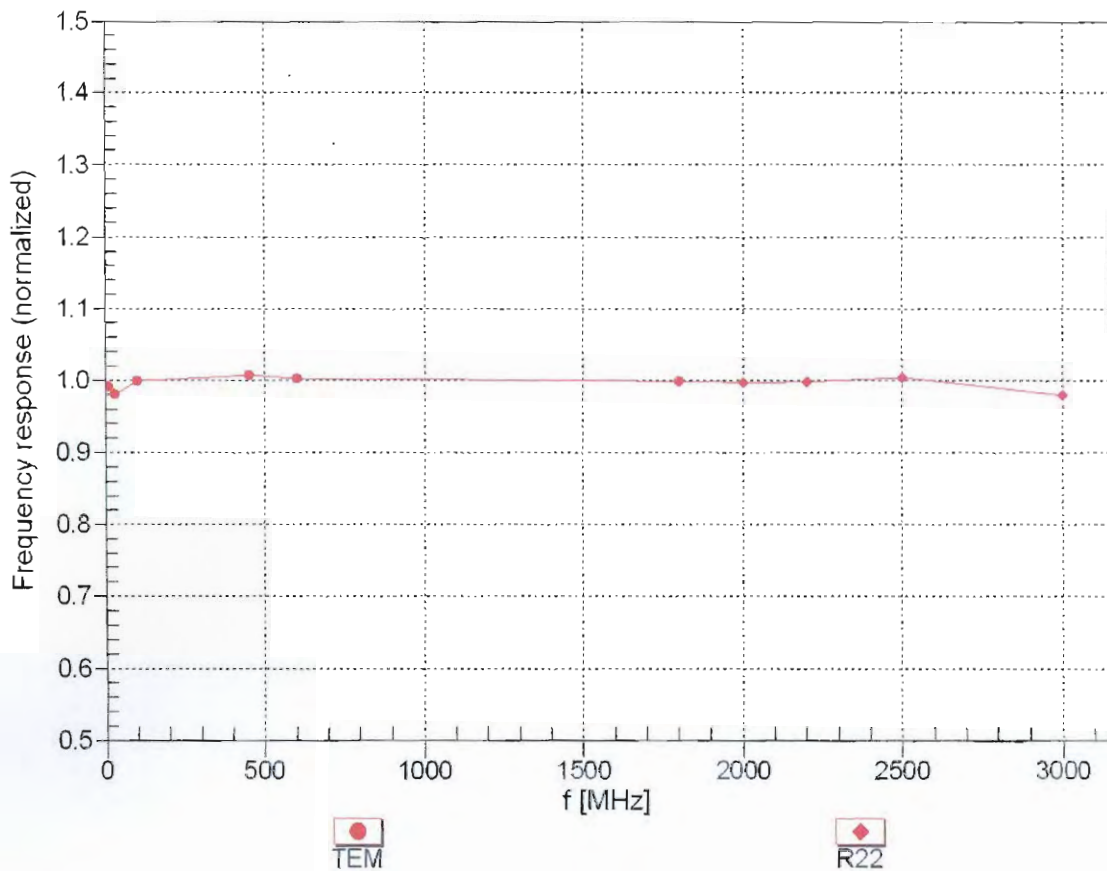

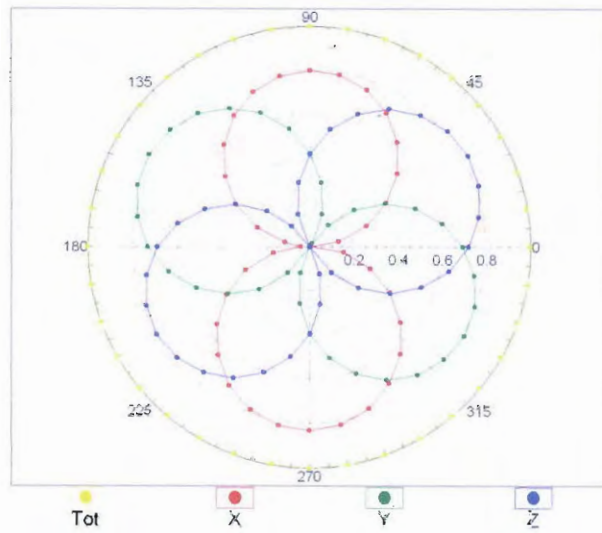


Uncertainty of Frequency Response of E-field:  $\pm 6.3\%$  ( $k=2$ )

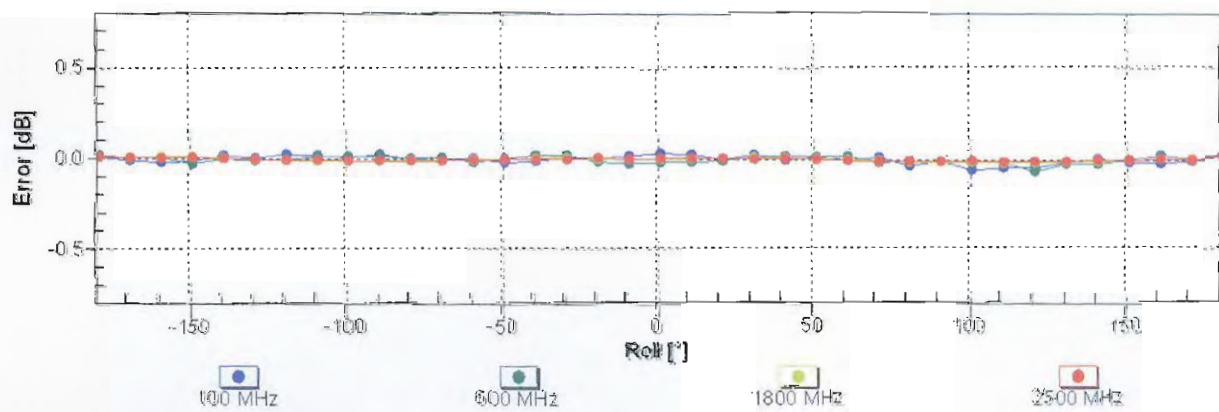
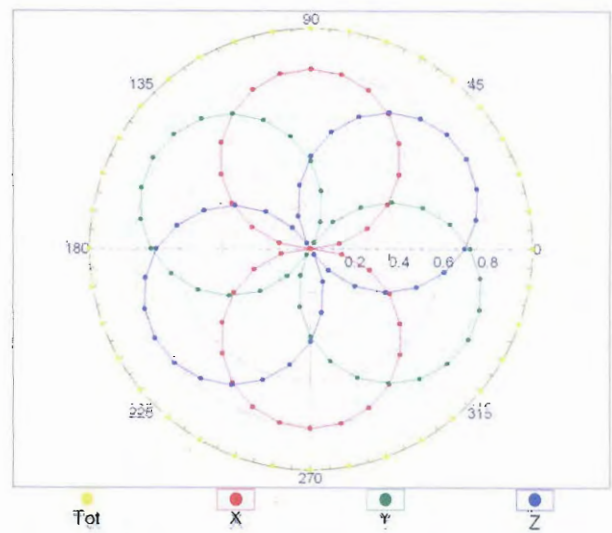

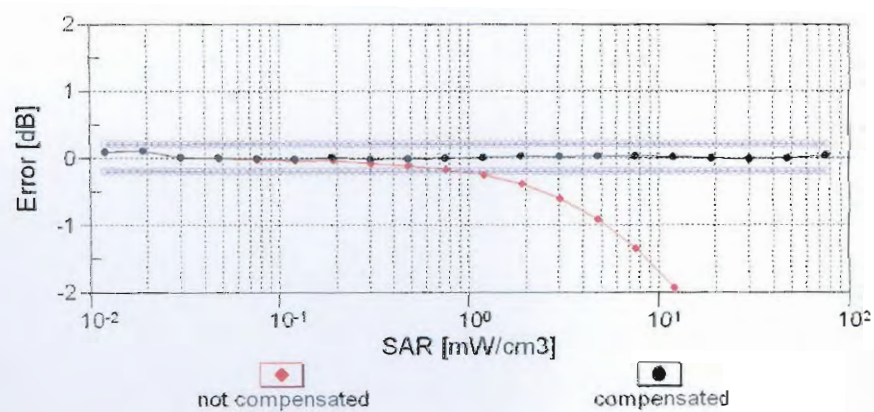
