

MANUAL

This is a candle light speaker, can be connected with any device of mobile phone/laptop/pad/computer which with Bluetooth function.

- Product's Desperation:

- 1) Bluetooth wireless audio transmission
- 2) Bluetooth receive range: $\geq 10M$
- 3) Frequency Response: 20HZ-20KHZ
- 4) Output Power: 3W
- 5) Rechargeable battery: 3.7V, 500mAh (speaker candle only); 300mAh (LED candle)
- 6) Accessory: USB Cable

- Product's Feature:

- 1) The biggest size is a BT speaker + LED light. The light of the candle with BT is continues.
- 2) The other two in M and S is LED light without BT speaker. It is flickering all the time at rhythm of the sound.
- 3) Live time of light in each candle: 50000 hours.


Light of speaker will be working in 12 hours above when not playing music.

Light of the other two will be working in 30 hours above.

- 4) Charging time: 3 hours charged by AC, or 6 hours charged by computer.

Playing time: 4-5 hours when full power.

- How to use:



- 1) Switch on the candle light speaker - -Open "Bluetooth function" on mobile phone/laptop/pad/computer
- 2) Searching "UVBELIEF" Bluetooth --Connected "UVBELIEF" Bluetooth
- 3) Play music or play game according to BT devices; any sound will send from bag speaker, control the sound or select the song from the mobile phone/laptop/pad/computer

- How to Charge: (2 options)

- 1) First way : use USB cable charged from computer (stander accessory)
- 2) Second way: use USB adaptor with cable charged from AC (customer special request)
- 3) Red LED ON: Charge
- 4) Red LED OFF: Full power

- Caution: 1. Make sure the Bluetooth Speaker is in the off state before operation.
2. The bag is with electronic parts, please pay attention to moisture proof and do not near water.
3. Do not let children play the product.
4. Do not hit or beat the product.
5. It is a flameless candle LED light. Do not throw it into fire.
6. Do not block speaker's net above the body
