


1. Product Guide



2. Product Use

- 1) Power on / off
- : Press and hold the power button on the right side of the product for more than 2 seconds to turn it on .
- : When the power is on, press and hold the power button for more than 2 seconds to turn the power off .
- 2) Adjust the volume
- : You can adjust the volume up and down with the two buttons on the left side of the product
- 3) Chat * You can chat with Pocoro while connected to Wi-Fi .
- : When you press the conversation button, a short guidance sound is heard , and when you release the button, a guidance sound is heard again .
- : What you say between the guidance sounds will be conveyed to Pocoro .
- : Pocoro thinks about what is being said and responds .
