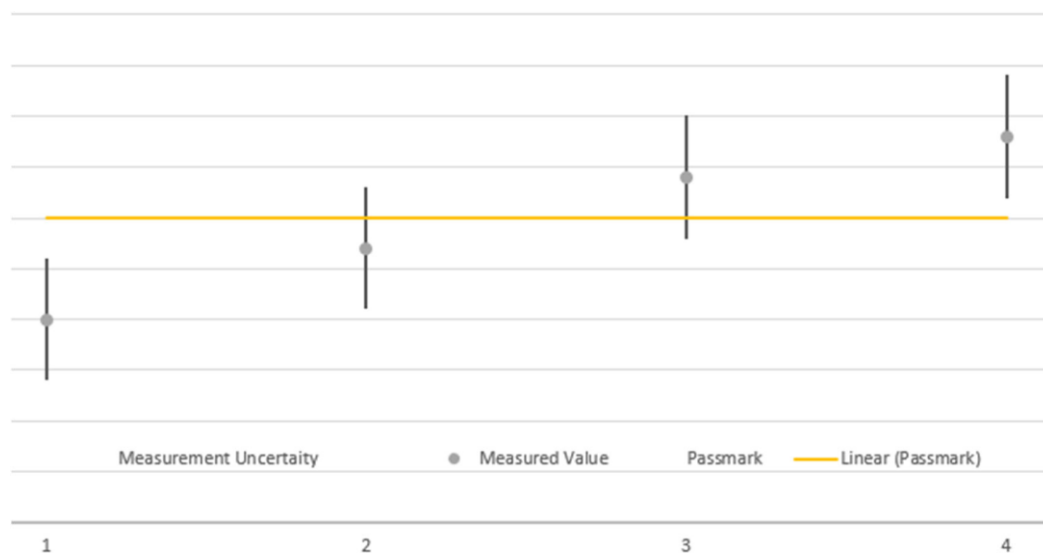

$L_{\text{C}}$  = signal attenuation in the connecting cable between the transmitter and antenna, in dB.

The EUT was set up for the maximum power with WCDMA link data modulation and link up with simulator. Set the EUT to transmit under low, middle and high channel and record the power level shown on simulator.

## 3.2 FREQUENCY STABILITY MEASUREMENT

### 3.2.1 LIMITS OF FREQUENCY STABILITY MEASUREMENT

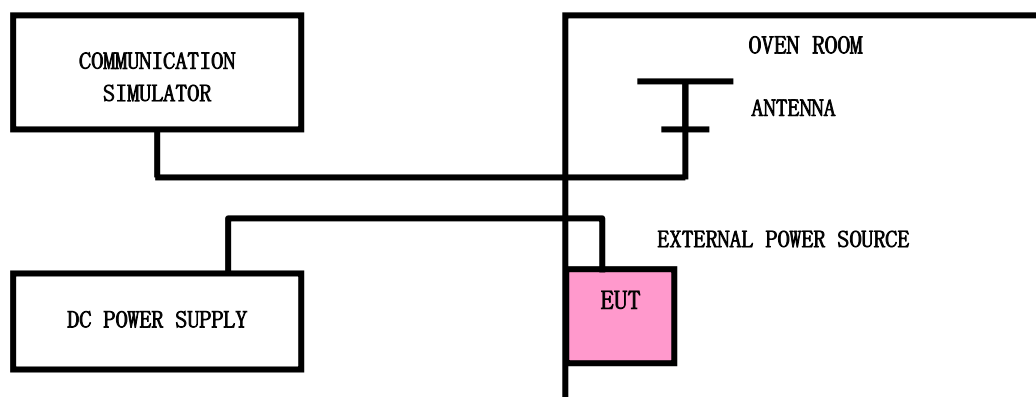
1.5 ppm is for base and fixed station. 2.5 ppm is for mobile station.

### 3.2.2 TEST PROCEDURE

- Device is placed at the oven room. The oven room could control the temperatures and humidity. Power warm up is at least 15 min and power applied should perform before recording frequency error.
- EUT is connected the external power supply to control the DC input power. The test voltage range is from minimum to maximum working voltage. Each step shall be record the frequency error rate.
- The temperature range step is 10 degrees in this test items. All temperature levels shall be hold the  $\pm 0.5^{\circ}\text{C}$  during the measurement testing. The each temperature step shall be at least 0.5 hours, consider the EUT could be test under the stability condition.

NOTE: The frequency error was recorded frequency error from the communication simulator.

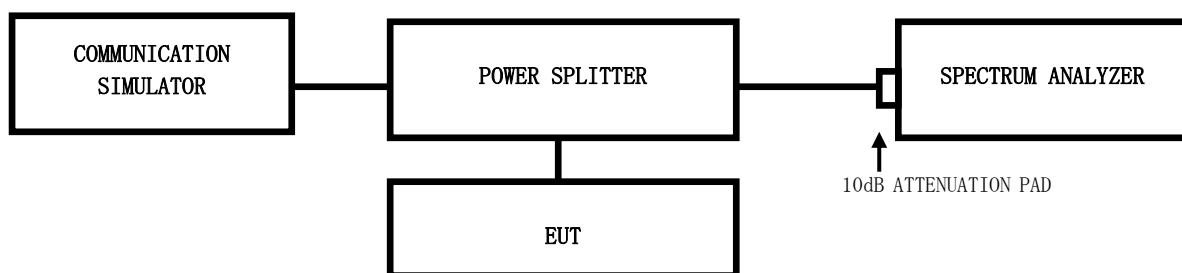

### 3.3 OCCUPIED BANDWIDTH MEASUREMENT

#### 3.3.1 LIMITS OF OCCUPIED BANDWIDTH MEASUREMENT

The width of a frequency band such that, below the lower and above the upper frequency limits, the mean powers emitted are each equal to a specified percentage 0.5 % of the total mean power of a given emission.

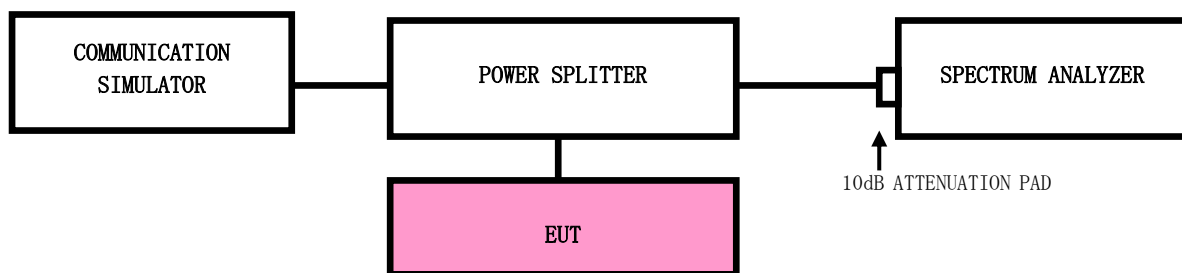

### 3.4 BAND EDGE MEASUREMENT

#### 3.4.1 LIMITS OF BAND EDGE MEASUREMENT

Power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least  $43 + 10 \log(P)$  dB. In the 1 MHz bands immediately outside and adjacent to the frequency block a resolution bandwidth of at least one percent of the emission bandwidth of the fundamental emission of the transmitter may be employed.

### 3.4.3 TEST PROCEDURES

- a) All measurements were done at low and high operational frequency range
- b) Connect the transmitter to the spectrum analyzer via coaxial cable while ensuring proper impedance matching.
- c) Tune the analyzer to the nominal center frequency of the emission bandwidth (EBW)
- d) .Set the resolution bandwidth (RBW)  $\geq 1\%$  EBW in the 1MHz band immediately outside and adjacent to the band edge.
- e) Beyond the 1MHz band from the band edge, RBW=1MHz was used.
- f) Set the video bandwidth (VBW) to  $\geq 3 \times$  RBW.
- g) Select the average power (RMS) display detector.
- h) Set the number of measurement points to  $\geq 1001$ .
- i) Use auto-coupled sweep time.
- j) Perform the measurement over an interval of time when the transmission is continuous and at its maximum power level.
- k) The RF fundamental frequency should be excluded against the limit line in the operating frequency band and use RBW is 10KHz or 100KHz.
- l) Record the max trace plot into the test report.

### 3.5 CONDUCTED SPURIOUS EMISSIONS

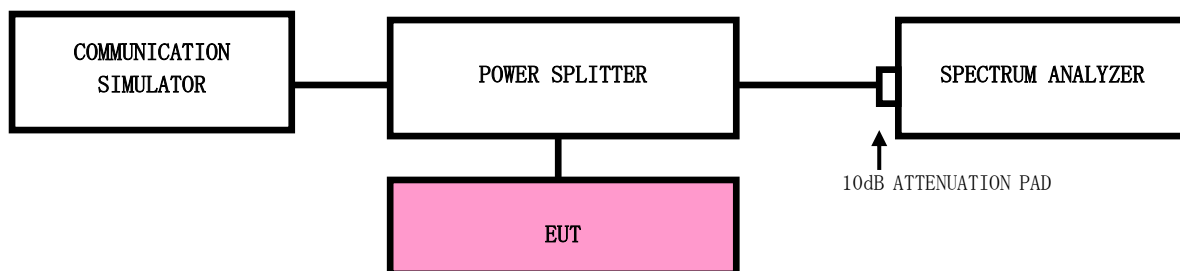
#### 3.5.1 LIMITS OF CONDUCTED SPURIOUS EMISSIONS MEASUREMENT

The power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least  $43 + 10 \log(P)$  dB. The emission limit equal to  $-13\text{dBm}$ .

#### 3.5.2 TEST PROCEDURE

- a. The EUT makes a phone call to the communication simulator. All measurements were done at low, middle and high operational frequency range.
- b. Measuring frequency range is from 9kHz up to a frequency including its 10<sup>th</sup> harmonic. 10dB attenuation pad is connected with spectrum. RBW=1MHz and VBW=3MHz is used for conducted emission measurement.

### 3.6 RADIATED EMISSION MEASUREMENT

#### 3.6.1 LIMITS OF RADIATED EMISSION MEASUREMENT

The power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least  $43 + 10 \log(P)$  dB. The emission limit equal to  $-13\text{dBm}$ .

#### 3.6.2 TEST PROCEDURES

- a. Substitution method is used for E.I.R.P measurement. In the semi-anechoic chamber, EUT placed on the 0.8m height of Turn Table, rotated the table around 360 degrees to search the maximum radiation power and receiver antenna shall be rotated vertical and horizontal polarization and moved height from 1m to 4m to find the maximum polar radiated power. The "Read Value" is the spectrum reading the maximum power value.
- b. The substitution horn antenna is substituted for EUT at the same position and signals generator export the CW signal to the substitution antenna via a TX cable. Rotated the Turn Table and moved receiving antenna to find the maximum radiation power. Adjust output power level of S.G to get a Value of spectrum reading equal to "Read Value" of step a. Record the power level of S.G
- c.  $\text{EIRP} = \text{Output power level of S.G} - \text{TX cable loss} + \text{Antenna gain of substitution horn}$ .
- d. E.R.P power can be calculated form E.I.R.P power by subtracting the gain of dipole,  
 $\text{E.R.P power} = \text{E.I.P.R power} - 2.15\text{dBi}$ .

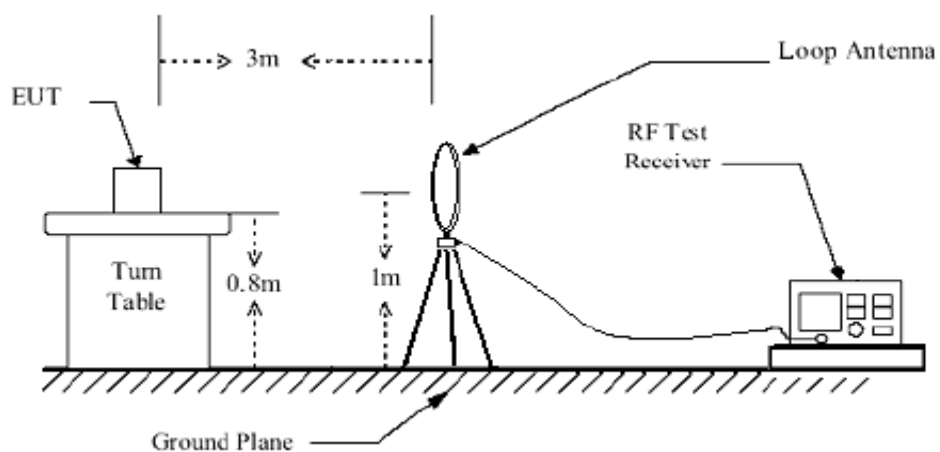

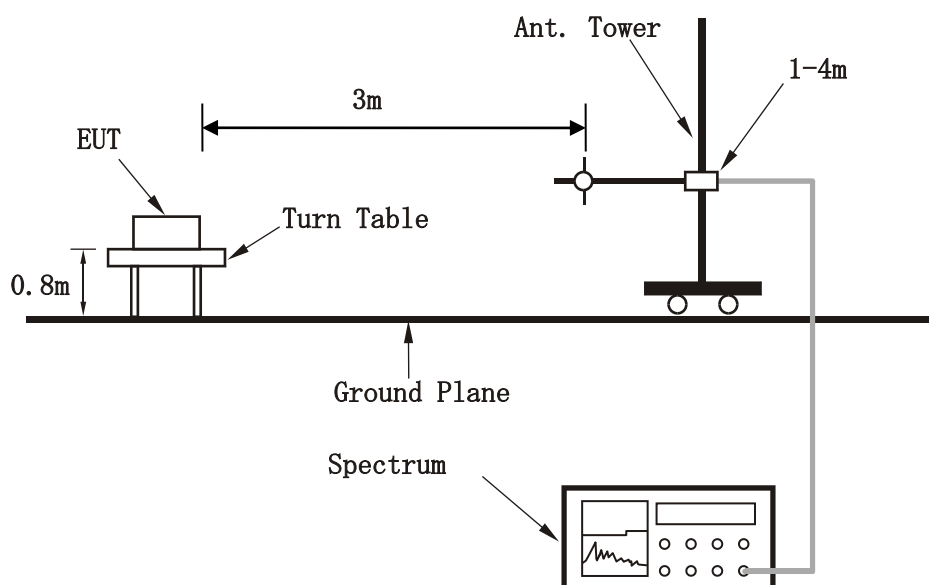

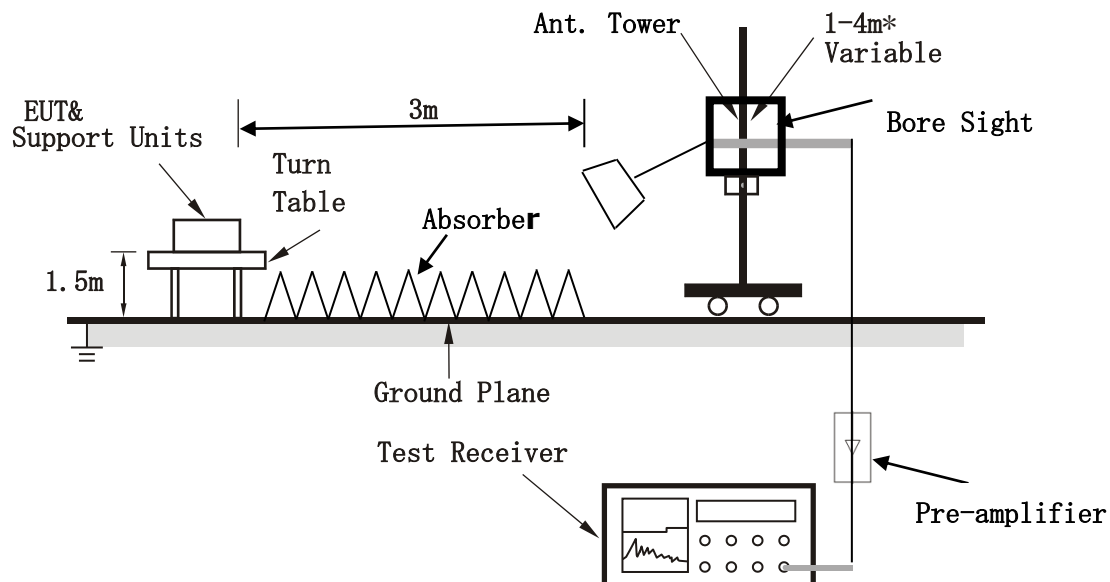
#### < Frequency Range below 30MHz >

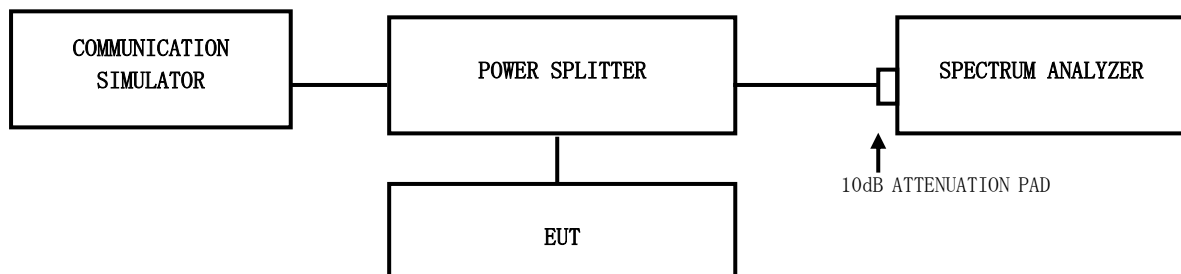
