Charging the Speaker

Before using the speaker for the first time charge it for at least 24 hours.

1. Plug the adapter with the USB cable into the charging socket of the speaker. Plug the other end of the adapter into a wall outlet. The red LED indicator on the speaker will light up and your speaker will start charging.
2. The red LED turns on to indicate that the unit is charging.
3. Once fully charged, the red LED turns off.
4. Under "ON", the red light will be off when charging.

Pairing the Device

1. Place speaker within 30ft of the Bluetooth-enabled device.
2. Slide the ON/OFF button to ON. The blue LED flashes 3 times slowly, then flashes quickly to indicate Bluetooth pairing mode.
3. Follow the instructions of your device to search for the speaker.

4. The speaker is called "**TEWELL T-1D**." If a PIN is required, enter "0000."
5. The blue LED flashes when pairing is complete.

Basic instructions

To turn the speaker on, press the ON/OFF button to ON.

The speaker beeps and a blue LED flashes slowly.

The blue LED stays on when playing music.

When the battery is low, the machine indicates "beep" with intervals every 1 minutes

LED indicator

Charging: Red LED on (the speaker off)

Fully Charged: Red LED off

Pairing Mode: Blue LED flashes quickly

Connected: Blue LED on

Playing: Blue LED on

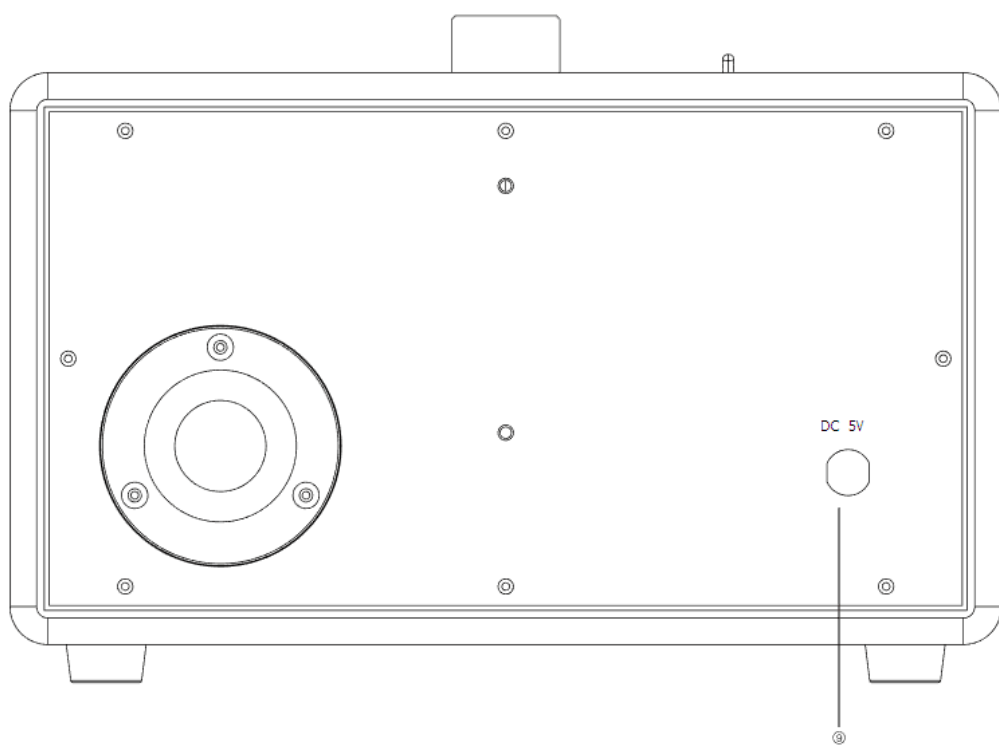
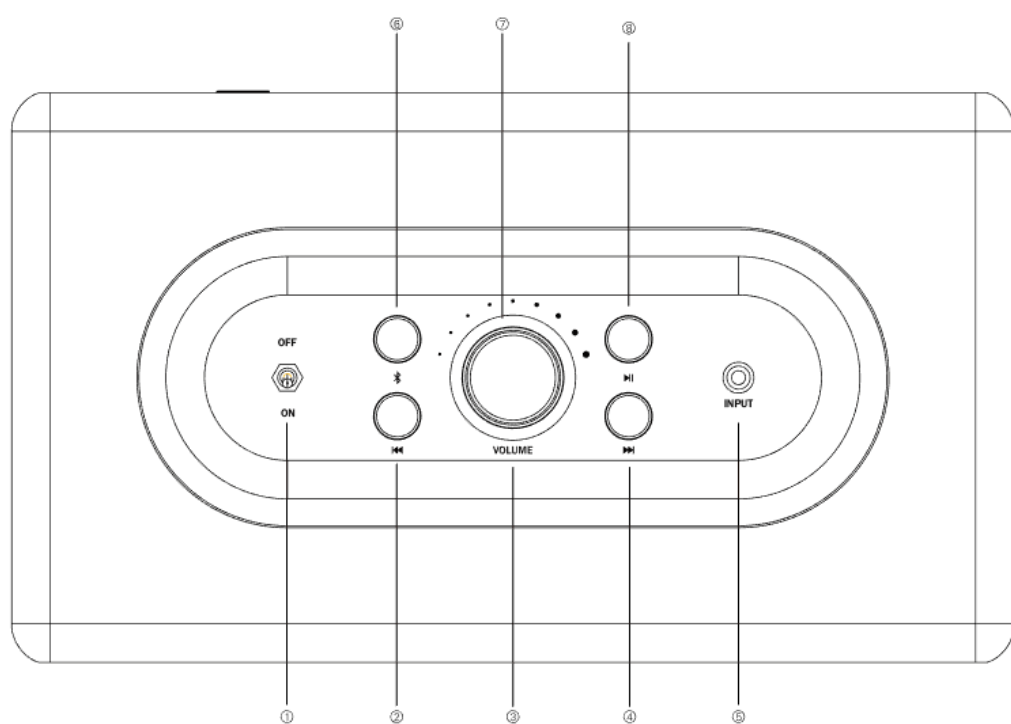

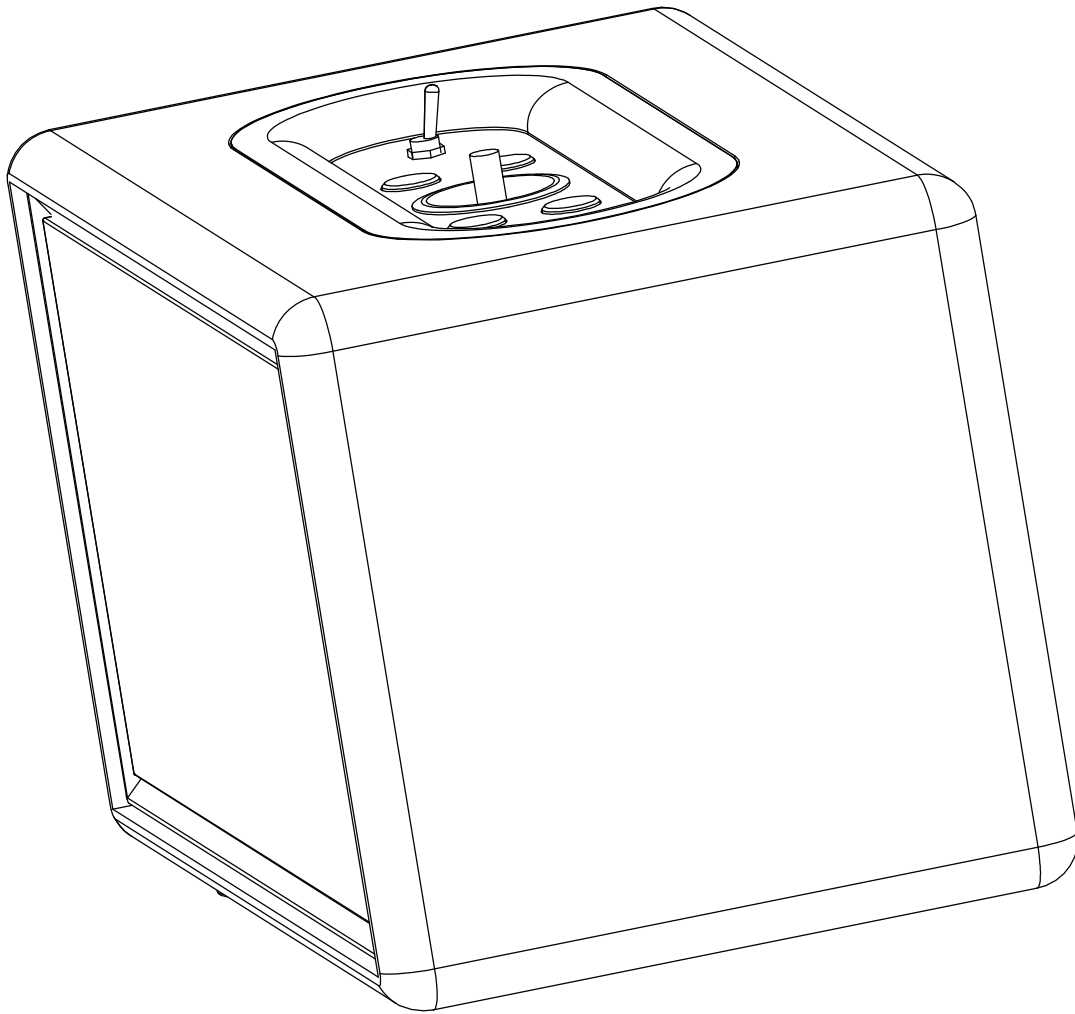

Speaker button functions





1. **Power On/Off**
Press the ON/OFF button, the unit ON/OFF.
2. **Last song:**
Press quickly for last song.
3. **Volume up /down:**
Rotate the switch and adjust volume
4. **Next song:**
Press quickly for next track.
5. **3.5mm audio input (line-in)**
6. **Bluetooth**
Press the button, Switch Bluetooth and aux-in input,
Press and hold the button under Bluetooth made to enter to Bluetooth free pairing.

7. LED Red/Blue

8. Play/Pause

When playing music, press the button to pause or play. Press and hold to unpair the current device.
