6dB bandwidth Low Channel




6dB bandwidth Middle Channel


Middle Channel

7. Band Edge and Conducted Spurious Emissions

7.1 Requirement and Measurement Procedure

In any 100KHz bandwidth outside the frequency band in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100KHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement.

The antenna port of the EUT was connected to the input of a spectrum analyzer. Analyzer was set as below.

A Quasi-peak measurement was then made for that frequency point for below 1GHz test. PK and AV for above 1GHz emission test.





Band Edge Low Channel










Conducted Spurious Emissions Low Channel




Middle Channel







8.2 Measurement Procedure

- a. Blow 1GHz, the EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter semi- anechoic chamber room.
- b. For the radiated emission test above 1GHz:
 - The EUT was placed on the top of a rotating table 1.5 meters above the ground at a 3 meter full anechoic chamber room. The table was rotated 360 degrees to determine the position of the highest radiation. Place the measurement antenna away from each area of the EUT determined to be a source of emissions at the specified measurement distance, while keeping the measurement antenna aimed at the source of emissions at each frequency of significant emissions, with polarization oriented for maximum response. The measurement antenna may have to be higher or lower than the EUT, depending on the radiation pattern of the emission and staying aimed at the emission source for receiving the maximum signal. The final measurement antenna elevation shall be that which maximizes the emissions. The measurement antenna elevation for maximum emissions shall be restricted to a range of heights of from 1 m to 4 m above the ground or reference ground plane.
- c. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- d. The height of antenna is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- e. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading. The test-receiver system was set to peak detect function and specified bandwidth with maximum hold mode.
- f. A Quasi-peak measurement was then made for that frequency point for below 1GHz test. PK and AV for above 1GHz emission test.





9. Antenna Application

9.1 Antenna requirement

According to of FCC part 15C section 15.203 and 15.240:

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator, the manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.

Systems operating in the 2400-2483.5MHz band that are used exclusively for fixed, point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi provided the maximum peak output power of the intentional radiator is reduced by 1dB for every 3dB that the directional gain of the antenna exceeds 6dBi.

9.2 Measurement Results

The antenna is PIFA antenna that no antenna other than furnished by the responsible party shall be used with the device, and the best case gain of the antenna is 2.99dBi, So, the antenna is consider meet the requirement.
