



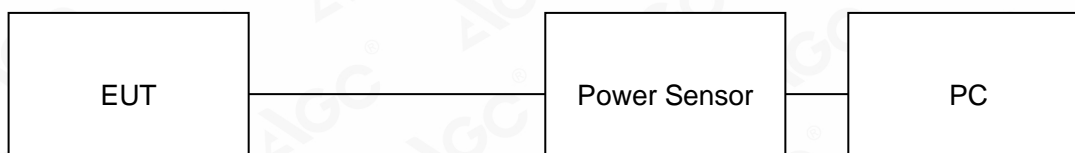

1. Connect EUT RF output port to power sensor through an RF attenuator.
2. Connect the power sensor to the PC.
3. Set the EUT Work on the top, the middle and the bottom operation frequency individually.
4. Record the maximum power from the software.

**Note :** The EUT was tested according to ANSI C63.10 (2013) for compliance to FCC 47CFR 15.247 requirements.

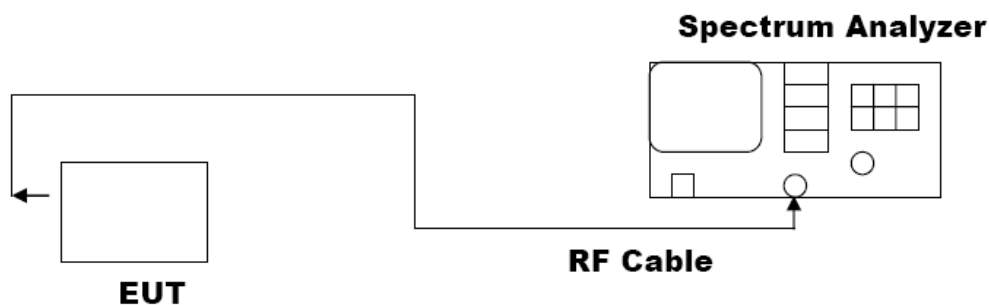

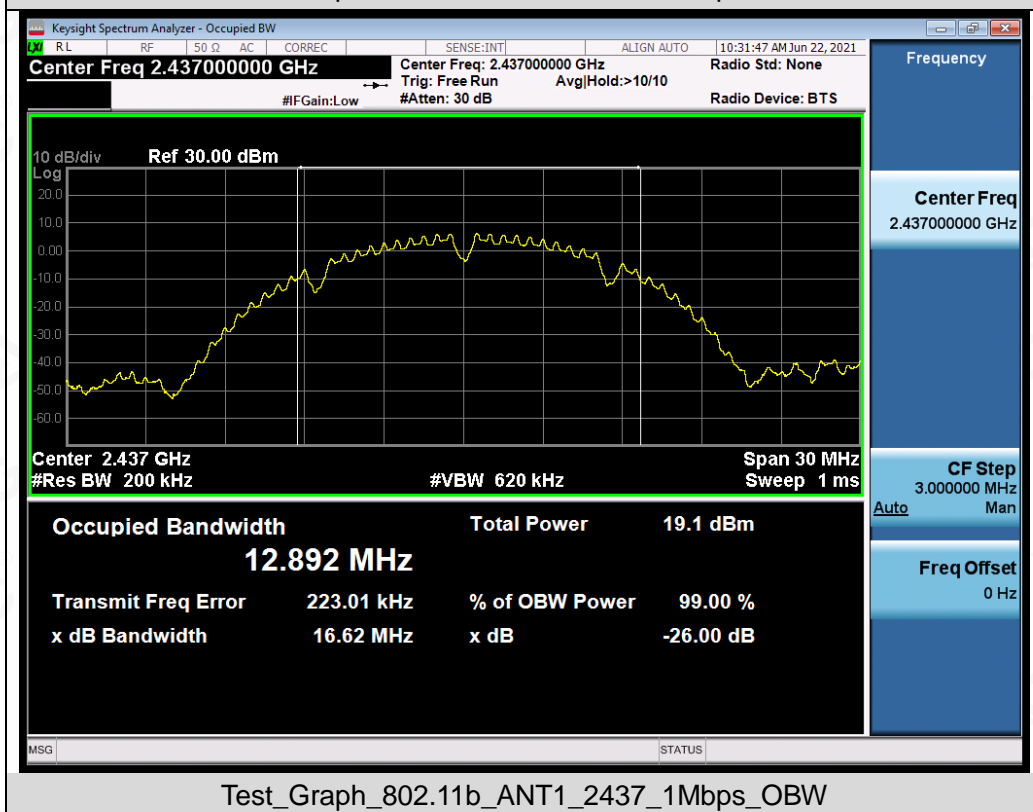




### Test Graphs of Occupied Bandwidth

Test\_Graph\_802.11b\_ANT1\_2437\_1Mbps\_Lower Band Emissions

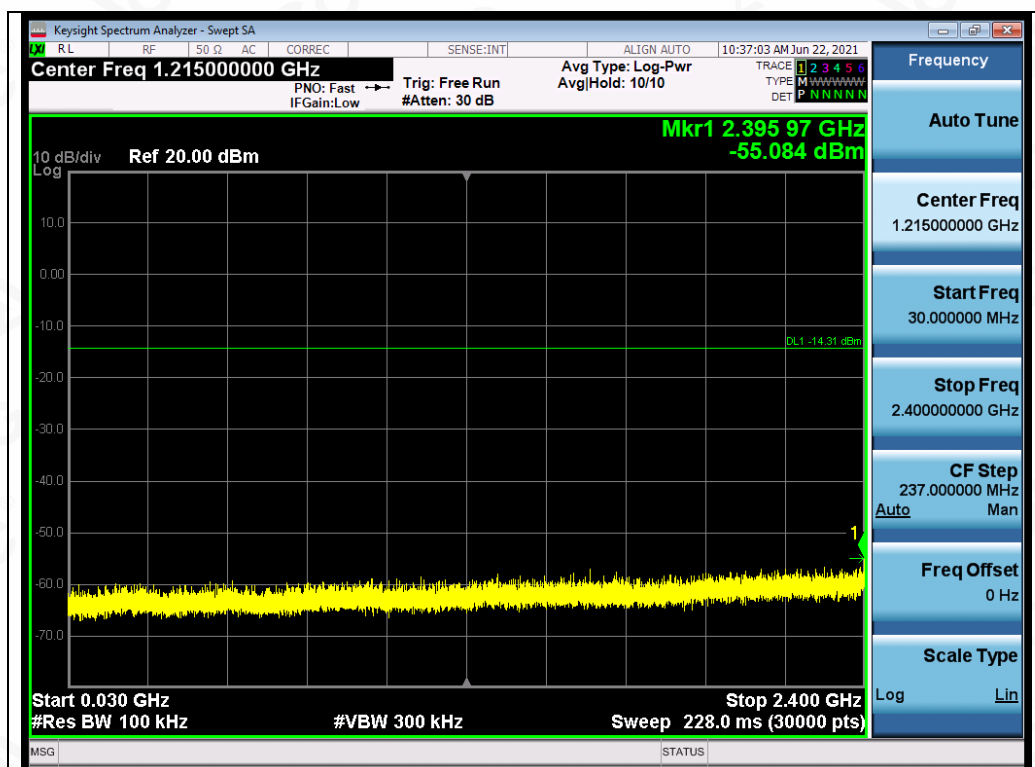

Test\_Graph\_802.11g\_ANT1\_2462\_6Mbps\_Lower Band Emissions

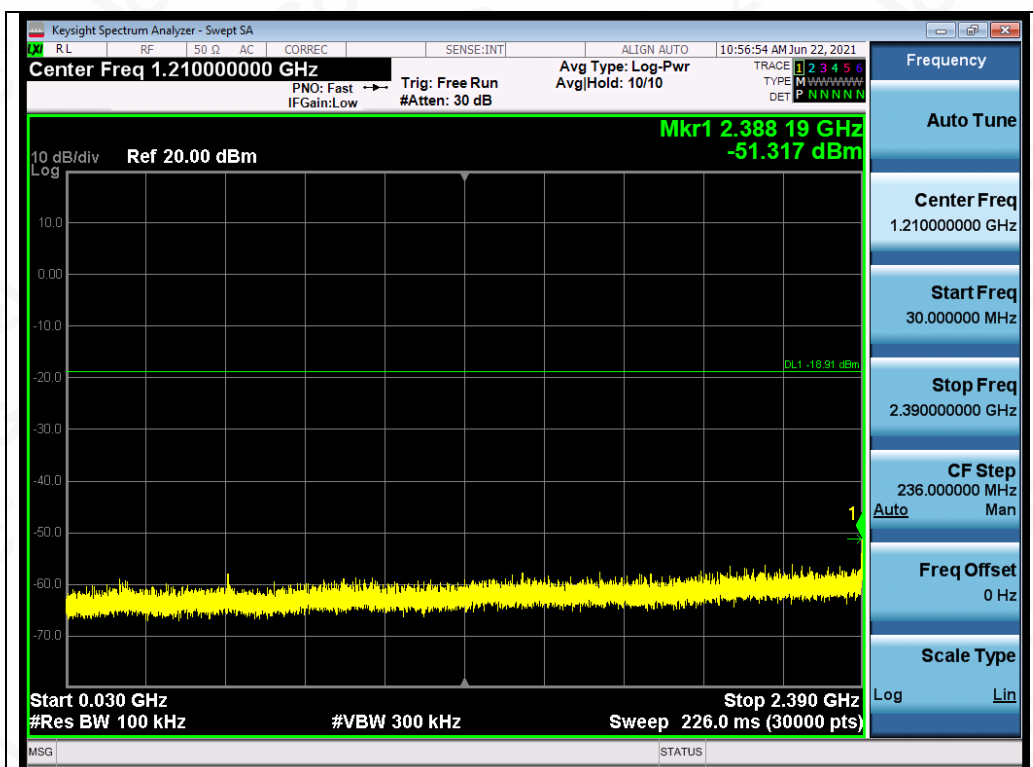

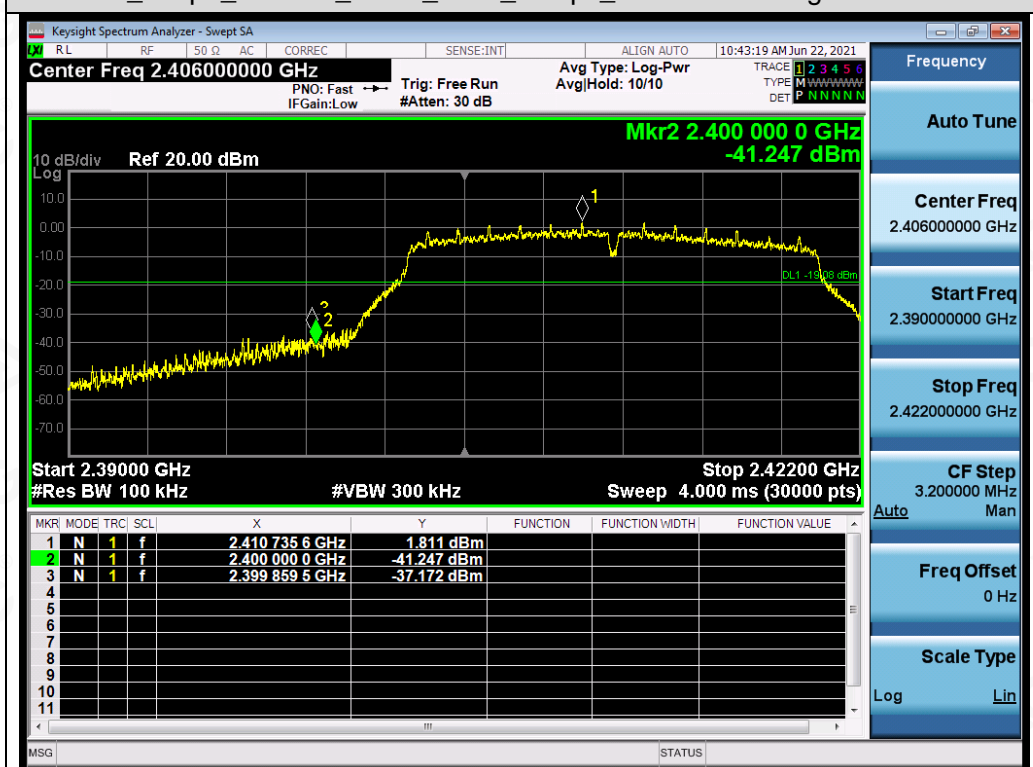




### Test Graphs of Band Edge Emissions in Non-Restricted Frequency Bands



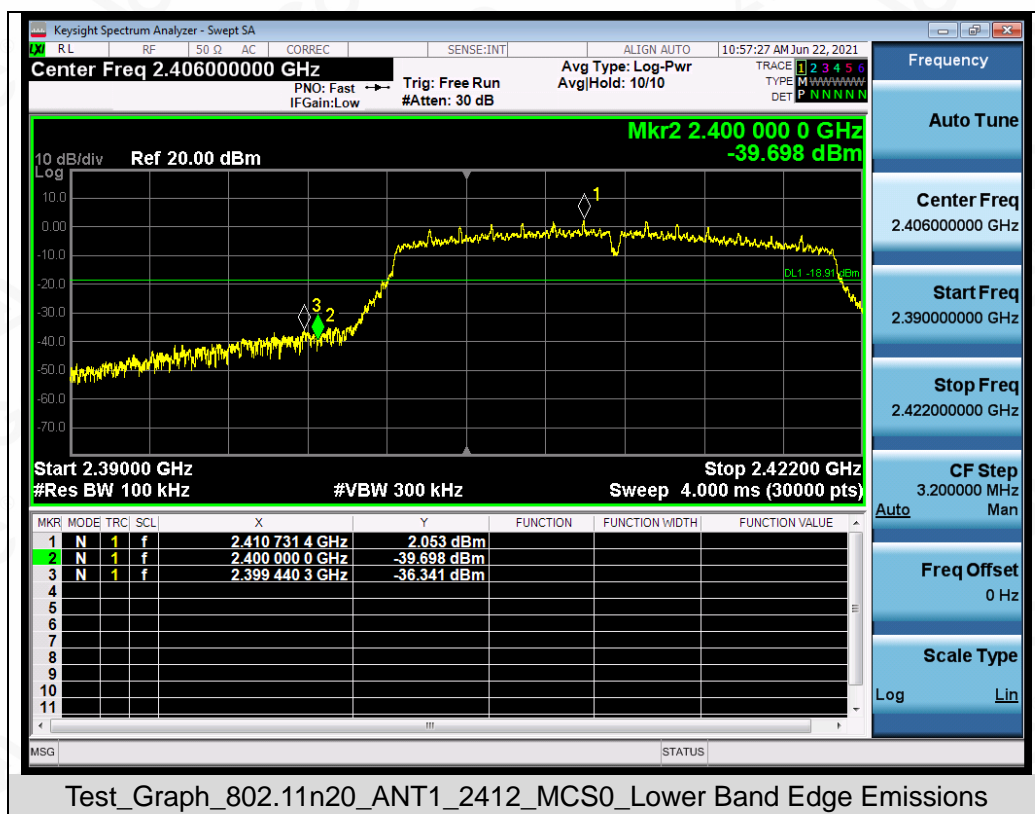
