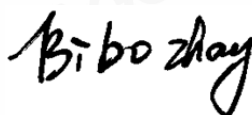

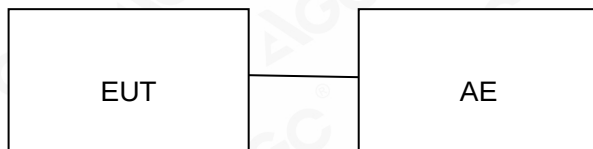

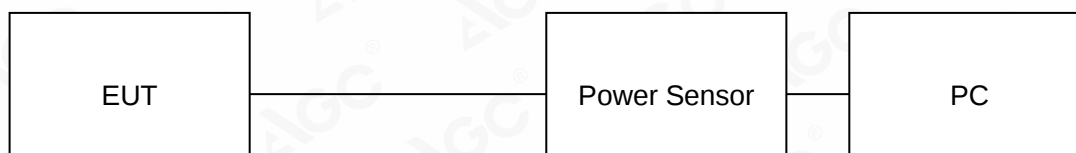
7.1. MEASUREMENT PROCEDURE

2. Connect the power sensor to the PC.
3. Set the EUT Work on the top, the middle and the bottom operation frequency individually.
4. Record the maximum power from the software.

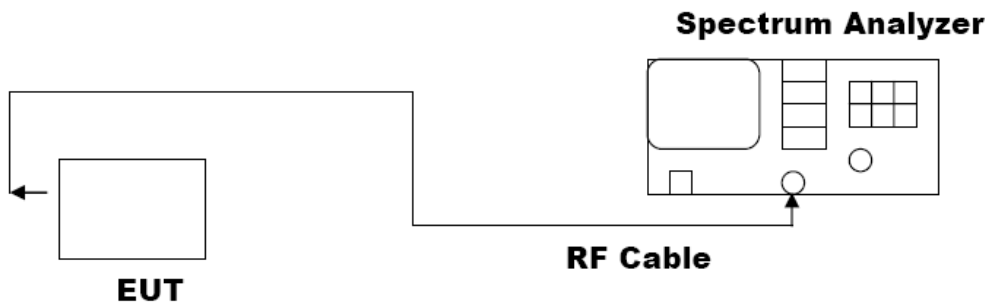

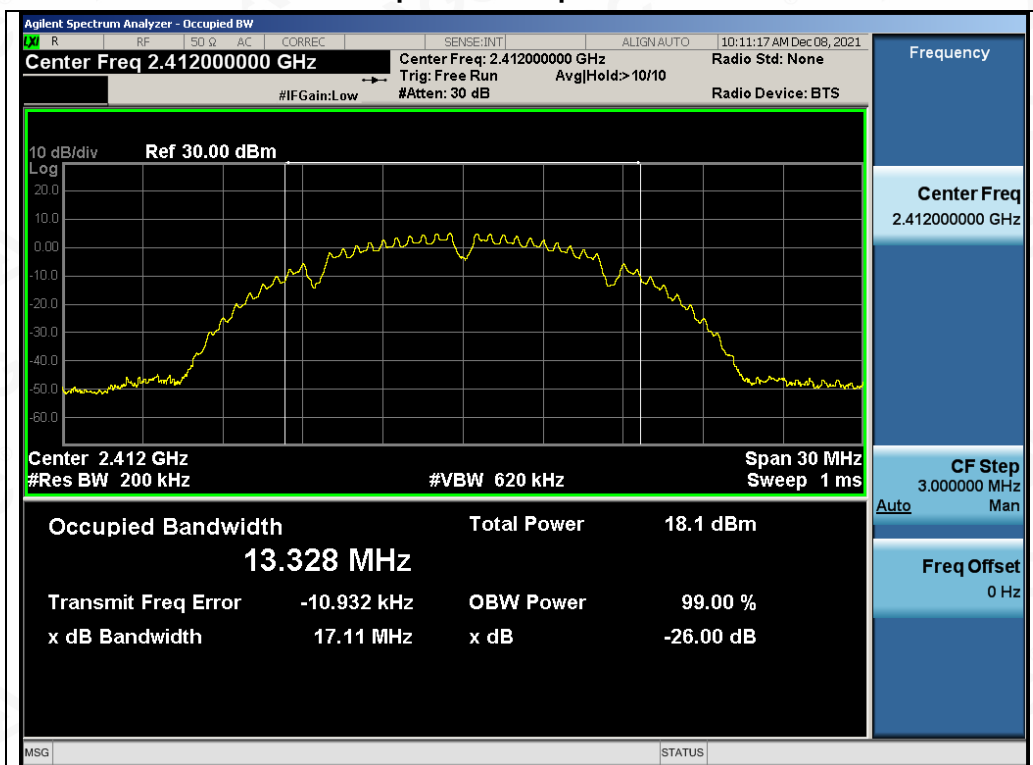

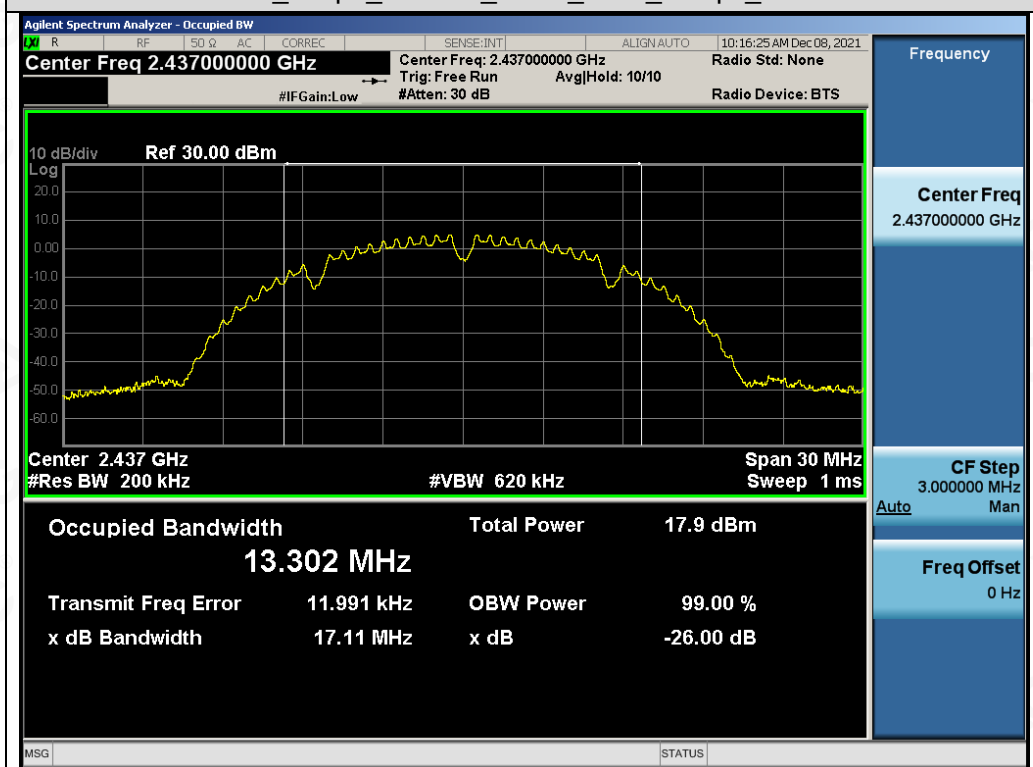

Test_Graph_802.11b_ANT1_2412_1Mbps_OBW

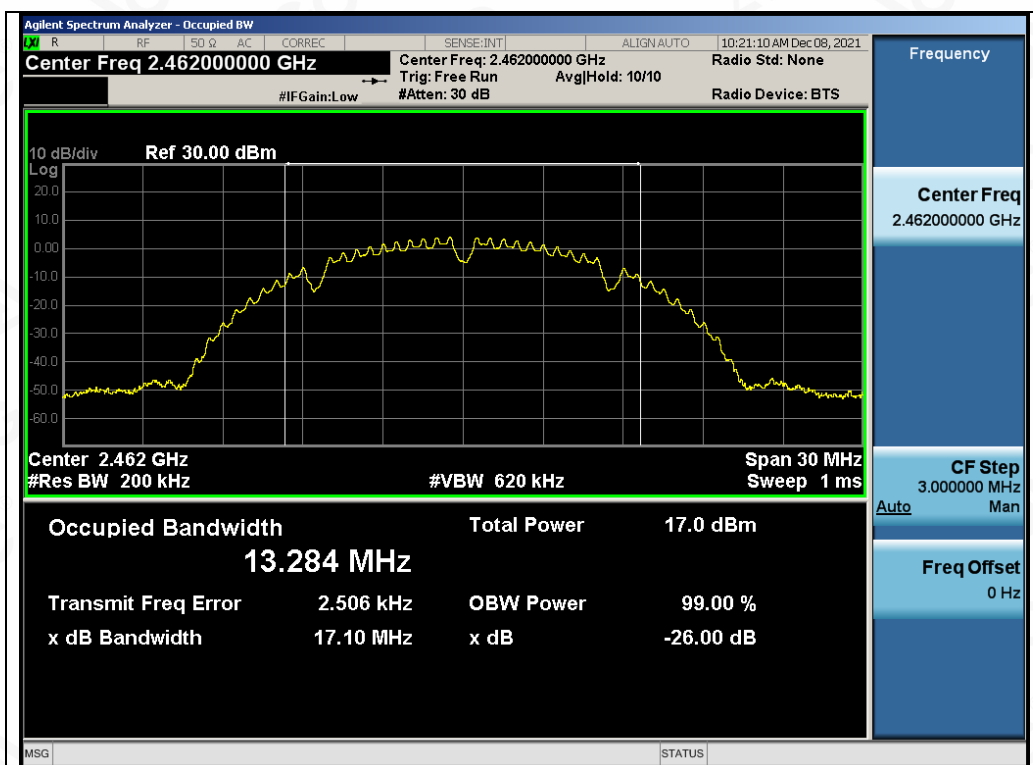

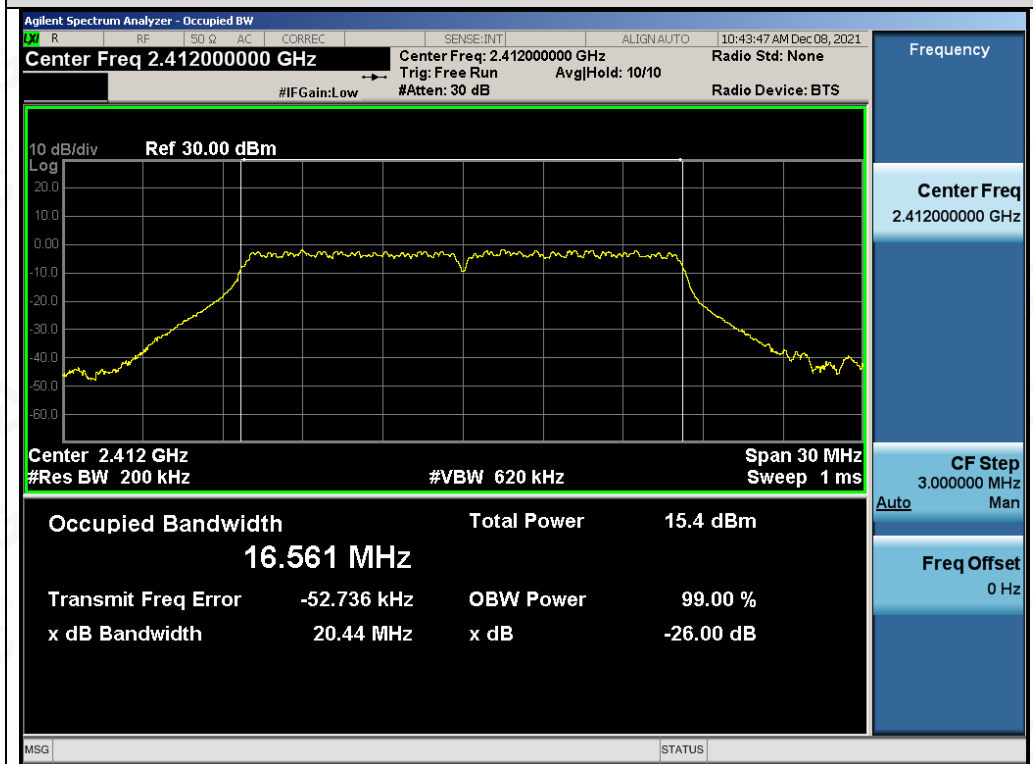

Test_Graph_802.11b_ANT1_2462_1Mbps_OBW

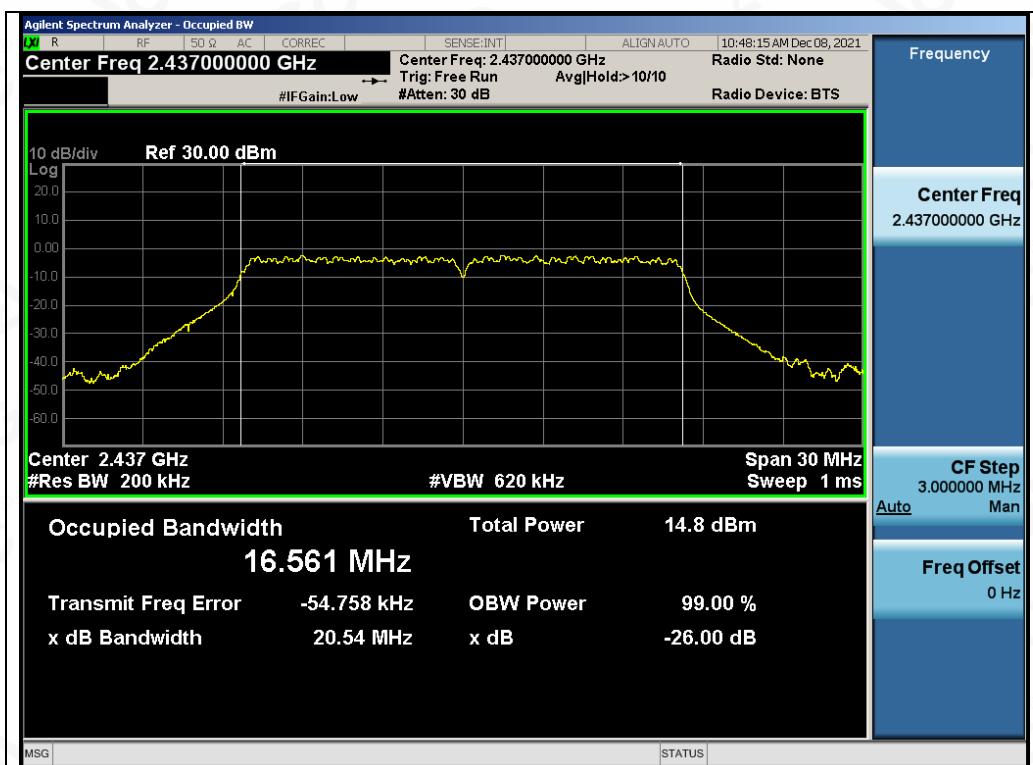

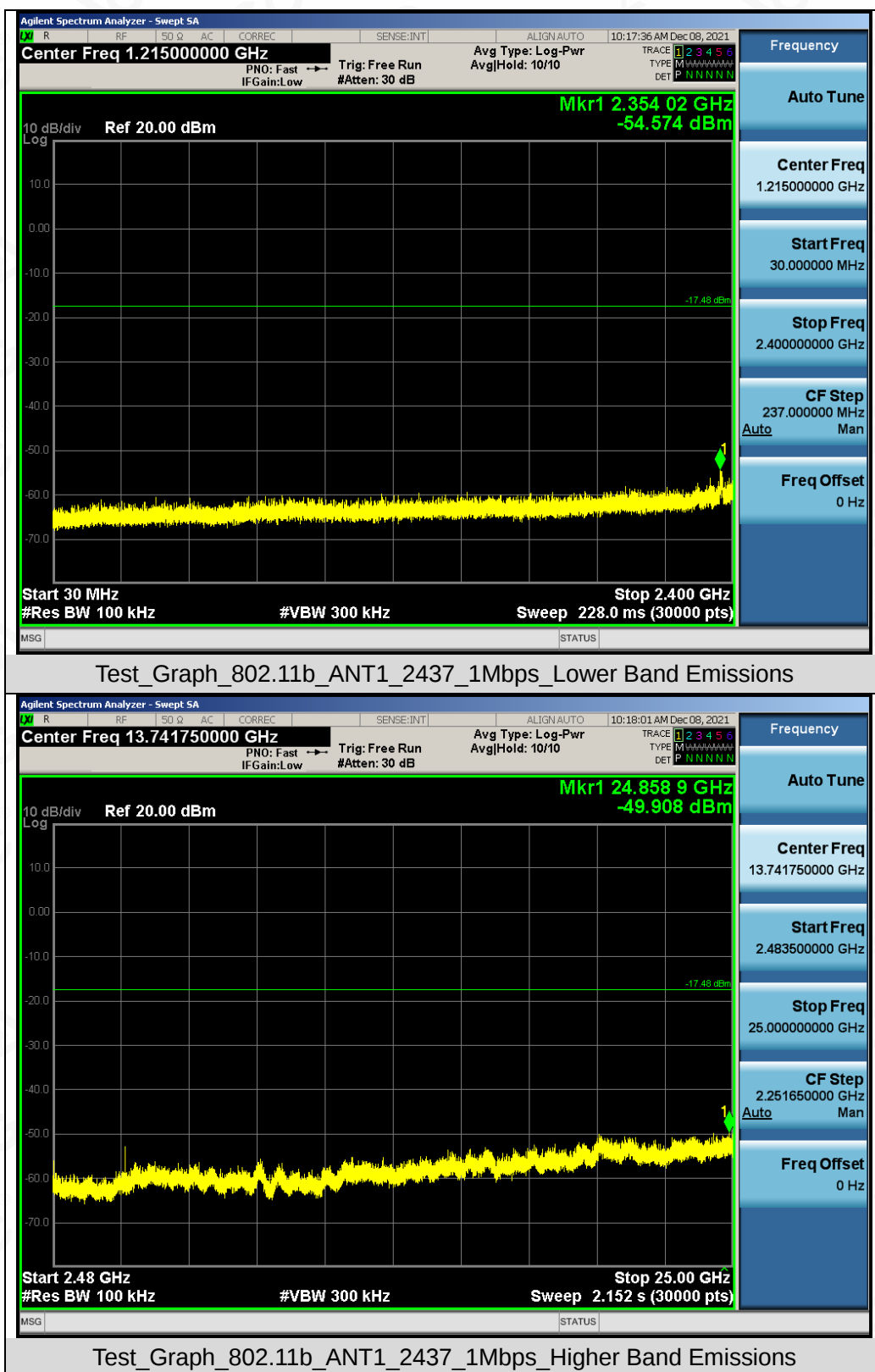

Test_Graph_802.11g_ANT1_2437_6Mbps_Lower Band Emissions

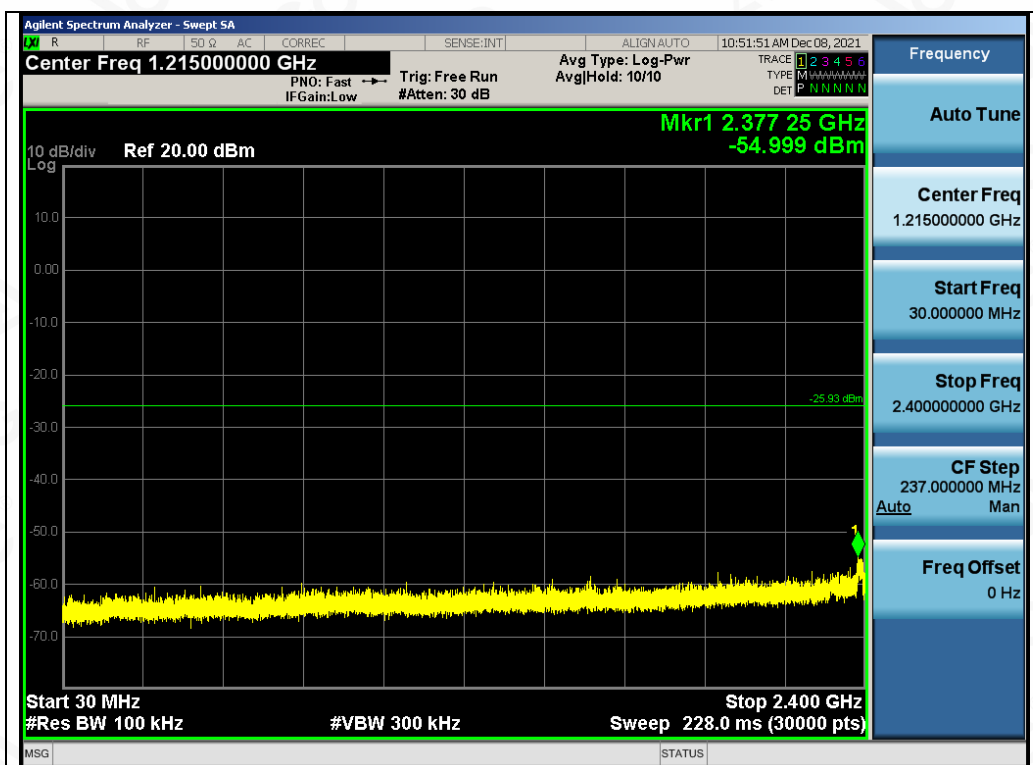

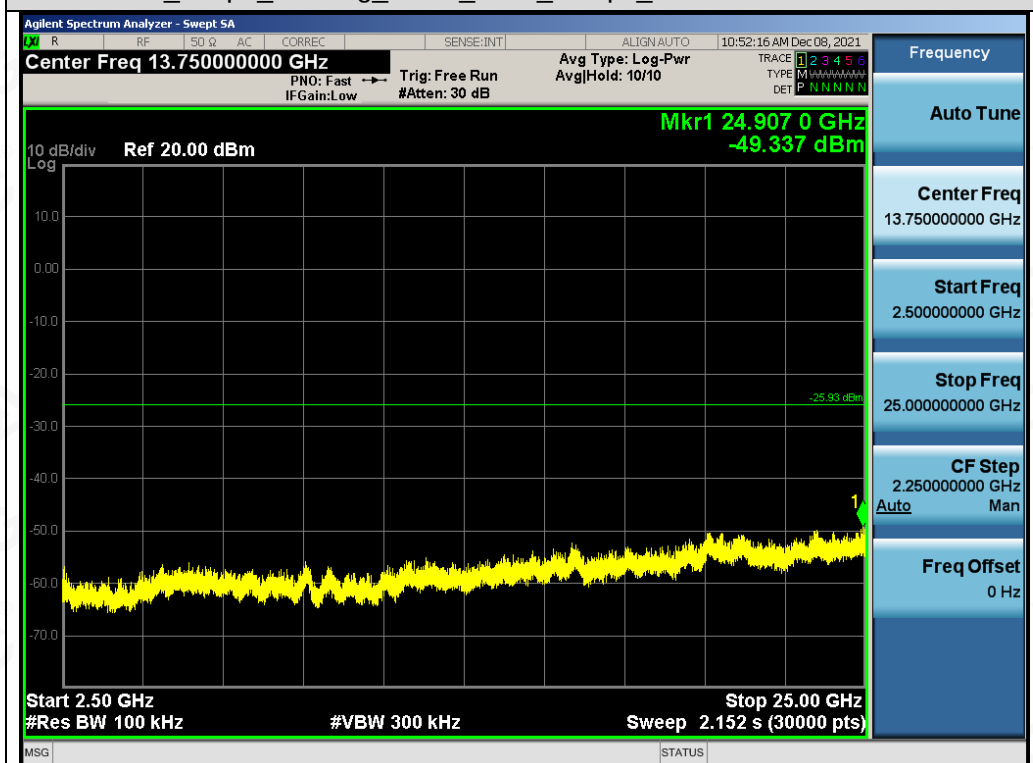

Test_Graph_802.11g_ANT1_2462_6Mbps_Lower Band Emissions

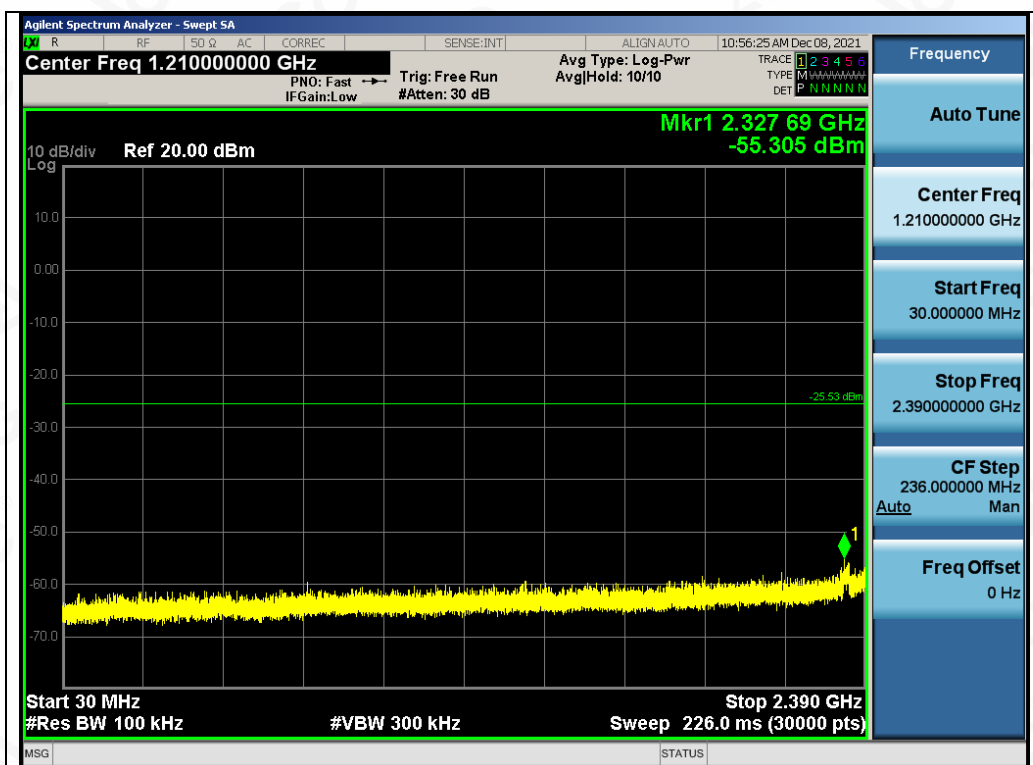

Test_Graph_802.11n40_ANT1_2422_MCS0_Lower Band Emissions

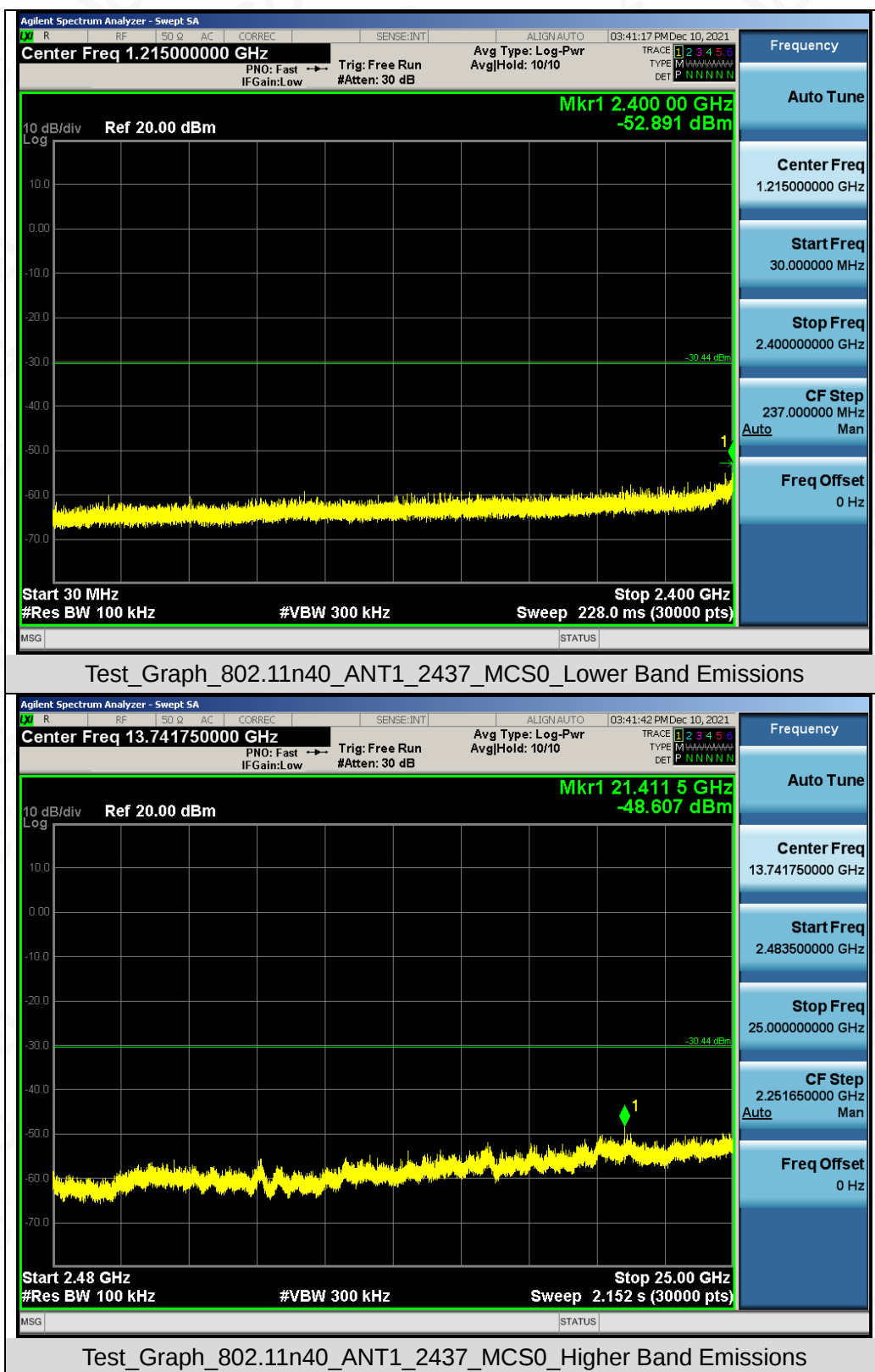


Test_Graph_802.11n40_ANT1_2422_MCS0_Higher Band Emissions

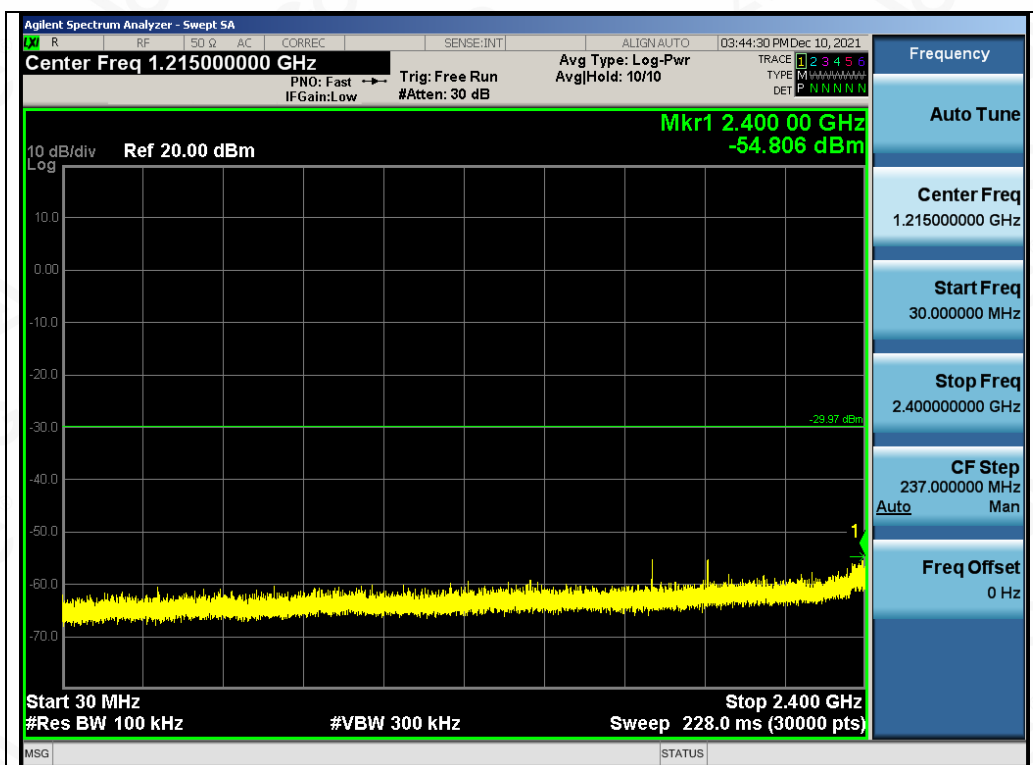




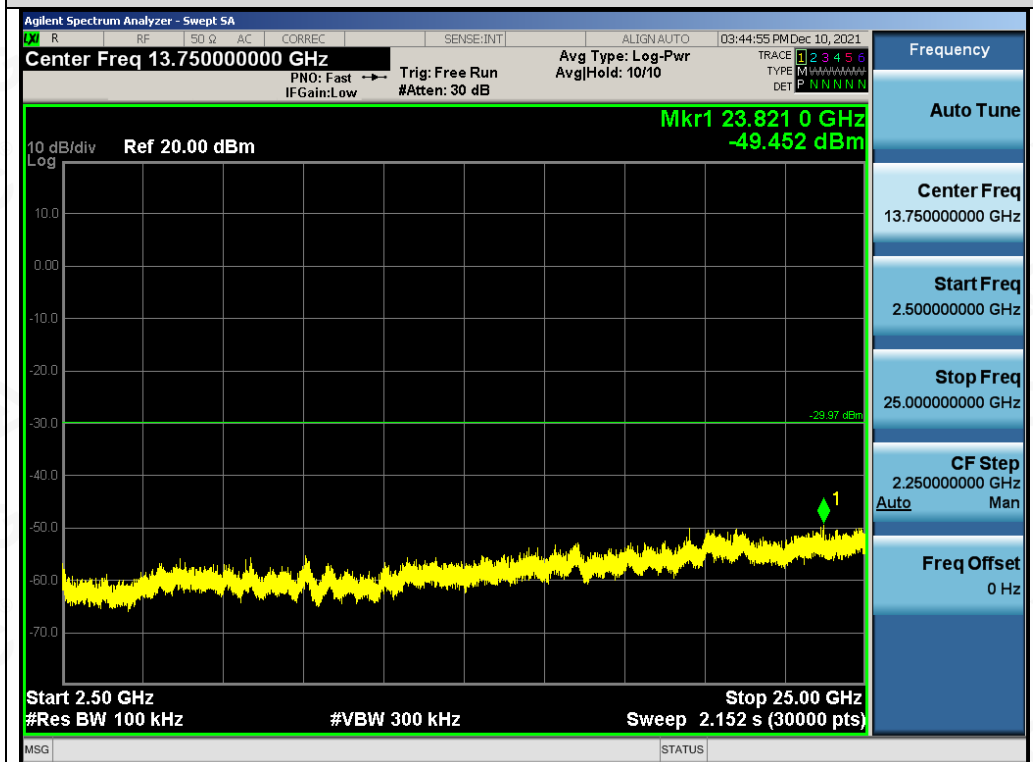

Test_Graph_802.11n40_ANT1_2452_MCS0_Lower Band Emissions



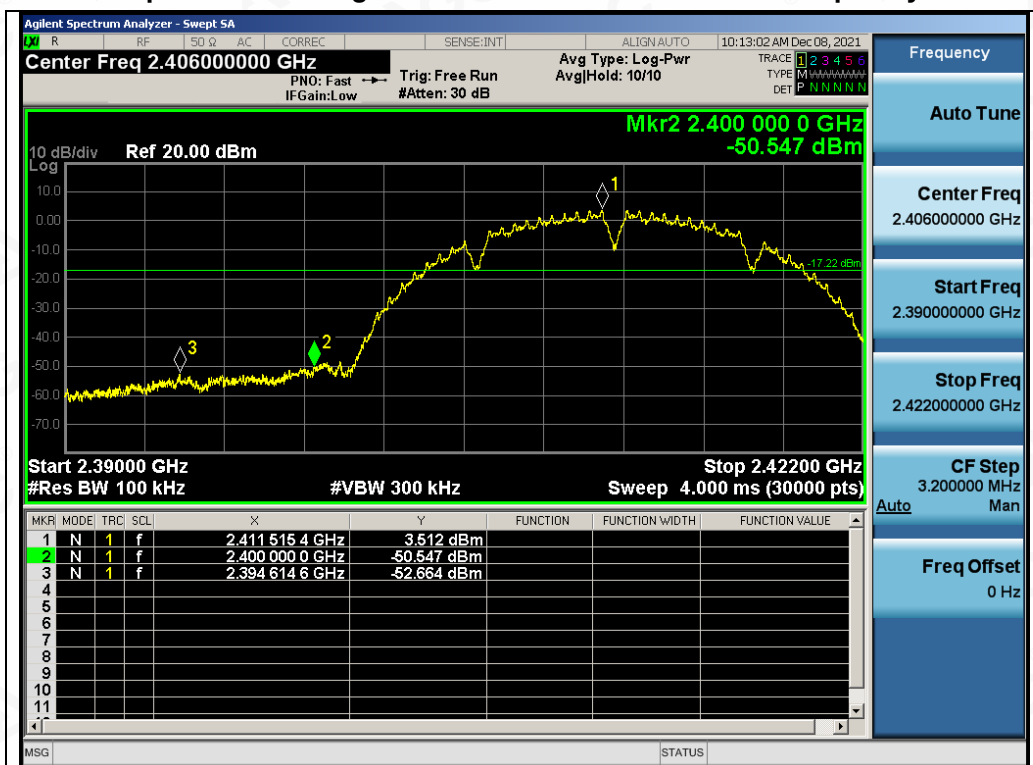

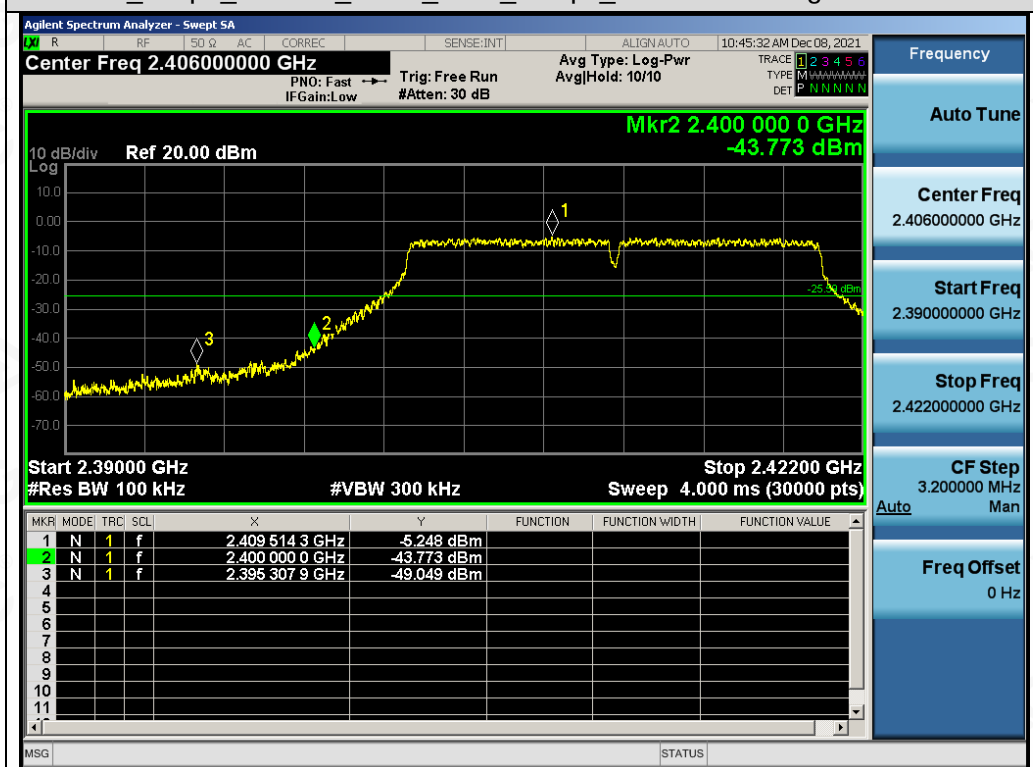
