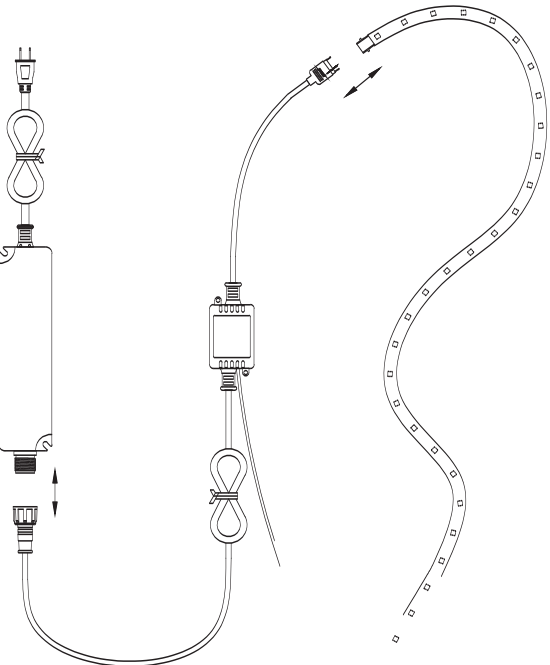

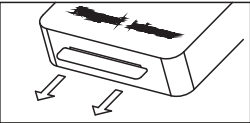

Use remote control to control device :

Must completed matching the remote control with device before control.

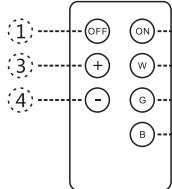
Matching steps

- Step 1: Power on, the light strips will turn on.
- Step 2: Remove the plastic spacer on the battery,and make sure the remote control works properly.



- Step 3: Long press the "ON" button on the remote control, if the light strip flashed three times, the match succeeded.

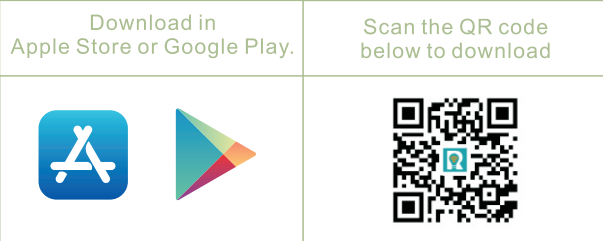
- 1.Turn off the light
- 2.Turn on the light
- 3.Brightness increase
- 4.Brightness decrease
- 5.Switch to white light
- 6.Switch to gold light
- 7.Switch to blue light



Warning :
if need to change remote control, first cut off the power for device, then power on and match with new remote control. Do not match and power off several devices at the same time.

Use App to control :

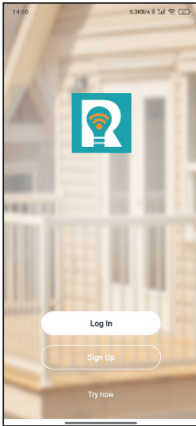
Step 1: install "Regal Ideas" App on phone.

2. If you are unsure of the device type, please enable all these permissions

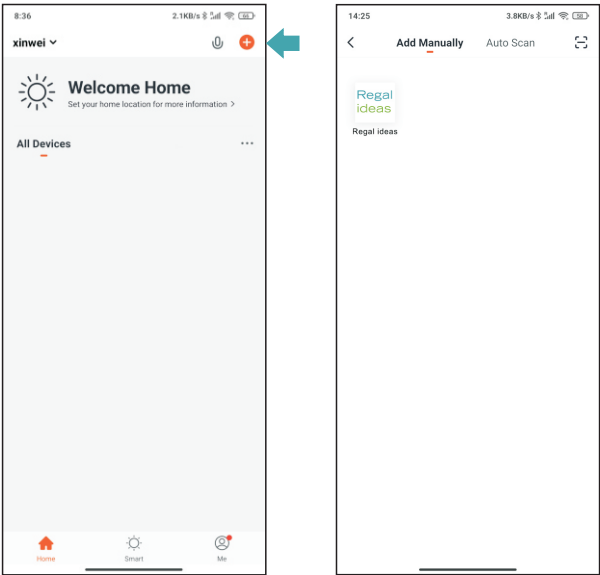

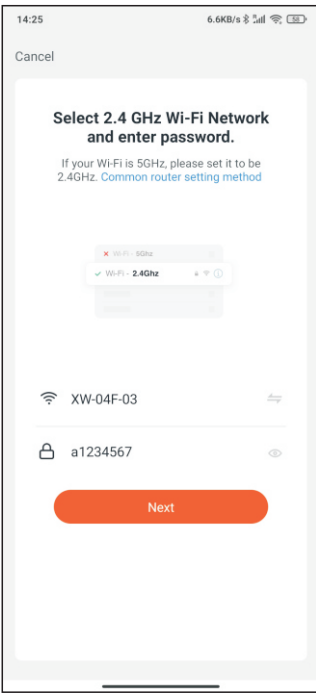
Step 3:

(Follow the prompts to operate.)



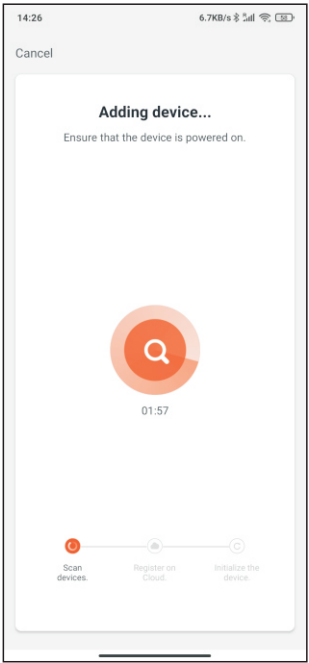
Step 4:

Step 5:

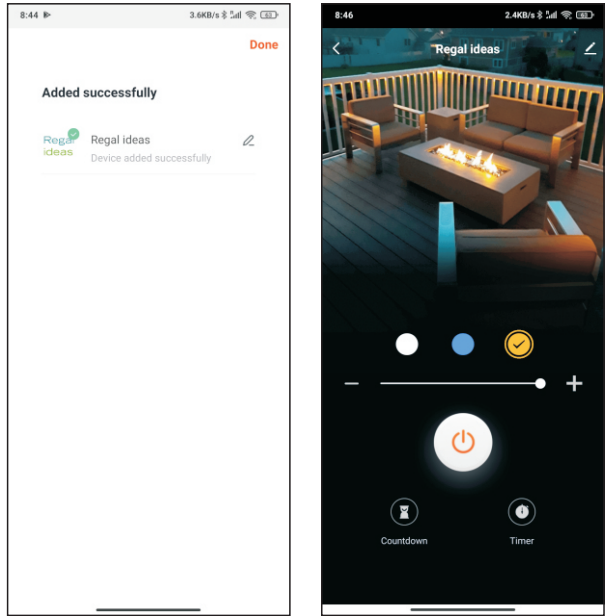
The device is registering the Cloud, hold on 1-2 minutes.



If the connection failed, please repeat the Step 3.

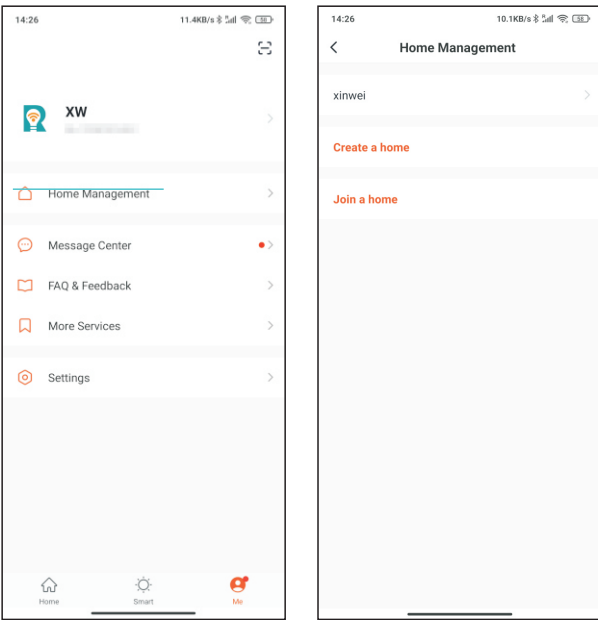
Step 6:
