During the test, each emission was maximized by: having the EUT continuously working, investigated all operating modes, rotated about all 3 axis (X, Y &amp; Z) and considered typical configuration to obtain worst position, manipulating interconnecting cables, rotating the turntable, varying antenna height from 1m to 4m in both horizontal and vertical polarizations. The emissions worst-case are shown in Test Results of the following pages. Duty cycle setting during the transmission is 100% with maximum power setting for all modulations.</p>



Test Procedure:	<div><div>1.</div><div>The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter camber. The table was rotated 360 degrees to determine the position of the highest radiation.</div></div> <div><div>2.</div><div>The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.</div></div> <div><div>3.</div><div>The antenna height is varied from one meter to four meters above the ground to determine the maximum value of the field strength.
