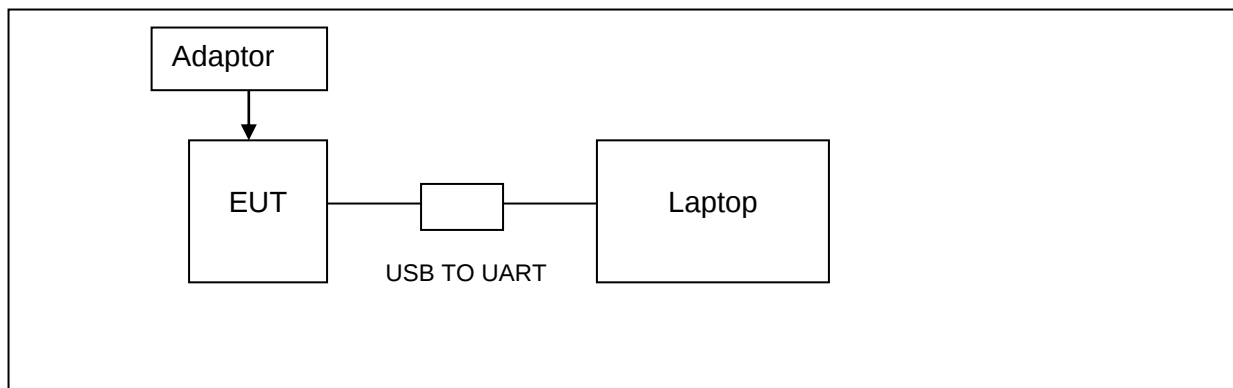

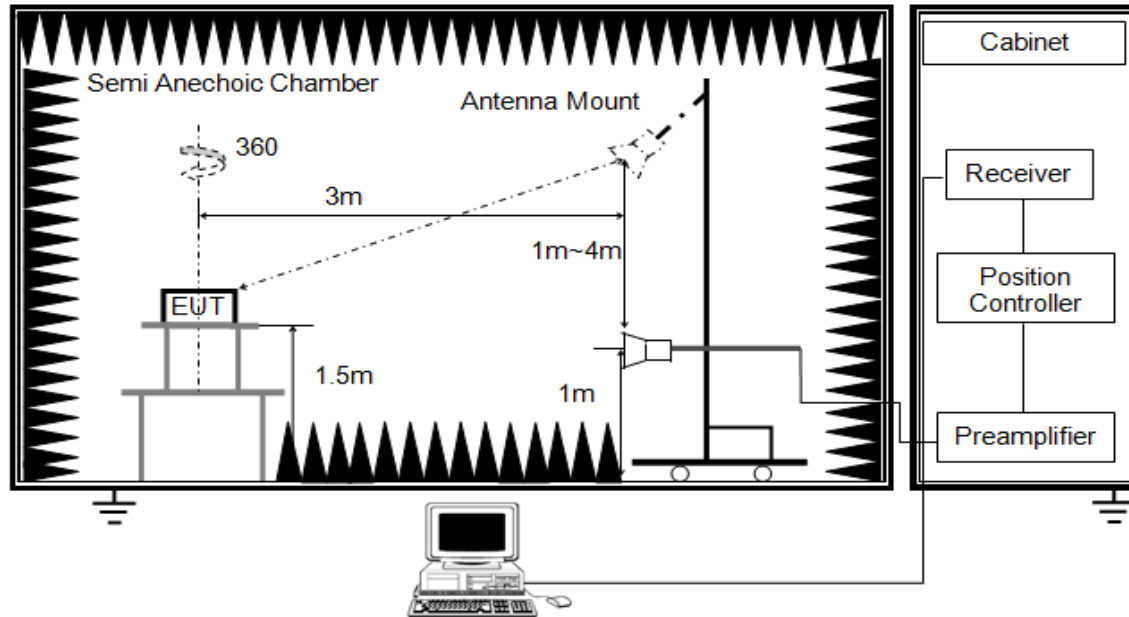

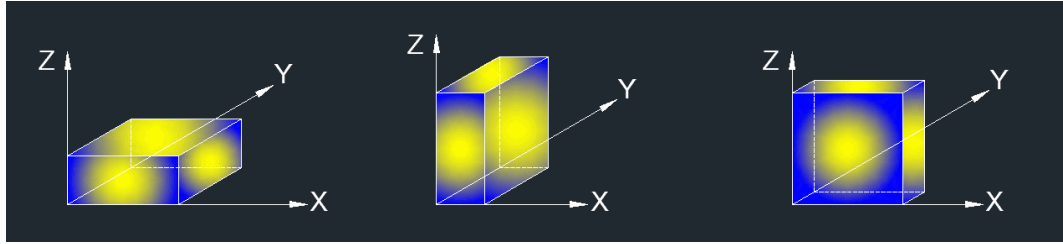

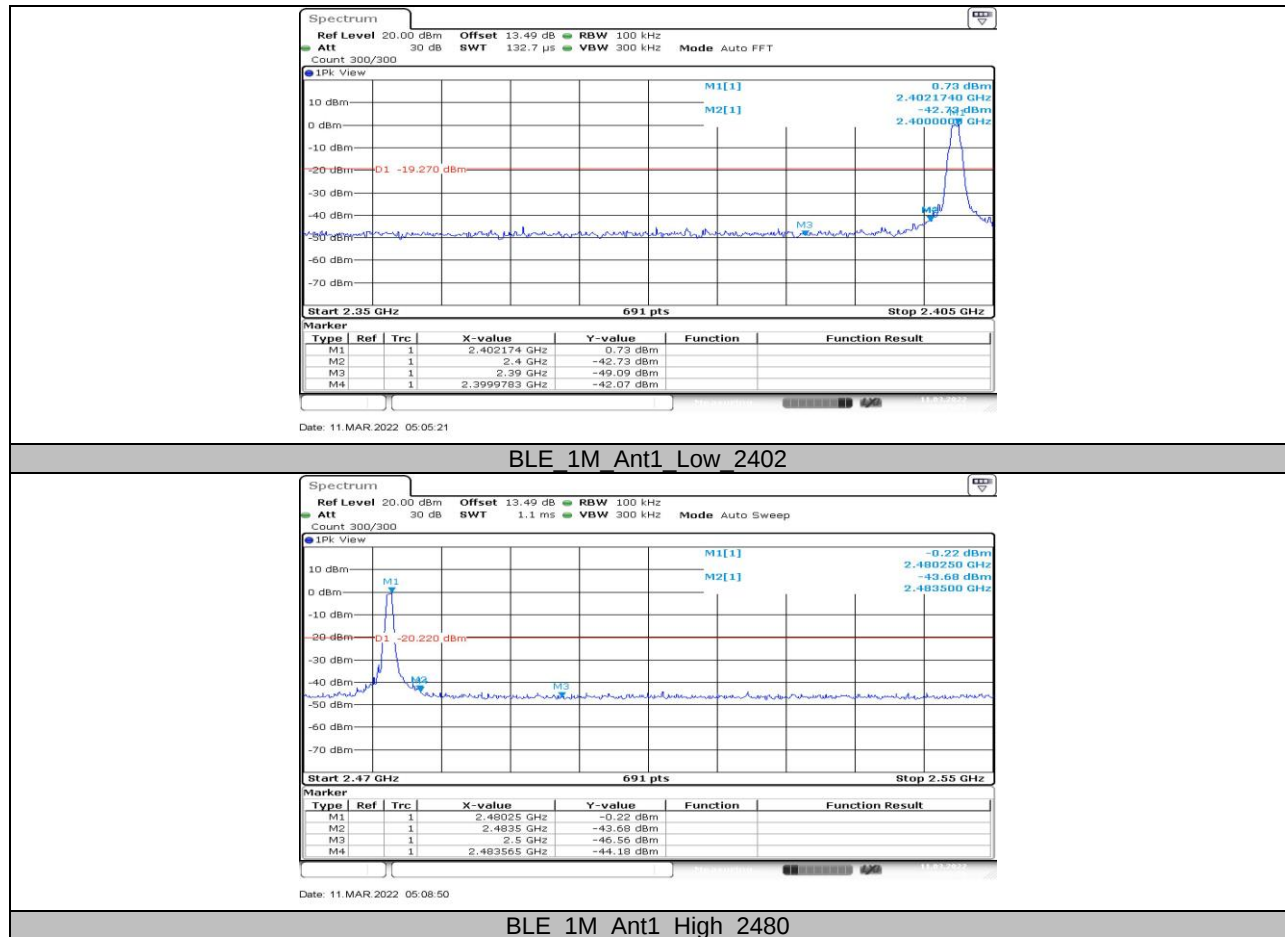

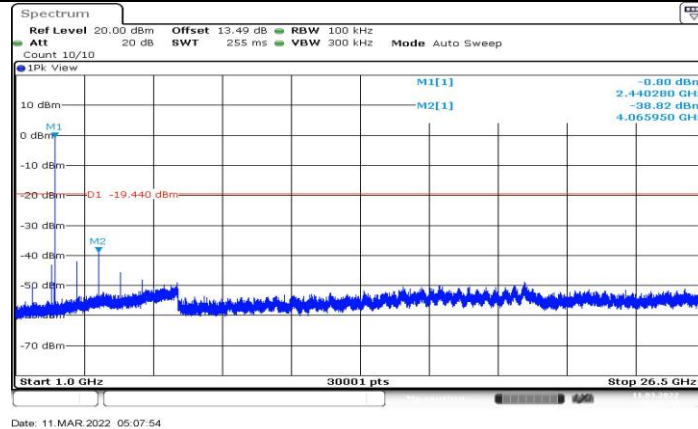




BLE 1M Ant1 2440 0-Reference



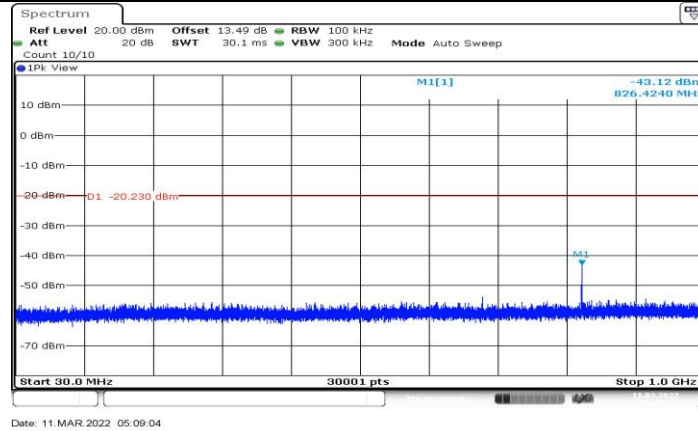
BLE 1M Ant1 2440 30-1000



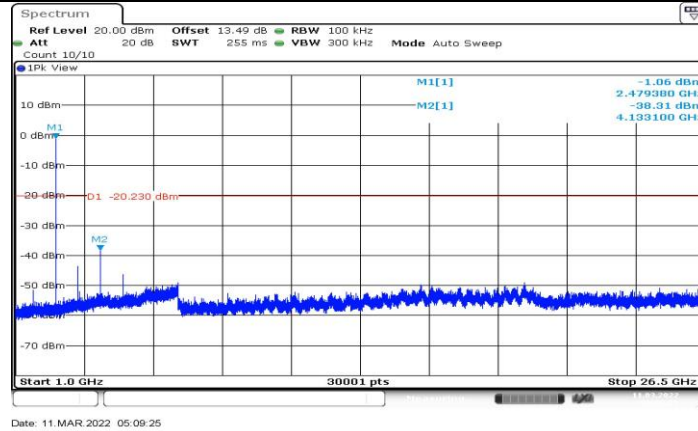
BLE 1M Ant1 2440 1000-26500

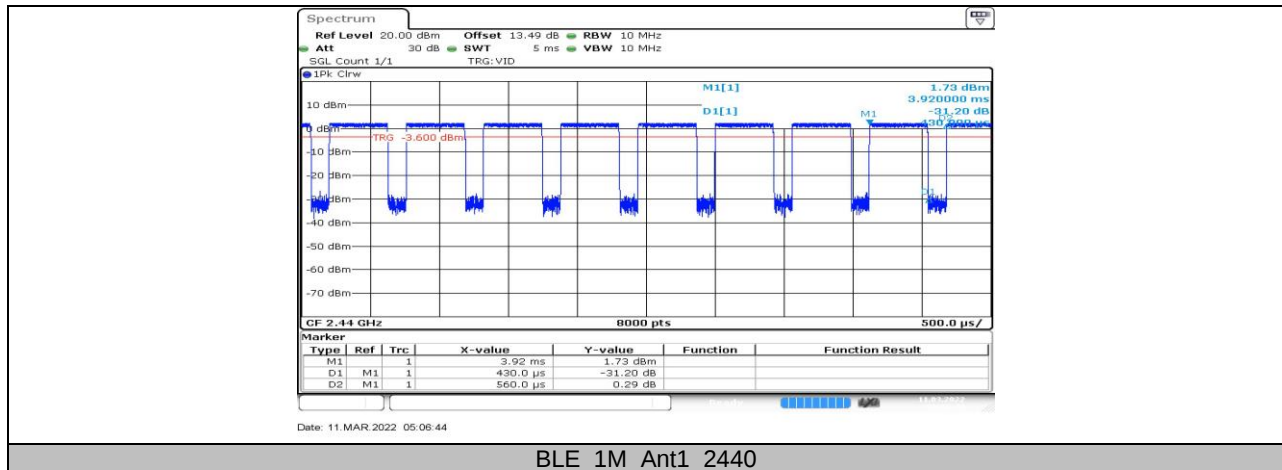
