The antenna is a FPC Antenna which permanently attached, and the best case gain of the antenna is 2.83dBi. It complies with the standard requirement.



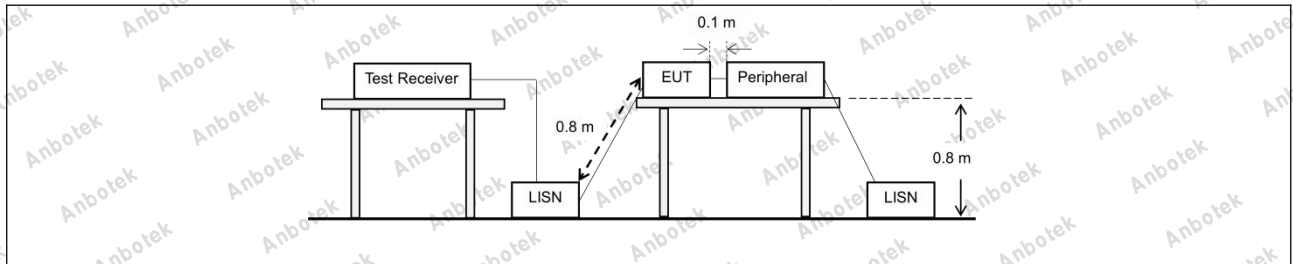
