3 RF Exposure Test Exemptions

3.1 1-mW Test Exemption

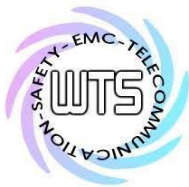

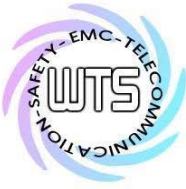
