## SAR Test Exclusion Calculations

1. FCC: According to KDB 447498 D01 Mobile and Portable Devices RF Exposure Procedures and Equipment Authorization Policies v06.

- (1) Clause 4.3: General SAR test reduction and exclusion guidance

- Sub clause 4.31: Standalone SAR test exclusion considerations

- 1) The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6GHz at test separation distance  $\leq 5$  mm are determined by:

- $$\frac{[(\text{max. power of channel, including tune-up tolerance, mW})/(\text{min. test separation, mm})] * [\sqrt{f_{\text{(GHz)}}}] \leq 3.0 \text{ for 1-g SAR}$$

- $$\frac{[(\text{max. power of channel, including tune-up tolerance, mW})/(\text{min. test separation, mm})] * [\sqrt{f_{\text{(GHz)}}}] \leq 7.5.0 \text{ for 10-g SAR}$$
