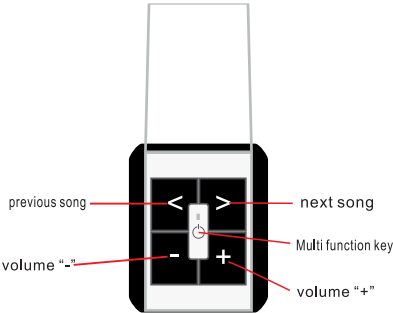


BH23 Bluetooth headset operating instructions

This product adopts the new head shape design, adopts the world famous brand CSR Bc05 Bluetooth stereo Bluetooth chip, ensure quality and stable performance and excellent communication with high fidelity Effect.
This product supports Bluetooth V3.0 version, support for Bluetooth A2DP and call function;

Function introduction



- 1. NEXT key: Bluetooth music player status short pull for a function
- 2. PREV key: Bluetooth music player status short pull for a function
- 3. VOL+ key: press to increase the volume level, long press for a rapid increase in volume
- 4. VOL- key: press the volume reduced level, long press to decrease the volume
- 5. Multi function button: press 4 seconds off, 7 seconds long to enter pairing state, red and blue light flash; music playing short press the play / pause, call state short press to answer the phone / 1.2 seconds long rejected calls / short press the answer key and then 1.2 seconds long to mobile phone calls. The match three minutes

did not connect automatically exit the pairing state, matching time is 3 minutes; when paired with red and blue lights flashing rapidly Not connected state blue lights flash once interval of about 2.5 seconds. Continuous short press the key function of two for heavy dial telephone. Mobile phone connection interval of about 5 seconds after the blue lights flash once; Bluetooth does not work, charging when the red light, red light is the completion of charging

Product operation

We first use long press the power switch for 7 seconds after the release, the red / blue light flash, Bluetooth headset enters pairing state; then open your Bluetooth devices (such as mobile phone) to search, search by name for the "DL-BH02", were paired with this device, if asked to enter the password, please enter 0000; and then confirm on the success of the product, and connection, connect the blue light every 5 seconds after blink. If you want to play music, short press the play button to open the product, or Bluetooth music player. When the call, press the answer key short for telephone, long press to refuse to listen. 4 seconds long to boot, blue light slow flash, automatically back to the last use of Bluetooth devices, long by 4 seconds for the shutdown, the red light
