





How to connect speaker to two Device

1. By BT Connect to the first device. After success pairing, turn off the BT of the fist device.
2. Turn on the Second BT device and apply pairing, Confirm the pairing.
3. After the Second device confirm pairing, turn on the first BT device. Now both device had been paired to the Speaker.
