







6 Radiated Emission Test

6.1 Test Method and test Procedure:

- (1) The EUT was tested according to ANSI C63.4 –2003. The radiated test was performed at Timeway Laboratory. This site is on file with the FCC laboratory division, Registration No.899988
- (2) The EUT, peripherals were put on the turntable which table size is 1m x 1.5 m, table high 0.8 m. All set up is according to ANSI C63.4-2003.
- (3) The frequency spectrum from 30 MHz to 25 GHz was investigated. All readings from 30 MHz to 1 GHz are Quasi-peak values with a resolution bandwidth of 120 kHz. For measurement above 1GHz, peak values with RBW=VBW=1MHz and PK detector. AV value with RBW=1MHz, VBW=10Hz and PK detector. Measurements were made at 3 meters.
- (4) The antenna high is varied from 1 m to 4 m high to find the maximum emission for each frequency.
- (5) Maximizing procedure was performed on the six (6) highest emissions to ensure EUT compliance is with all installation combinations. All data was recorded in the peak detection mode. Quasi-peak readings was performed only when an emission was found to be marginal (within -4 dB of specification limit), and are distinguished with a “QP” in the data table.
- (6) The antenna polarization : Vertical polarization and Horizontal polarization.

CH01 for 11g at 6Mbps: Vertical





CH06 for 11n HT20 at 65Mbps: Vertical





CH01 for 11n HT40 at 65Mbps: Vertical





CH04 for 11n HT40 at 65Mbps: Vertical







7.3 Test Procedure

1. Set resolution bandwidth (RBW) = 100 kHz
2. Set the video bandwidth (VBW) $\geq 3 \times$ RBW.
3. Detector = Peak.
4. Trace mode = max hold.
5. Sweep = auto couple.
6. Allow the trace to stabilize.
7. Measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission.
