1. What Have You Bought?

PayAnywhere Plus – A Smart POS solution powered by an Android tablet and the PayAnywhere application. The solution is mounted on a secure base that rotates and tilts for ease of transaction entry and capturing customer signatures.

USB charger & USB cable supplied



Note: Product is sold in white and black. White product is being submitted to FCC for testing purposes.

2. Powering On the Smart POS solution

Press and hold the button on the upper left enclosure until the unit begins its power on sequence.



3. Charging the Smart POS solution

Plug the USB cable into the base of the stand

4. How to process a transaction using PayAnywhere from the Android tablet


A. Load the PayAnywhere application. Enter correct "Username" and "Password" of your account, click the green bar to get permits to enter, or just select "Test Drive" (for testing only) to enter without an account



B. After selecting "Sell", the following screen appears briefly




C. Select Express Sale, then select an item (or items), then press green bar to "check out"



D. Swipe a credit card as demonstrated below



E. Upon successful scan, the following symbol is shown

5. How to move / rotate the base / tablet enclosure

A. The stand rotates at the base and the tablet enclosure moves up and down, as demonstrated in the image below





6. Stand Features

The stand provides access to stand base to allow for the removal of the suction cup that is used to affix the stand to the countertop.



The picture to the right demonstrates the screw that is used to attached the suction cup. The same screw can be removed and the suction cup can be taken away.
