



### 3. Auto-Update oftheApplication




## 4. Installingofwirelessnetwork

Fortheuseofthe POS App an internetconnectionisrequired. Tosetupthewirelessnetwork, pleasefollowthosesteps


- 1)Quittheapp (see "Exit the terminal appwithpassword").
- 2) From the Home screen, out, start the Settings / Properties App.




3)Enable "Wi-fi "(seepicture).

## 5. Trouble Shooting

Ifyouhaveproblemswiththe auto-update, oriftheapp will not start, thereis a recoveryversionoftheapp (also bymeansoficon in theappslisted on the Device).



The opening of Terminal Recovery App enforces installing the latest application, ensuring that the app can be updated in any case.

#### FCC RF Exposure Information and Statement

The SAR limit of USA (FCC) is 1.6 W/kg averaged over one gram of tissue. Device types: FK-POS4S (FCC ID: 2ABTW-FK-POS4S) has also been tested against this SAR limit. The highest SAR value reported under this standard during product certification for use at when properly worn on the body is 0.3182W/kg. This device was tested for typical body-worn operations with the back of the handset kept 1.5cm from the body.

To maintain compliance with FCC RF exposure requirements, use accessories that maintain a 1.5cm separation distance between the user's body and the back of the handset. The use of belt clips, holsters and similar accessories should not contain metallic components in its assembly.
