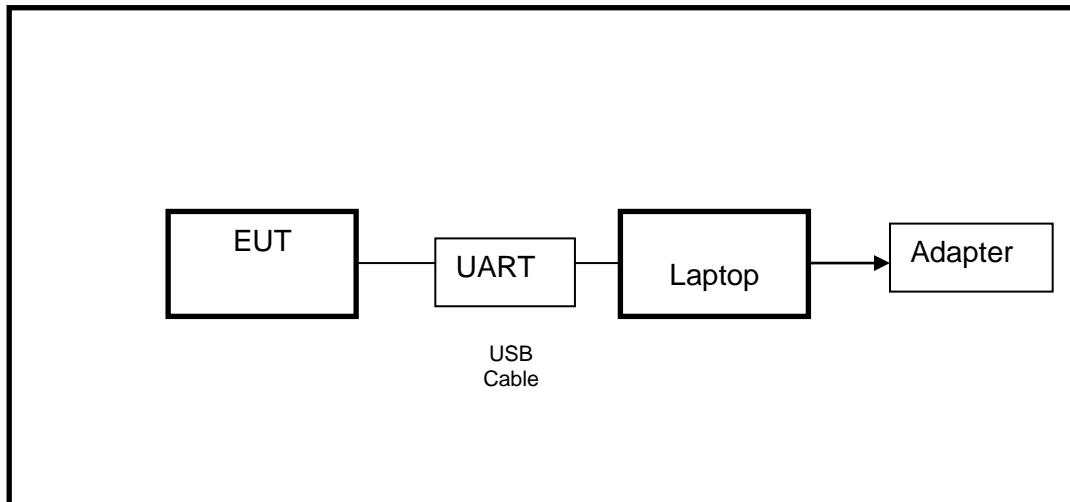

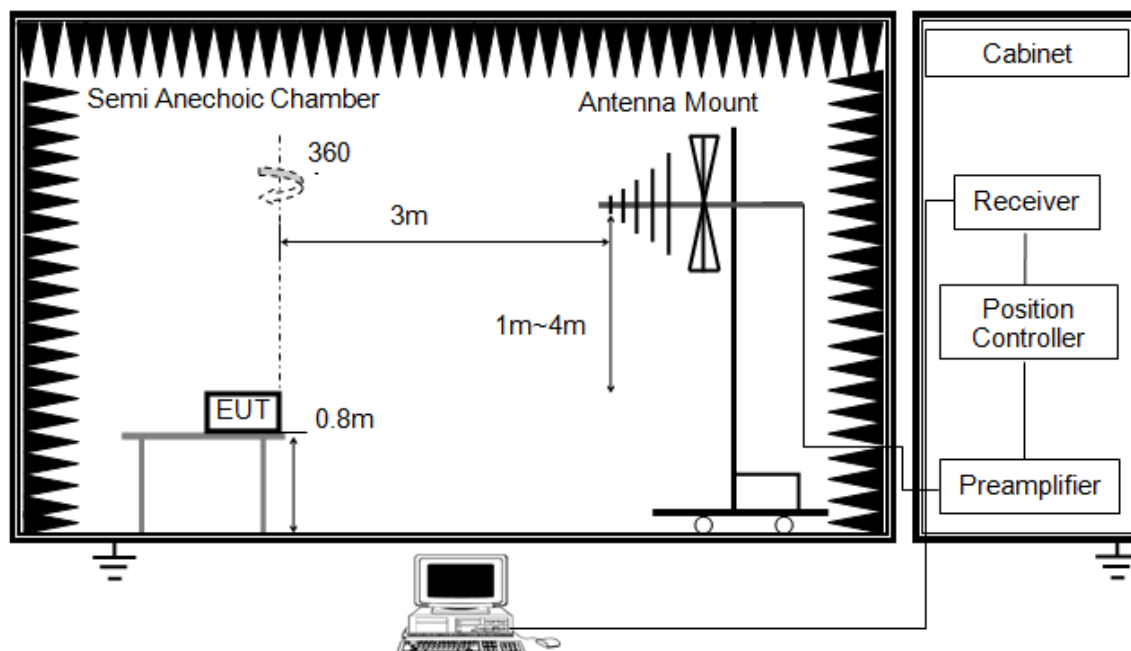

2. The EUT was arranged to its worst case and then turntable (from 0 degree to 360 degrees) to find the maximum reading. 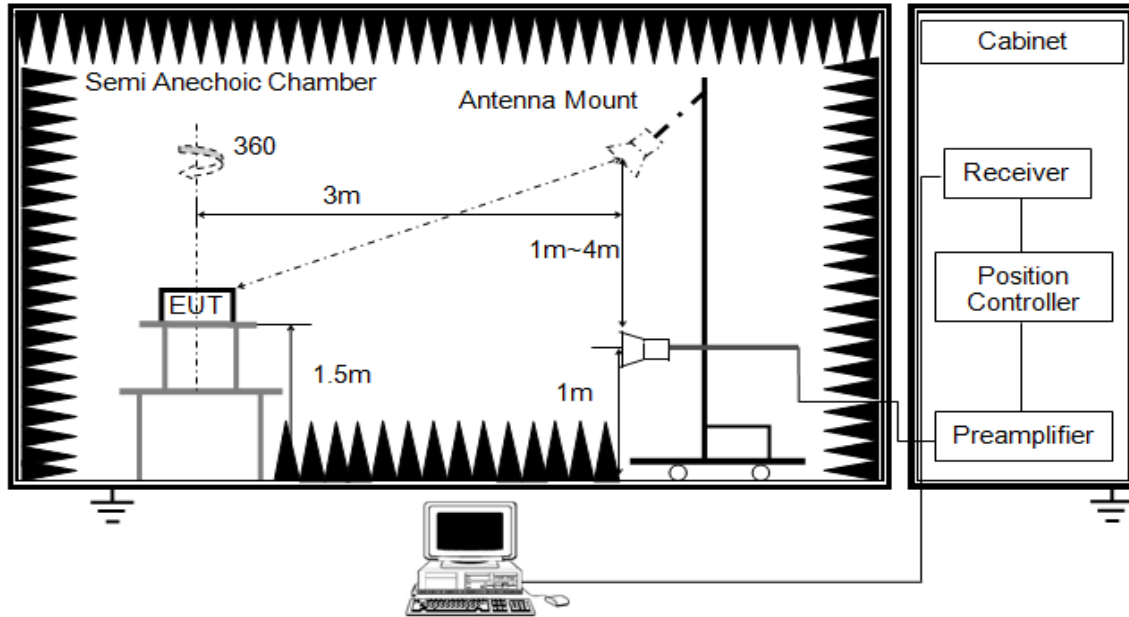

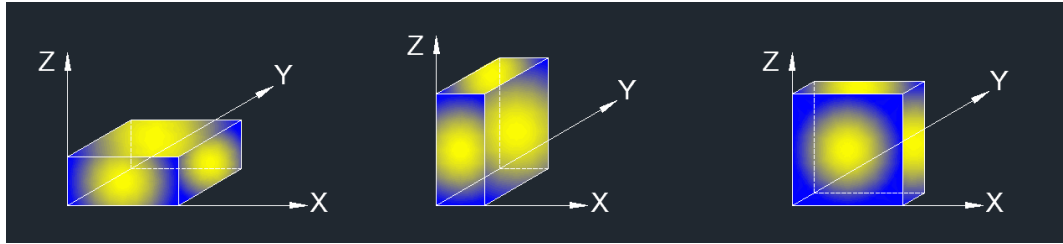

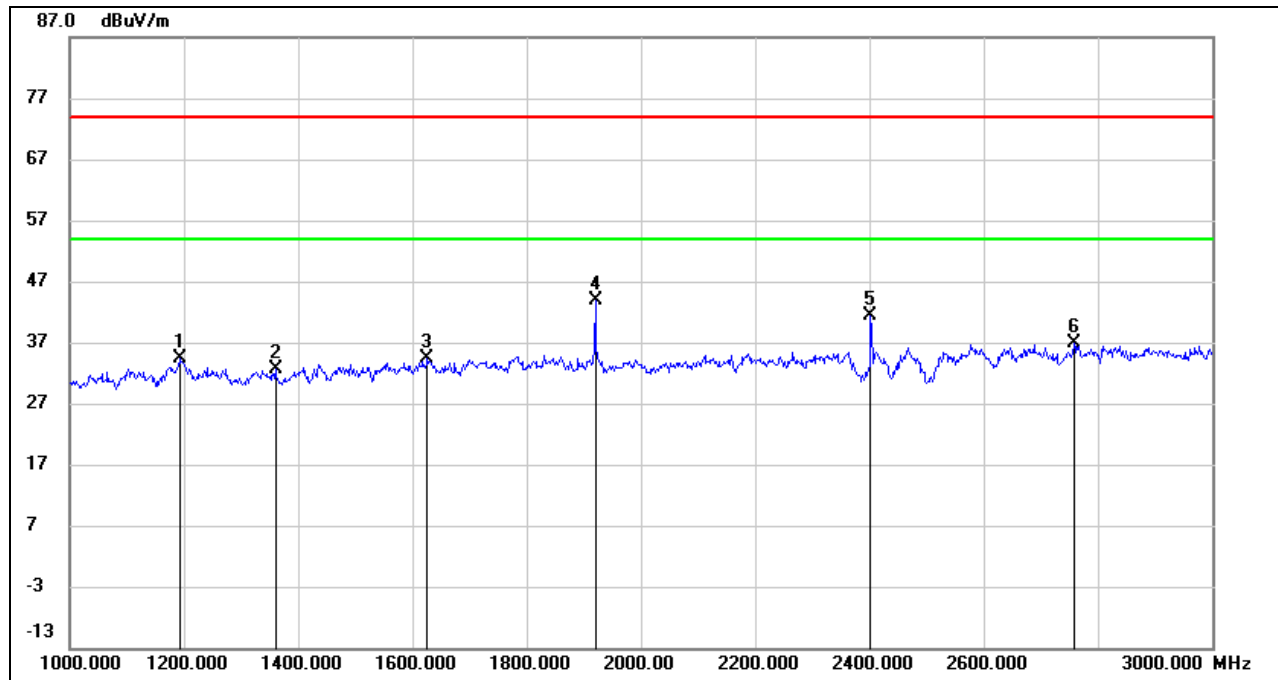
