1. The modular transmitter must have its own RF shielding.	EH-MB05 module contain shielding.
2. The modular transmitter must have buffered modulation/data inputs.	EH-MB05 module uses single Bluetooth chip which integrated buffered modulation/data inputs
3. The modular transmitter must have its own power supply regulation.	EH-MB05 module incorporates regulators to ensure operation in specified power rage
4. The modular transmitter must comply with the antenna requirements of Section 15.203 and 15.204(c).	EH-MB05 module a trace layout antenna .Please see user manual .
