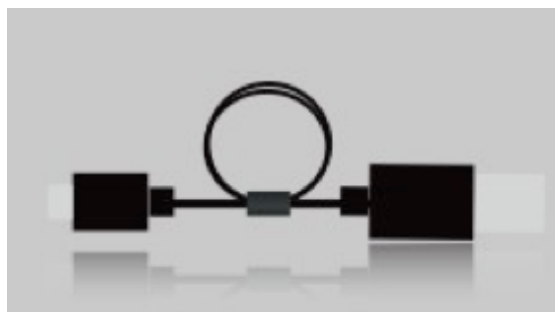

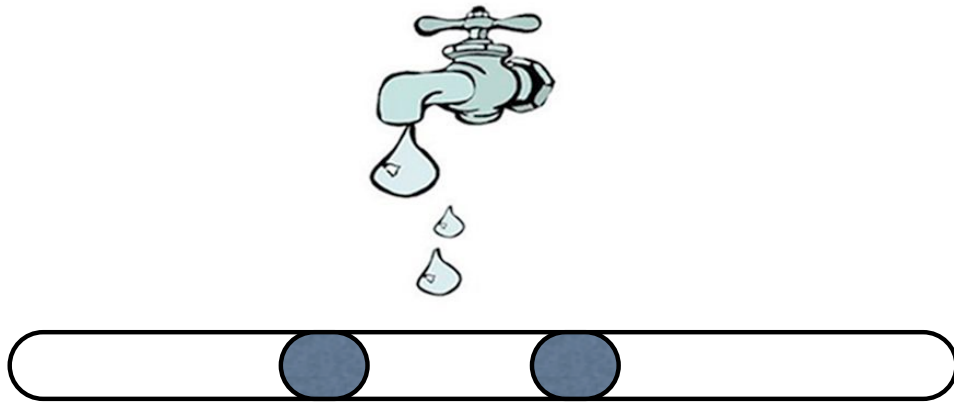
## 第一次使用

# Indemnification Clause

---

## **bOMDIC Term of Use**

This Term of Use ("Agreement") is a legal agreement between you and bOMDIC, Inc., a company incorporated under the laws of Taiwan (R.O.C.) having its registered office at 2F., No.326, Sec. 3, Huilai Rd., Xitun Dist., Taichung City 407, Taiwan (R.O.C.) ("bOMDIC"). Please read it carefully before completing the download and installation of the Software (as defined below). By installing or using any part of the Software and/or Hardware, you are confirming your acceptance of this Agreement and agreeing to become bound by the terms, especially provisions regarding warranties and limitation of liabilities. If you do not agree to be bound by these terms, please do not download, install, or use the Software and/or Hardware (as defined below).

IMPORTANT NOTICE: The Hardware uses mild electricity through human body so as to obtain certain statistics. If you are using a pacemaker or any other devices that may malfunction because of electricity; if you are allergic to electricity or have been using cardiac catheterization; or if you have any history of heart irregularities or disease, please consult your doctor before using bOMDIC devices, otherwise bOMDOC will not be liable for any sickness or injury. In addition, if you are allergic to cotton, polyester, natural fibers or artificial fibers or you suffer any similar malaise during the use of Hardware, please immediately stop your use. Please further note that the statistics provided by the Software and/or Hardware are for your references only, and such statistics shall not be any substitute of medical testes or doctor's advises. Your acceptance to this Agreement also means that you agree to consult doctors for all the matters above, and you agree to be responsible for your health and body functions.

### **1. Definitions**



- 1.1 “User(s)” means customer and user of the Hardware or Software, no matter obtained through physical or online sales channels, aftermarket, or by borrowing or rental of the Hardware or Software;
- 1.2 “Software” means any information, computer program or firmware, either marked “bOMDIC” or “GoMore” or not, which can be used on computer, mobile devices or mobile phones, including but not limited to webpage, source code, formula, graphics, charts, and other content and associated works (if any) downloaded by the User. “Software” may also refer to Software licensed by a third party, including but not limited to the open-source Software licensed under other Software licensing terms (“Third-Party Software”). Any updated version of the Software or Third-Party Software are included in the definition provided herein;
- 1.3 “Hardware” means GoMore device produced or sold by bOMDIC, including the main parts, spare parts, any components and/or replacements.
- 1.4 “Trademark” means any graphic, mark, servicemark, or product name used to identify “bOMDIC” or “GoMore”. Trademark referred herein shall not be used in connection with product or service of any third party without bOMDIC’s prior consent. For the purpose of providing Hardware or Software, bOMDIC may use the product name, trademark or servicemark owned by a third party; however, it is understood that the foregoing product name, trademark, or servicemark belongs to the said third party. bOMDIC’s use of the foregoing does not mean or imply that bOMDIC has the right to sublicense such rights.

## **2. License Conditions and User’s Representations**

- 2.1 The User represents that he/she understands the rights and obligations under the terms of this Agreement, and is legally and physically capable of accepting the terms of this Agreement. In the event that the User is a minor (below the legal age to sign contracts), the User shall read this Agreement with the assistance of their parents or guardians. The User agrees that bOMDIC may, from time to time, amend this Agreement. Once the User continues to use the Hardware or Software, it is considered as the User’s acceptance of the amended version of Agreement.
- 2.2 The User agrees that the maintenance of physical health is the User’s own responsibility, and, while using the Hardware or Software, it is also the User’s

responsibility to consult doctors. It is further understood by the User that the Hardware or Software cannot be the substitute of medical examination or doctor's advices.

- 2.3 It is agreed that when the User downloads, installs or uses the Hardware or Software, the User is bound by all the terms and conditions of the Agreement at the time of download, installation or use. bOMDIC agrees to grant a non-exclusive license for the User to use the Hardware or Software under this Agreement.
- 2.4 In the event that the use of Hardware or Software concerns any third party software, the User agrees to use the third party software in accordance with the terms and conditions provided by the said third party or within the scope of license from that third party to bOMDIC.
- 2.5 bOMDIC reserves the right to alter the Hardware or Software. The User agrees that bOMDIC may suspend the services of Hardware or Software, either temporarily or permanently, with or without notice.
- 2.6 The User shall not sublicense the Software or Hardware to any third party, and the Hardware or Software shall not be used for commercial purpose, non-personal or non-family purposes, or any other similar purposes.
- 2.7 The User agrees not to alter, modify, adapt, create derivative works, decompile, translate, decrypt, deconstruct, disassemble or otherwise attempt to reverse engineer the Software, or permit, authorize or encourage any other party to do the same.

### **3. Limited Warranty, Limited Liability and Disclaimer**

- 3.1 bOMDIC provides one (1) year limited warranties for the Hardware. For more information, please see the website: [\[http://www.bomdic.com/warranty\]](http://www.bomdic.com/warranty). Except for the warranties provided in bOMDIC's website, bOMDIC disclaims any other warranties to the Hardware.
- 3.2 bOMDIC does not warrant the performance, availability, uninterrupted use or operation of the Hardware or Software even when it is explicitly requested by the User.
- 3.3 The User is prohibited to combine the Hardware with Software and/or parts that are not approved or remarked by bOMDIC, and bOMDIC does not warrant the safety or quality of the use with unapproved or unremarked Software and/or parts.

- 3.4 bOMDIC may, with or without notice, from time to time, alters, suspends, removes or cancels the storage of the content, or the function of the Software or Hardware. bOMDIC disclaims the warranties of the storage of the content and the safety of the content produced through the User's use of the Hardware or Software.
- 3.5 bOMDIC does not guarantee the uninterrupted use or correctness of the Hardware or Software. In addition, the operation of the Hardware or Software is based on the Internet services, but bOMDIC has no control over and does not warrant the stability of the Internet.
- 3.6 bOMDIC provides limited compensation for the damages resulting from the use of the Hardware or Software, wherein such limited amount of the compensation shall not exceed the aggregated amount of the purchase price paid by the User suffering the damage. Notwithstanding the above, the compensation shall not in any event exceed US\$150. However, please note that any damages resulting from misuse (including but not limited to, disobedience to the product use instruction or safety instructions, distraction during the use of Hardware or Software) shall not be indemnified. If in any event the above limitation of compensation must be raised under the applicable laws and government or court rulings, the interpretation of this Agreement and its limitations shall be made in accordance with the context hereof to the possible extent permitted under the laws.
- 3.7 Unless otherwise stipulated by law, bOMDIC or its supplier shall in no event be liable for any direct or indirect damages of a third party. In the event that bOMDIC or its supplier shall be responsible for damages suffered by a third party under the operation of laws, government or court ruling, the amount of compensation shall not in any event exceed US\$50. If in any event the above limitation of compensation must be raised under the applicable laws or court orders, the interpretation of this Agreement and its limitations shall be made in accordance with the context hereof to the extent permitted under the laws.
- 3.8 bOMDIC expressly disclaim any warranties made by its suppliers or any third party. In the event that the supplier's or third party's warranties are beyond the scope of warranties made by bOMDIC, the User shall promptly notify bOMDIC of such event. Unless otherwise specified in writing, bOMDIC does not make any warranties other than that specified in this Agreement.

#### **4. Intellectual Property ("IP") Policy**

- 4.1 The IP rights of Hardware and Software include the copyright, patent, trademark, trade secret, and other type of IP rights. bOMDIC hereby grants a non-exclusive license of the IP rights contained in the Hardware and Software to the User in accordance with this Agreement.
- 4.2 The User agrees not to alter, modify, adapt, create derivative works, decompile, translate, decrypt, deconstruct, disassemble or otherwise attempt to reverse engineer the Software, or permit, authorize, encourage or assist any other party to do the same. It is further agreed that the User shall not use the licensed IP rights by altering, modifying, translating, leasing, lending, or reselling the Hardware or Software.
- 4.3 It is understood and agreed that the User does not obtain any IP ownership by such license, and the User shall not sublicense any IP rights herein to any other party. The User covenants not to invalidate, revoke, or by any means make the IP rights void or cancelled.
- 4.4 bOMDIC does not guarantee the non-infringement of any third party IP rights contained in the Hardware or Software, and bOMDIC disclaims any liabilities of indemnification or compensation to any User for any infringement of the IP rights.
- 4.5 The User acknowledges and agrees that, the data generated from the use of the Hardware or Software may be collected by bOMDIC. The User hereby freely license the IP rights of such data to bOMDIC, and bOMDIC is allowed to further license the IP rights to any third party, either with or without collecting fees from the third party.

#### **5. Privacy Policy**

- 5.1 By using the Hardware or Software, the User gives bOMDIC a permission to collect information about the User, including but not limited to personal information, locations, and contacts ("Information").

## **6. Termination**

However, if disputes cannot be settled, bOMDIC and the User submit the exclusive jurisdiction of this Agreement of Taiwan Taipei District Court.
