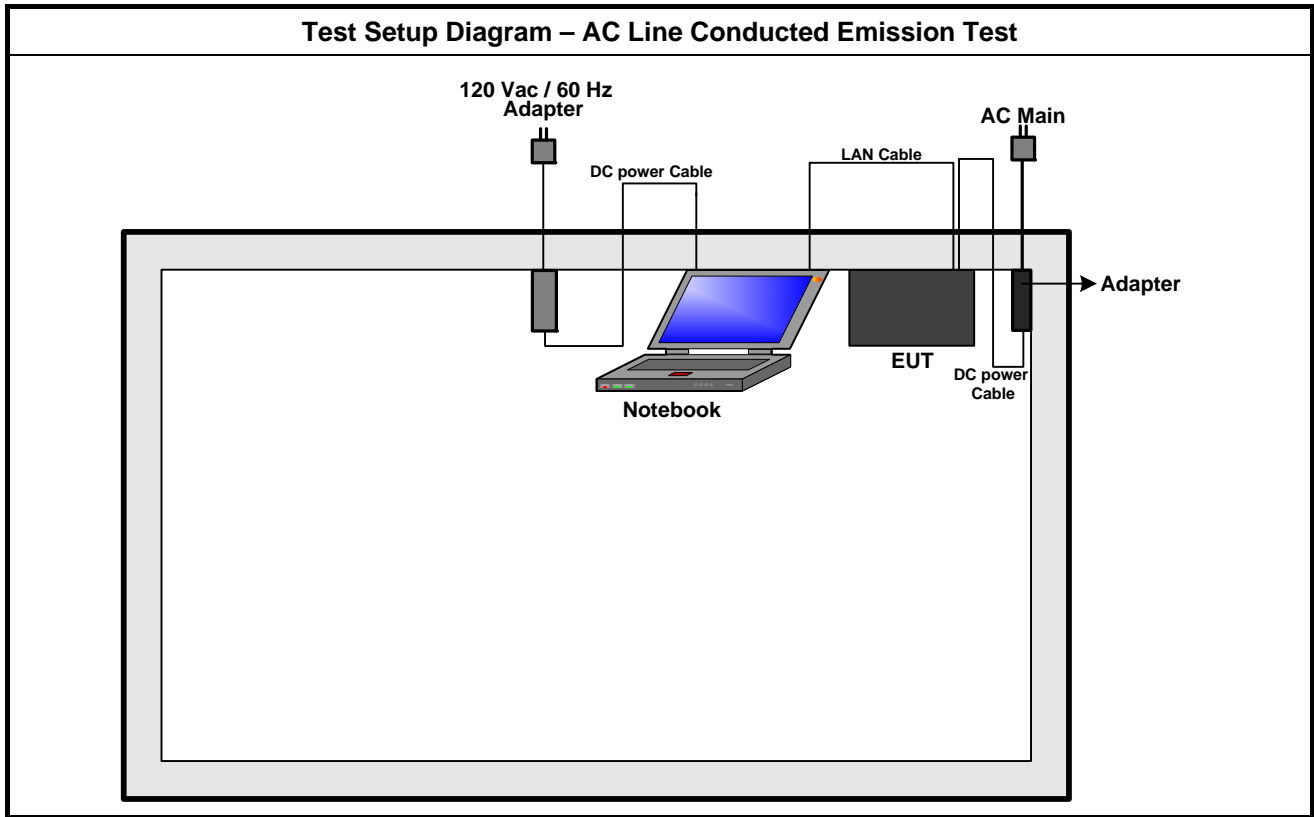

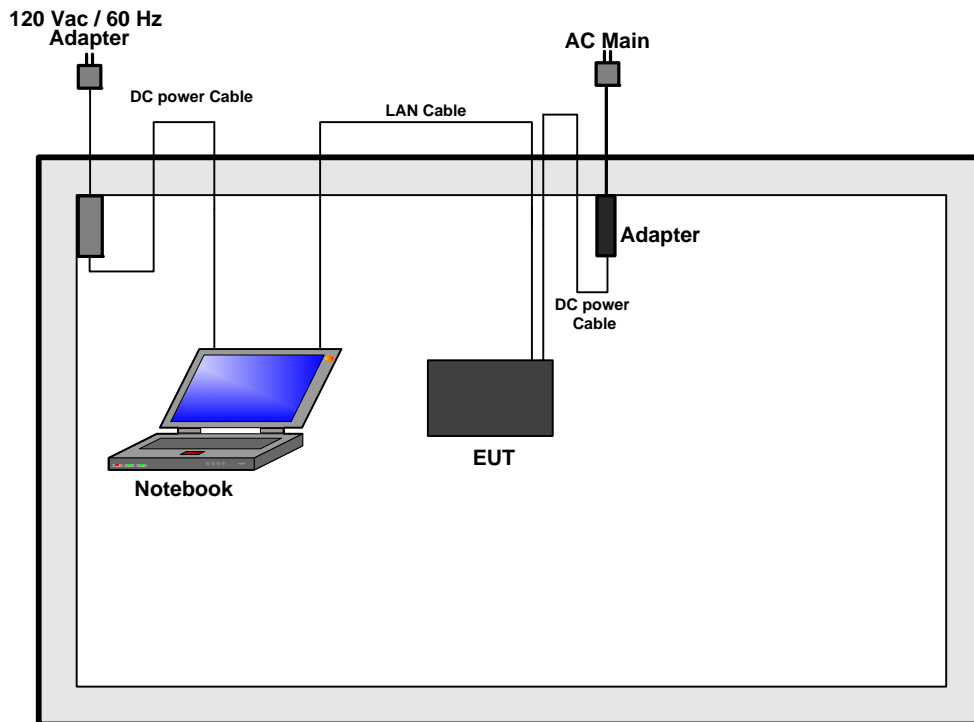

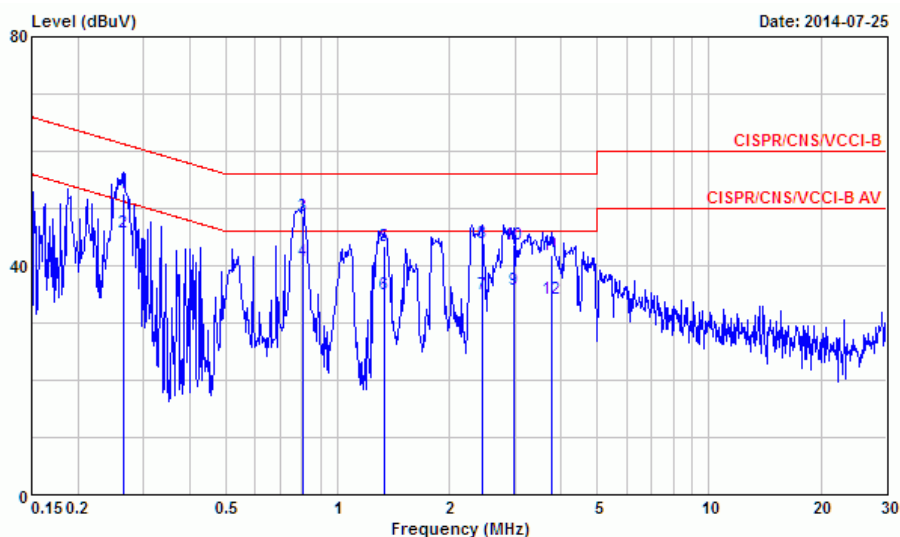

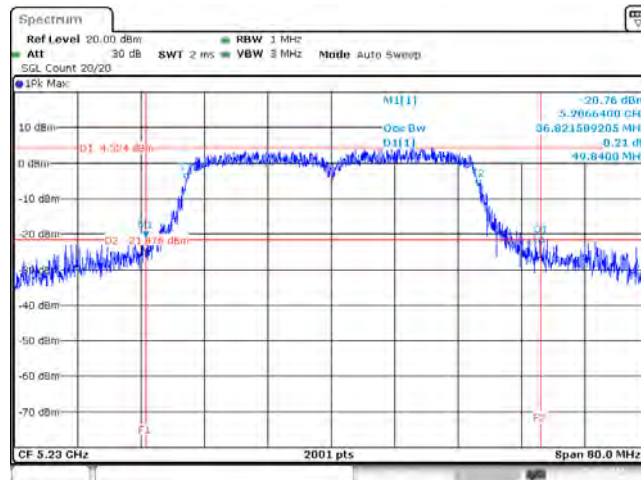

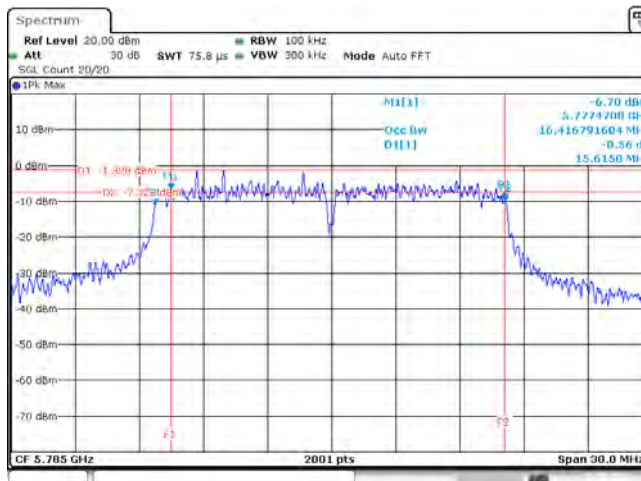

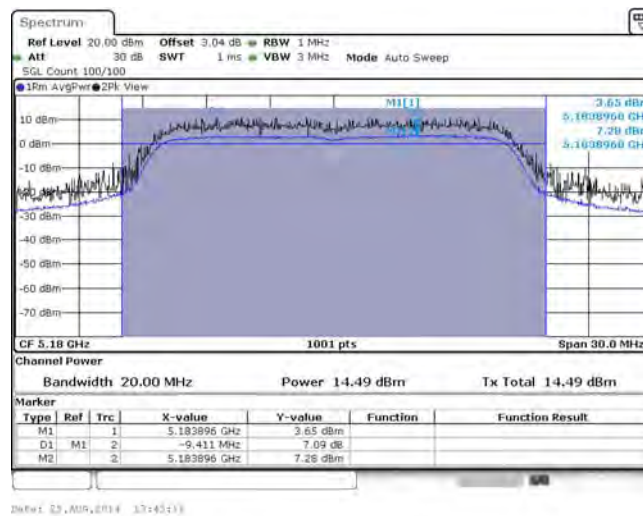

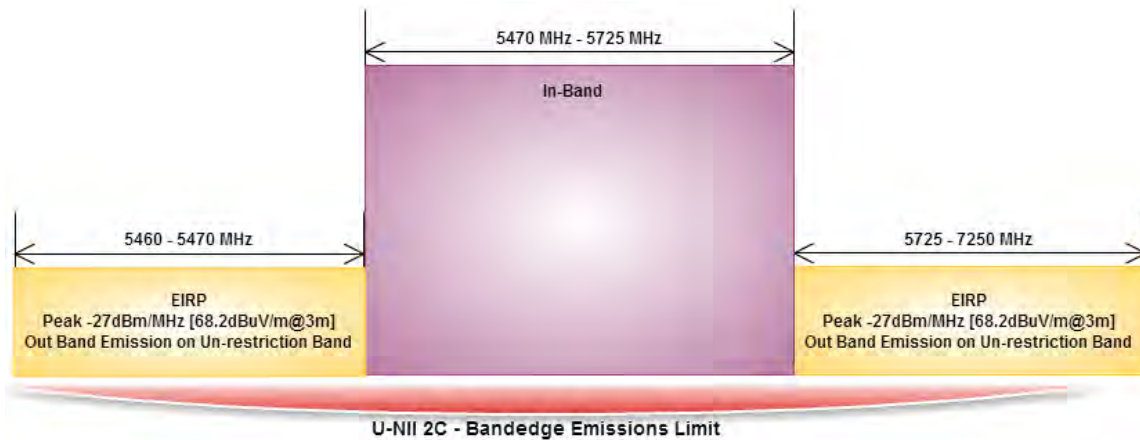
**5150-5250MHz - Worst Power Spectral Density Plots**

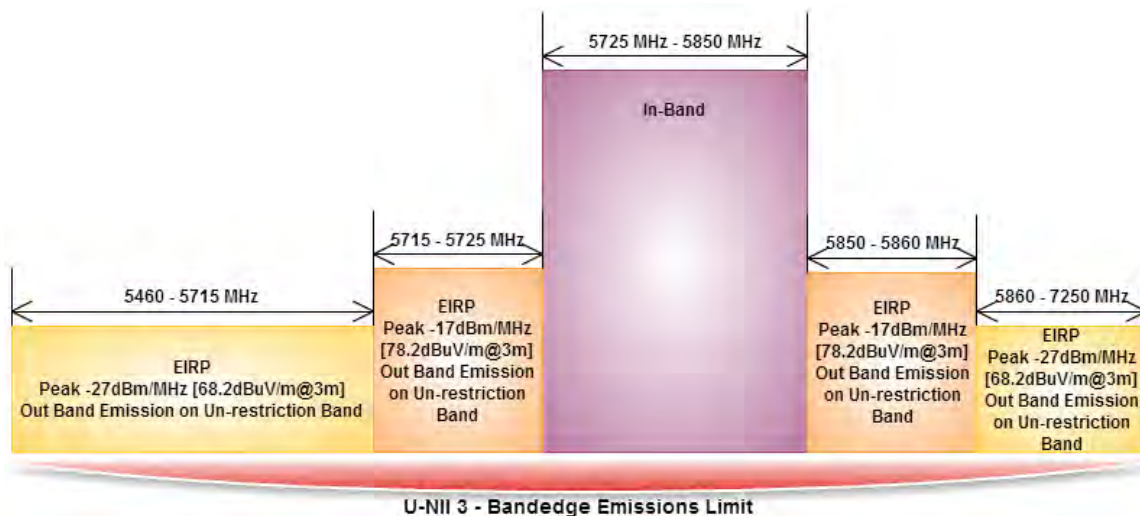
