## A 3-Minute User Guide



### 1. Recommended Routine

- Start with cleansed and dried skin for accurate results.
- In analysis mode, place the device on the center of your cheeks and wait 3 seconds. It will automatically recommend the mode your skin needs (Boosting/Double Toning/Relaxing Up).
- After sufficient skincare, place the device back on your face and the recommended mode will run for 3 minutes.
- Treat your entire face in an oblique upward motion for Boosting/ Double Toning modes.
- For modes Relaxing Up and Contouring, press gently on one area of your face for seconds.

### 2. Optional Routine

- Start with well-cleansed and prepped skin.
- Select the mode using the buttons on the front and treat your skin for 3 minutes. (Boosting/DoubleToning/RelaxingUp/Contouring)
- Relaxing Up and Contouring modes can be used additionally on the jawline, for example, where firmness is a particular concern. Simply place the device on the area of concern for seconds, and move it to the next area for intensive care.



## Essential Precautions Before Use

Use	<ul style="list-style-type: none"><li>• Always keep the device in close contact with the skin so that all sides of the device are in contact with the skin (except in analysis mode).</li><li>• Mild irritation may be felt due to the effect of the microcurrent. In this case, please apply plenty of cream.</li><li>• Do not use on areas that are seriously reddened or swollen due to skin irritation during use, and stop using until it disappears.</li><li>• Do not use on infected, burned or cut skin as skin damage may occur.</li><li>• If you have a wound on your skin, please treat it before use.</li><li>• We have completed the "Photobiological Safety_IEC-62471" test for LED light source, but please be careful not to look directly at the light. When using around the eyes, please close your eyes or keep the device as close to the skin as possible to prevent light from leaking out.</li></ul>
Storage	<ul style="list-style-type: none"><li>• Do not drop the product or subject it to external impact.</li><li>• Do not allow children or pets to put the product in their mouths or chew on it.</li><li>• Store at room temperature away from direct sunlight, do not store at too high or too low temperatures.</li><li>• Please be sure to clean and remove cosmetics after use before storing.</li><li>• Do not leave in direct sunlight for a long time. It may cause discoloration.</li></ul>
Charge	<ul style="list-style-type: none"><li>• Can be used about 35 times with a full charge within 2 hours.</li><li>• Recharging is required when the 'beep beep beep' sound &amp; red alarm light flashes. After the initial alarm, you can expect about 1-3 additional treatments. If charging does not proceed after the alarm, the device may be forced to turn off during use with a 'beep beep beep' sound.</li><li>• The red alarm light dims when charging starts, and the white alarm light dims when charging is complete.</li></ul>
