

### 6.4. Test Procedure

The Notebook connected to the power mains through a line impedance stabilization network (L.I.S.N.#2). This provides a 50 ohm coupling impedance for the EUT. Please refer the block diagram of the test setup and photographs. The other peripheral devices power cord connected to the power mains through a line impedance stabilization network (L.I.S.N.#1). Power on the PC and let it work normally, we use a keyboard test soft ware, let EUT working in test mode, then test it. Both sides of AC line are checked to find out the maximum conducted emission. In order to find the maximum emission levels, the relative positions of equipment and all of the interface cables shall be changed according to FCC Part 15C on Conducted Emission Test.





## 7.4. Test Procedure

The EUT and its simulators are placed on a turn table, which is 0.8 meter high above ground. The turn table can rotate 360 degrees to determine the position of the maximum emission level. The EUT is set 3 meters away from the receiving antenna, which is mounted on a antenna tower. The antenna can be moved up and down between 1 meter and 4 meters to find out the maximum emission level. Broadband antenna (calibrated bilog antenna) is used as receiving antenna. Both horizontal and vertical polarization of the antenna is set on Test. In order to find the maximum emission levels, all of the interface cables must be manipulated according to ANSI C63.4-2009 on radiated emission Test.

### 8.2. Test procedure

1. The EUT operates at hopping-off test mode. The lowest or highest channels are tested to verify the largest transmission and spurious emissions power at the continuous transmission mode.
2. Max hold the trace of the step 1, and the EUT operates at hopping-on test mode to verify the largest spurious emissions power.
3. Set the spectrum analyzer in the following setting in order to capture the lower and upper band-edges of the emission:
  - (a) PEAK: RBW=VBW=1MHz / Sweep=AUTO
  - (b) AVERAGE: RBW=1MHz ; VBW=1/on time(3KHz) / Sweep=AUTO
