1st step:

Switch on phone Bluetooth and search the "supreme icanany" when power on selfie stick in its bottom (the blue light will shine) then can pair the bluetooth



2nd step:

Click the Bluetooth name "supreme icanany" and pair when succeed the blue light will off. Open camera app and shoot by selfie stick. Function description: Zoom: press "+" button to zoom in while press "-" to zoom out (but this zoom function only works on Samsung phone and pad and some commonly used systems)



3rd step:

The clip can rotate around 270 degree people can choose a perfect angle and put phone inside the holder. After firmly hold the phone, extend to pole one section by one



4th step:

When choose the ideal angle please screw firmly to fix the position. Choose the view and press the camera button on the handle. Charge- power off- take in: insert the one side of MICRO-USB cable into the charging port of the stick, the other side connects the USB 2.0 port the red light on. When full charged, the blue light will on. Power off when all light off. And hold the handle with one hand and the other hand hold the top to fold the pole



5th step : phone stand

Warm tips: please store correctly, inedible, it is not a violent tool to harm others, do not break the pole violently, keep away from fire, shake hardly when hold the phone of which weight more than 300g will lead to phone dropping and damage
Notice: supreme mini II supports IOS 5.0 and above system. It can control the volume even if it can not zoom for ios. It works on Samsung and other Android 2.3.6 and above system. android system is a open source system so some phone still can not use the zoom and camera function.
