

Waterproof Bluetooth Speaker User Manual

Features

- 1. Bluetooth wireless technology, play music via Bluetooth
- 2. MP3 Player function, directly play MP3 music from TF card.

Instruction

Bluetooth Pairing

- 1. Long press Key ① to turn on the speaker. It defaults to Bluetooth connection mode. The indicator light will flash and wait for pair device.
- Manually search speaker: turn on Bluetooth capability on your phone or other devices, search the device name and pair the device. Once paired with a device successfully, you will hear an indicator tone "Du".

External Audio Input

- 1. Long press key ① to turn on the speaker.
- 2. Plug audio cable to the speaker to player external audio.

Playing

- 1. Long press key ② to increase volume; Long press key ③ to decrease volume.
- 2. Short press key ② to go to next song; short press key ③ to go to previous song.
- 3. Press key ④ to switch music mode.

Charging method

In operation state, when the battery is about to run out, Bluetooth speaker will make a prompt sound every 30 seconds, watch battery is too low, at this point you insert USB cable into the PC or the standard USB power adapter, insert the charger plug into the Bluetooth stereo charger port, Bluetooth stereo started charging. The red indicator light means it is charging. The red light not bright means the battery is filled. You can disconnect the charger and the device, and then to use this product.

Indicator Light

Blue light flashes quickly: ready for pairing
Blue light flashes slowly: Bluetooth playing mode
Red light flashes: TF card playing mode

Caution

-Please read the User Manual carefully before installation and use. Please don't throw or beat the product; please put the speaker away from heat sources; please charge the speaker when it in low power and please timely pull out charging connector when the battery fully charged. Please check Bluetooth mode of the speaker and other devices if paring failed; please turn off Bluetooth while charging. Suggestion: don't use Bluetooth speaker before the battery fully charged.
