





Fig.12 EUT Bottom side to flat phantom




Fig.13 EUT Back side to flat phantom





Fig.14 EUT Front side to flat phantom




Fig.15 Front view of EUT




Fig.16 Back view of EUT




Fig.17 Antenna position of EUT (Front view / Cover closed)




Fig.18 Antenna position of EUT (Front view / Cover closed)
