Use Means:

1. Long press the bluetooth pairing key for 3 seconds
bluetooth indicator light flashes fast, it indicates that
bluetooth is in the matching state.
2. Just choose design-pie from bluetooth settings in your device.
3. Open CALRA  APP , click bluetooth icon 
control the light color.

simultaneously. If you want to match new device,
please restart, just long press the
bluetooth pairing key to pair device.
