

2. How to use

- 1) 구글 플레이에서 KEEPOP 어플리케이션을 다운로드 하여 설치합니다.
- 1) Download and install KEEPOP application from Google Play.
- 2) 스마트폰에서 블루투스를 활성화 합니다.
- 2) Activate Bluetooth on the smartphone.
- 3) KEEPOP의 NEXT버튼과 PREVIOUS 버튼을 LED가 점멸할때까지 2초간 동시에 누릅니다.
- 3) Press NEXT button and PREVIOUS button together for 2 seconds until the LED flashes.
- 4) 스마트폰에서 KEEPOP 앱을 실행한 후 장치 버튼을 눌러 KEEPOP 제품을 검색합니다.
- 4) Play KEEPOP app and press the device button on smartphone, then search KEEPOP device.
- 5) 앱에서 KEEPOP이 검색되면 KEEPOP을 누르고 연결을 진행합니다.
- 5) Click KEEPOP and connection when searching in the KEEPOP app.
