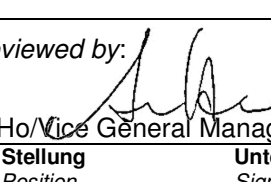

## 4. Test Set-up and Operation Modes

### 4.1 Principle of Configuration Selection

The equipment under test (EUT) was configured to measure its maximum power level. The test modes were adapted accordingly in reference to the instructions for use.

### 4.2 Test Operation and Test Software

Test samples provided by manufacturer can be controlled through Bluetooth test set. All testing were performed according to the procedures in ANSI C63.10: 2013

Full test was applied on all test modes, but only worst case was shown.

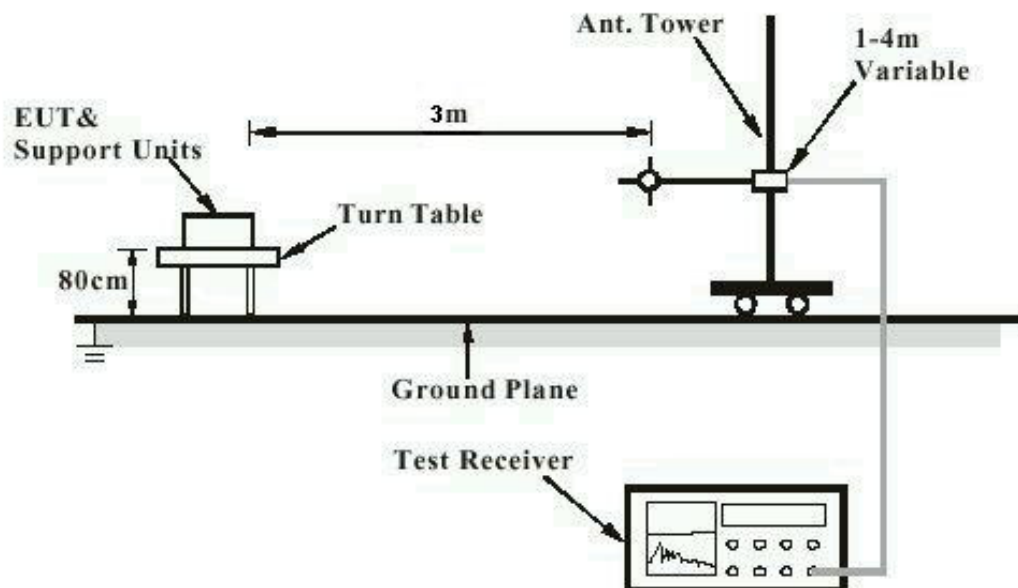

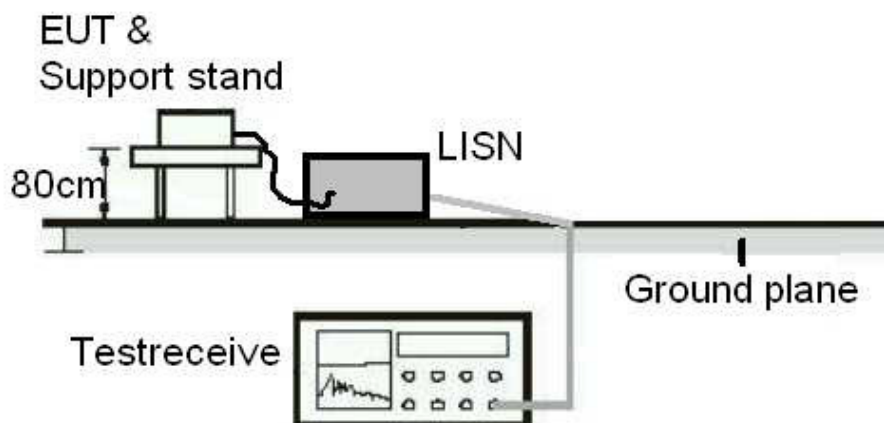

Diagram of Measurement Configuration for Radiation Test

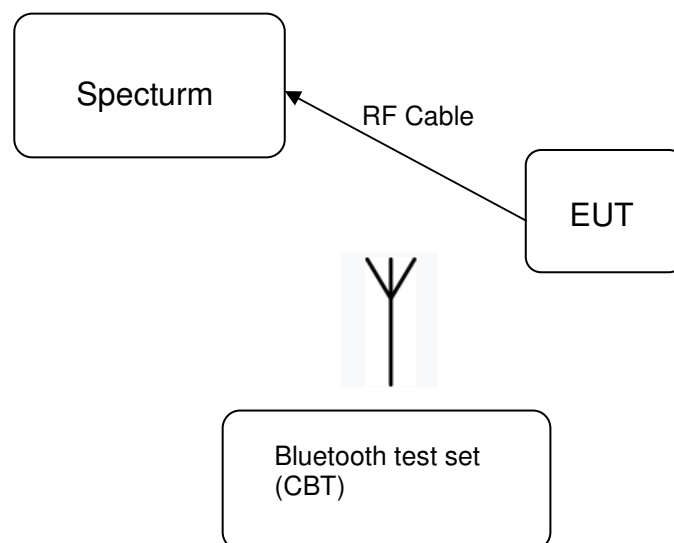


Note: Measurements above 1 GHz are done with a table height of 1.5m

## Test Plot of 100kHz Conducted Emissions, GFSK modulation

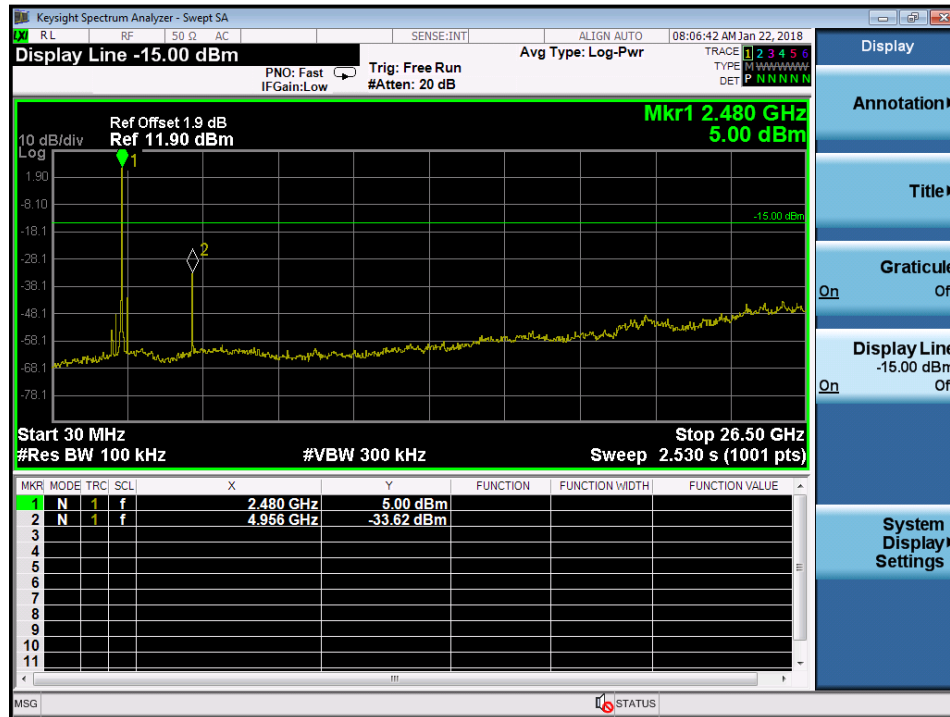

## Test Plot of 100kHz Conducted Emissions, 8DPSK modulation

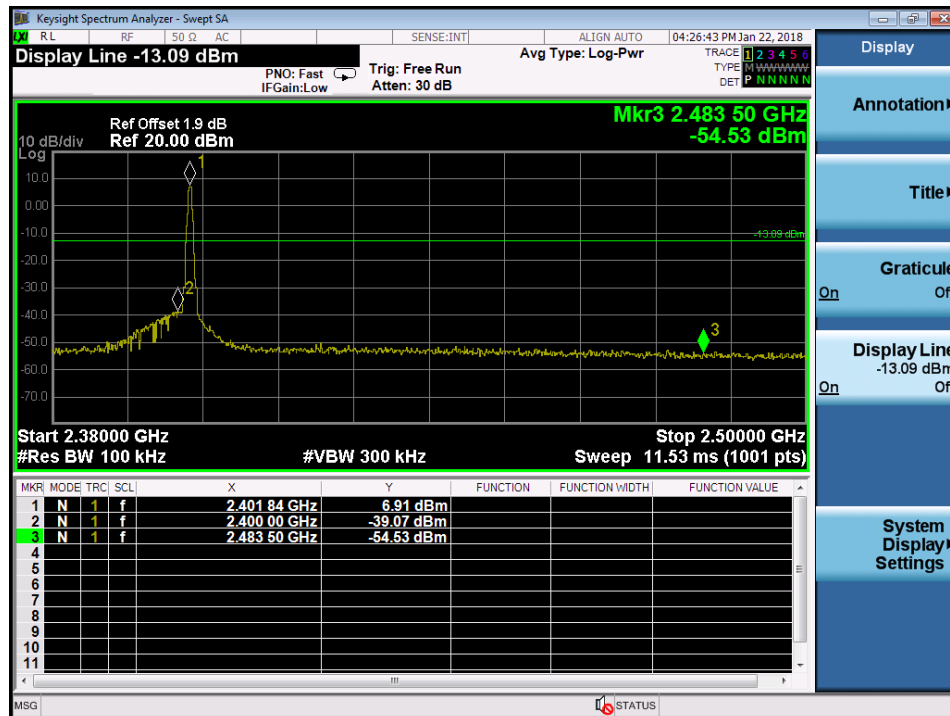

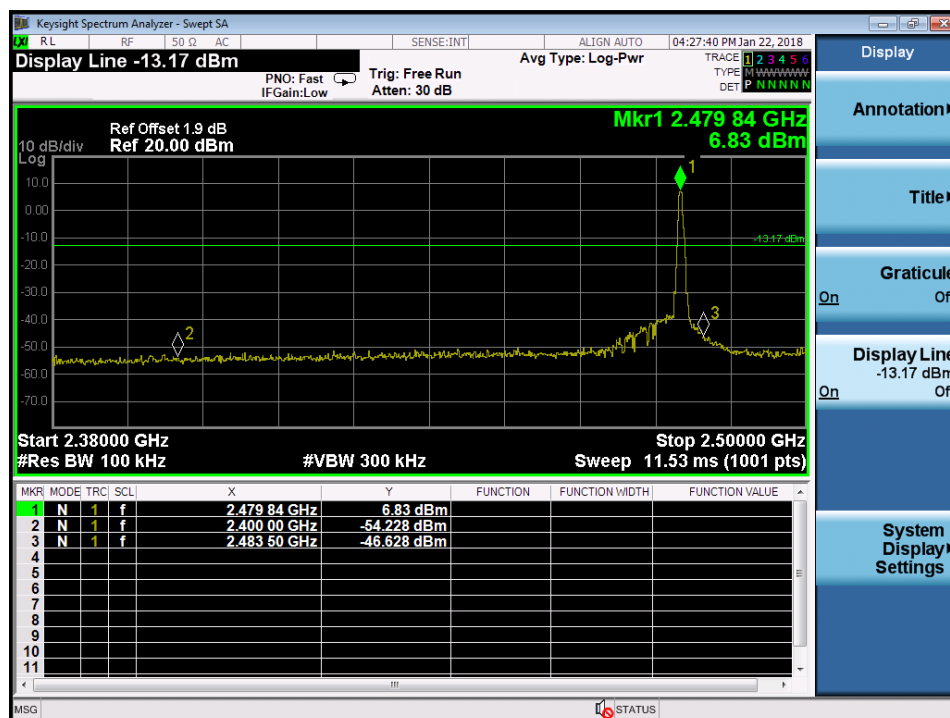

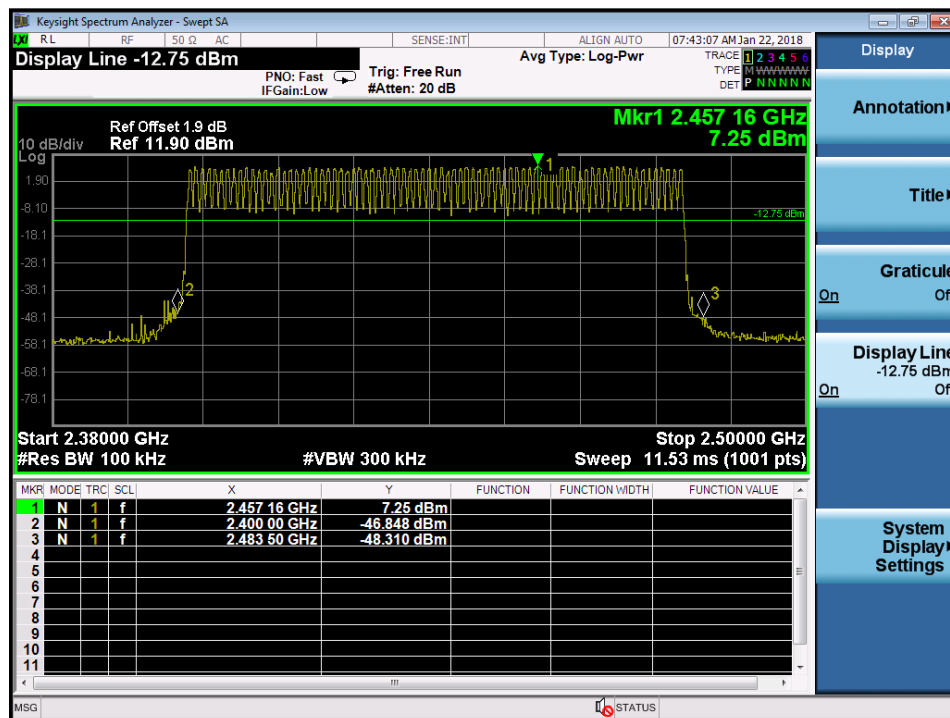
## Test Plot of 100kHz Bandwidth of Frequency Band Edge, GFSK modulation

## Test Plot of Time of Occupancy, GFSK modulation ON

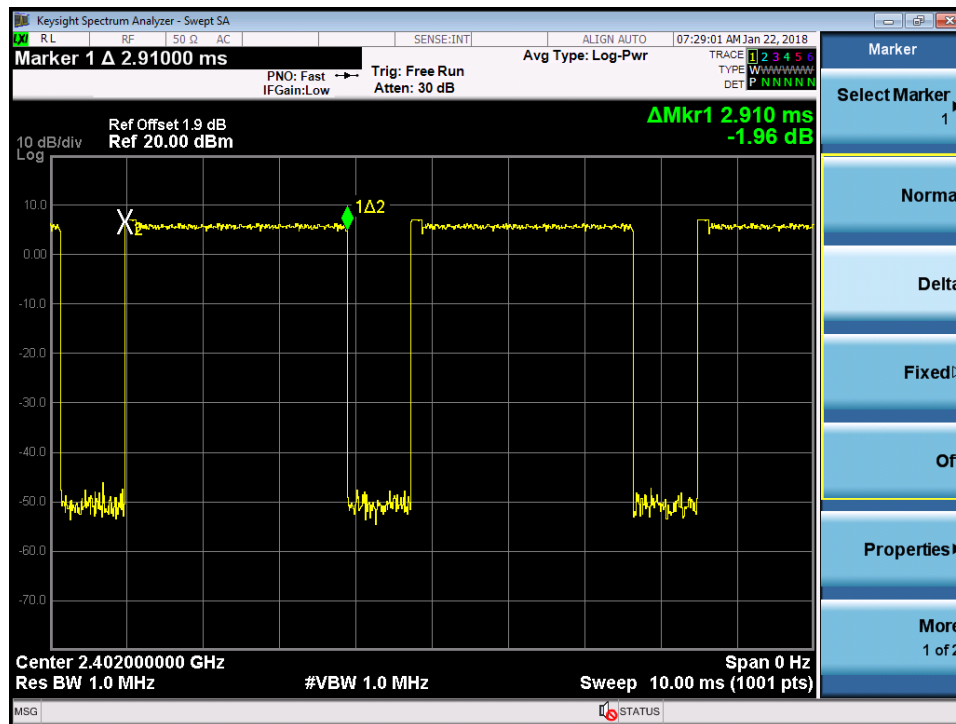

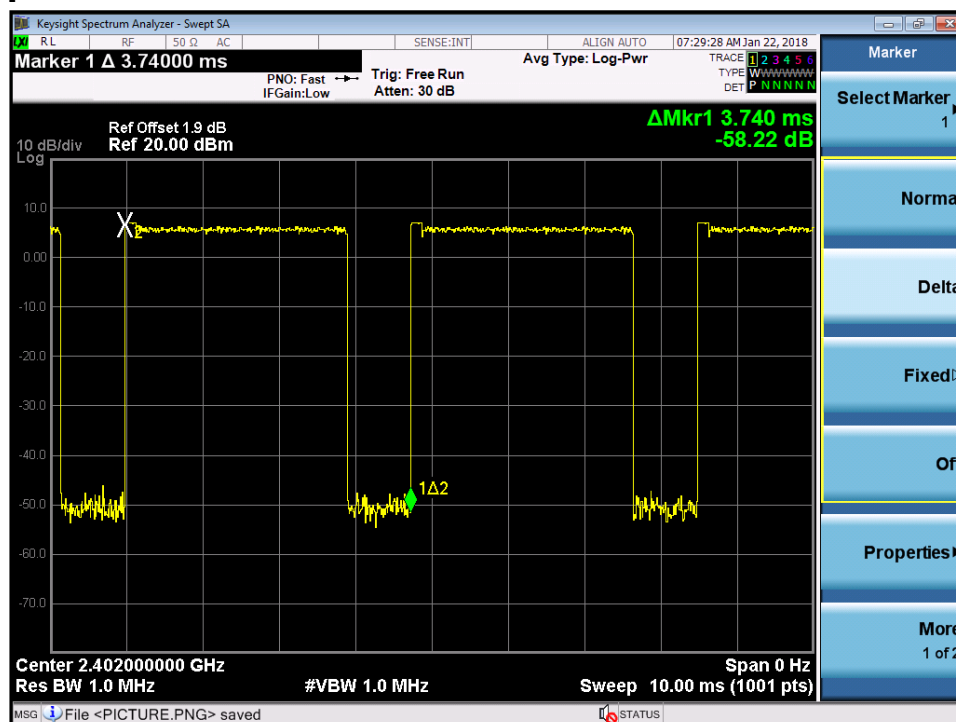




## Test Plot of Time of Occupancy, 8DPSK modulation ON

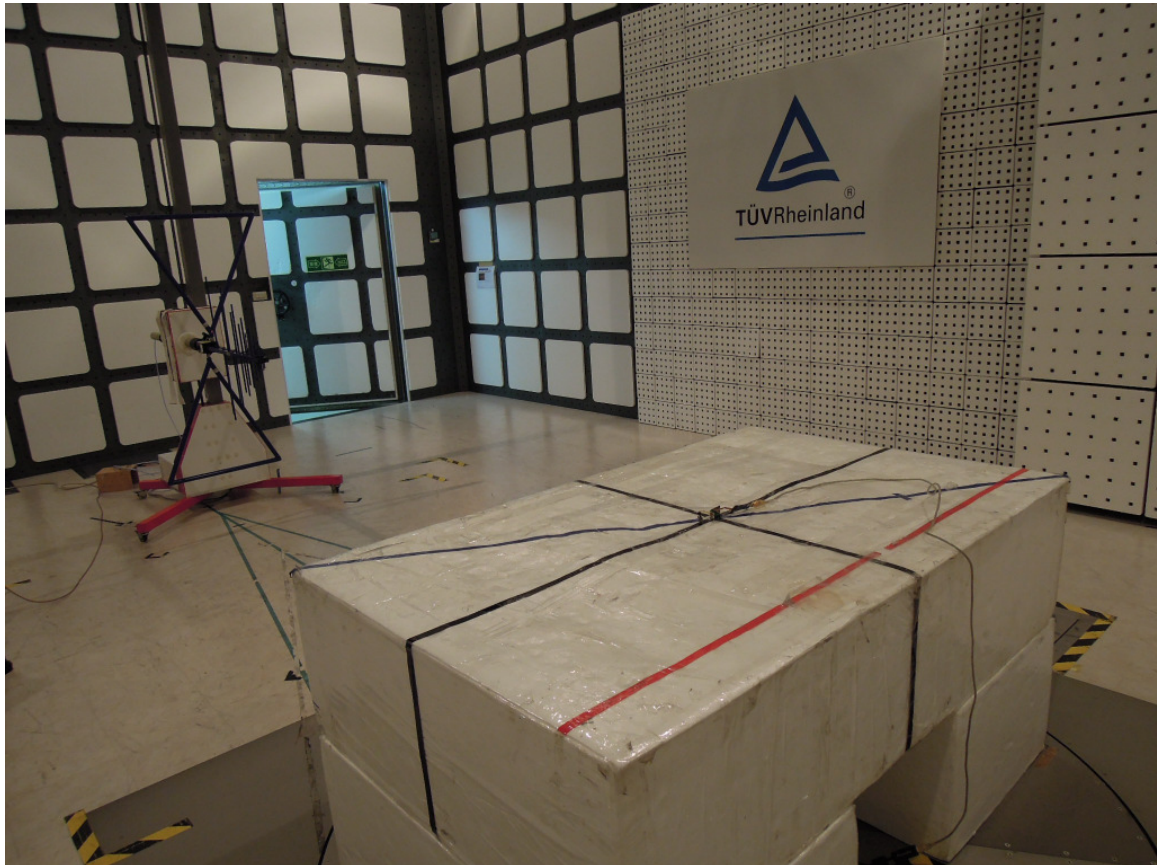

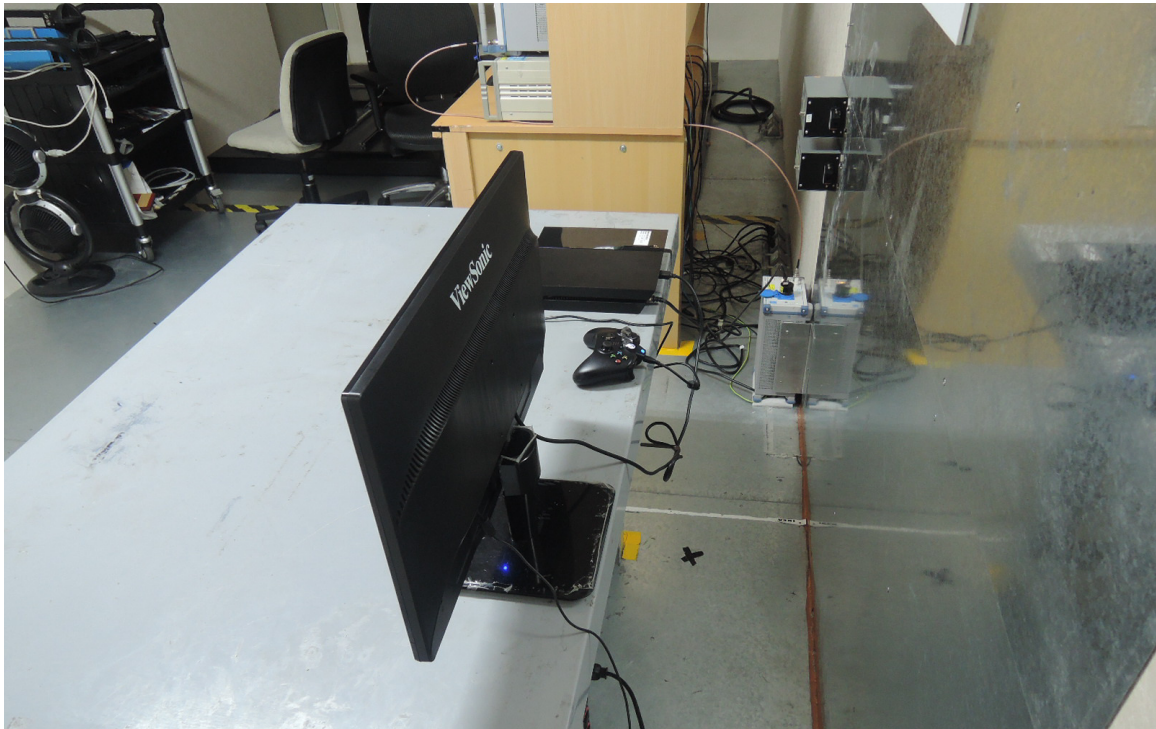
