
2.1. Transmitter Conducted Output Power and E.R.P./E.I.R.P.

2.1.1. Requirement

According to FCC section 2.1046(a), for transmitters other than single sideband, independent sideband and controlled carrier radiotelephone, power output shall be measured at the RF output terminals when the transmitter is adjusted in accordance with the tune-up procedure to give the values of current and voltage on the circuit elements specified in FCC section 2.1033(c)(8).

According to FCC section 90.635(b) for LTE Band 26, the maximum output power of the transmitter for mobile stations is 100 watts.

2.1.2. Test Description



The EUT is coupled to the Spectrum Analyzer (SA) and the System Simulator (SS) with Attenuators through the Power Splitter; the RF load attached to the EUT antenna terminal is 50Ohm; the path loss as the factor is calibrated to correct the reading. 

2.2. Occupied Bandwidth

2.2.1. Requirement

According to FCC section 2.1049, the occupied bandwidth is the frequency bandwidth such that, below its lower and above its upper frequency limits, the mean powers radiated are each equal to 0.5 percent of the total mean power radiated by a given emission. Occupied bandwidth is also known as the 99% emission bandwidth.

2.3. Frequency Stability


2.3.1. Requirement

According to FCC section 2.1055 & 90.213, the frequency stability shall be sufficient to ensure that the fundamental emission stays within the authorized frequency block. According to FCC section 2.1055, the test conditions are:

- (a) The temperature is varied from -30°C to +50°C at intervals of not more than 10°C.
- (b) For hand carried battery powered equipment, the primary supply voltage is reduced to the battery operating end point which shall be specified by the manufacture. The supply voltage shall be measured at the input to the cable normally provided with the equipment, or at the power supply terminals if cables are not normally provided.

Note: The operating temperature of EUT is from 0°C to 45°C, which are specified by the applicant.

2.3.2. Test Description



The EUT which is powered by the DC Power Supply directly, is located in the Temperature Chamber. The EUT is commanded by the System Simulator (SS) to operate at the maximum output power. A call is established between the EUT and the SS via a Common Antenna.



2.4. Conducted Spurious Emissions

2.4.1. Requirement

According to FCC section 2.1051, the power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least $43+10*\log(P)$ dB. This calculated to be -13dBm.


B26 Part90 / 3MHz / Low CH / QPSK / FULL RB






2.6. Radiated Spurious Emissions

2.6.1. Requirement

According to FCC section 2.1051, the power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least $43+10*\log(P)$ dB. This calculated to be -13dBm.

2.6.2. Test Description





(For the test frequency above 1GHz)

The EUT is located in a 3m Full-Anechoic Chamber, the cable loss, air loss and so on of the site as factors are pre-calibrated using the "Substitution" method, and calculated to correct the reading. A call is established between the EUT and the SS via a Common Antenna. The EUT is commanded by the SS to operate at the maximum and minimum output power, and only the test result of the maximum output power was recorded.

In the frequency range above 30MHz, Bi-Log Test Antenna (30MHz to 1GHz) and Horn Test Antenna (above 1GHz) are used. Test Antenna is 3m away from the EUT. Test Antenna height is varied from 1m to 4m above the ground and the Turn Table is actuated to turn from 0° to 360° to determine the maximum value of the radiated power. The emission levels at both horizontal and vertical polarizations should be tested. The Filters consists of Notch Filters and High Pass Filter.

Note: when doing measurements above 1GHz, the EUT has been within the 3dB cone width of the horn antenna during horizontal antenna.

2.6.3. Test procedure

KDB 971168 D01v03 Section 5.8 and ANSI/TIA-603-E-2016.

For measurements below 1 GHz the resolution bandwidth is set to 100 kHz for peak detection measurements.

For measurements above 1GHz the resolution bandwidth is set to 1MHz, the video band width is set to 3MHz for peak measurements.



2.6.4. Test Result

The measurement frequency range is from 30MHz to the 10th harmonic of the fundamental frequency. The Turn Table is actuated to turn from 0° to 360°, and both horizontal and vertical polarizations of the Test Antenna are used to find the maximum radiated power. The lowest, middle and highest channels are tested to verify the out of band emissions.

The substitution corrections are obtained as described below:

$$A_{\text{SUBST}} = P_{\text{SUBST_TX}} - P_{\text{SUBST_RX}} - L_{\text{SUBST_CABLES}} + G_{\text{SUBST_TX_ANT}}$$

$$A_{\text{TOT}} = L_{\text{CABLES}} + A_{\text{SUBST}}$$

Where A_{SUBST} is the final substitution correction including receive antenna gain.

$P_{\text{SUBST_TX}}$ is signal generator level,

$P_{\text{SUBST_RX}}$ is receiver level,

$L_{\text{SUBST_CABLES}}$ is cable losses including TX cable,

$G_{\text{SUBST_TX_ANT}}$ is substitution antenna gain.

A_{TOT} is total correction factor including cable loss and substitution correction

During the test, the data of A_{TOT} was added in the test spectrum analyze, so spectrum analyze reading is the final values which contain the data of A_{TOT} .

Note1: The power of the EUT transmitting frequency should be ignored.


Note2: All Spurious Emission tests were performed in X, Y, Z axis direction. And only the worst axis test condition was recorded in this test report.

Note3: All bandwidth and modulation were considered and evaluated respectively by performing full test for each band, only the worst cases (Max Bandwidth and QPSK mode) were recorded in this test report.



LTE Band 26, 5MHz BW, Low Channel, QPSK






