BLE_2M_Ant1_2402_1000~26500



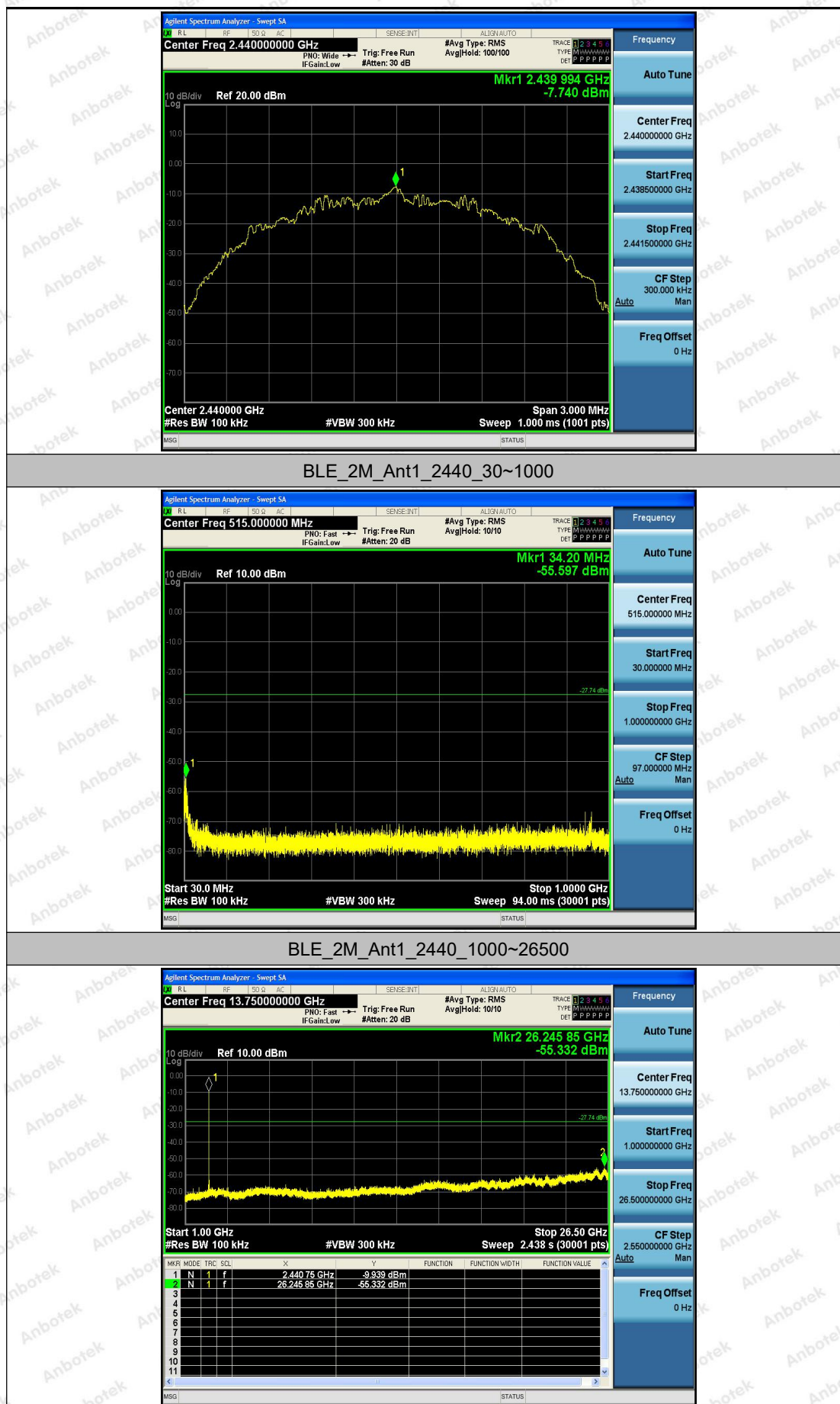

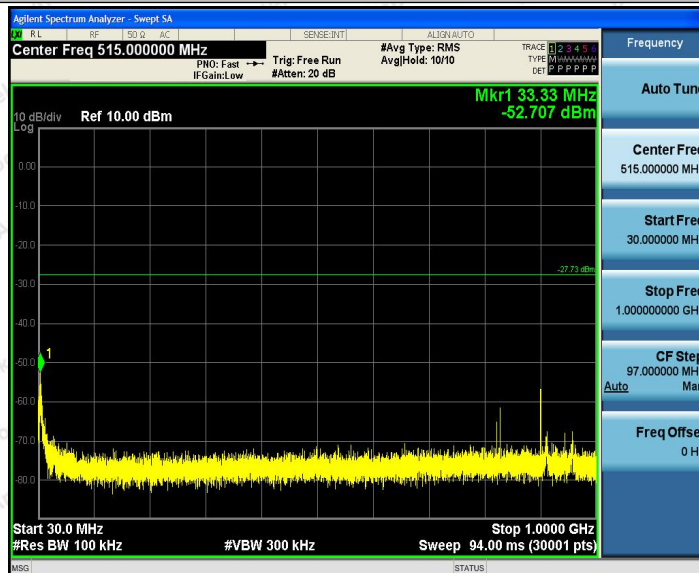

BLE_2M_Ant1_2480_30~1000



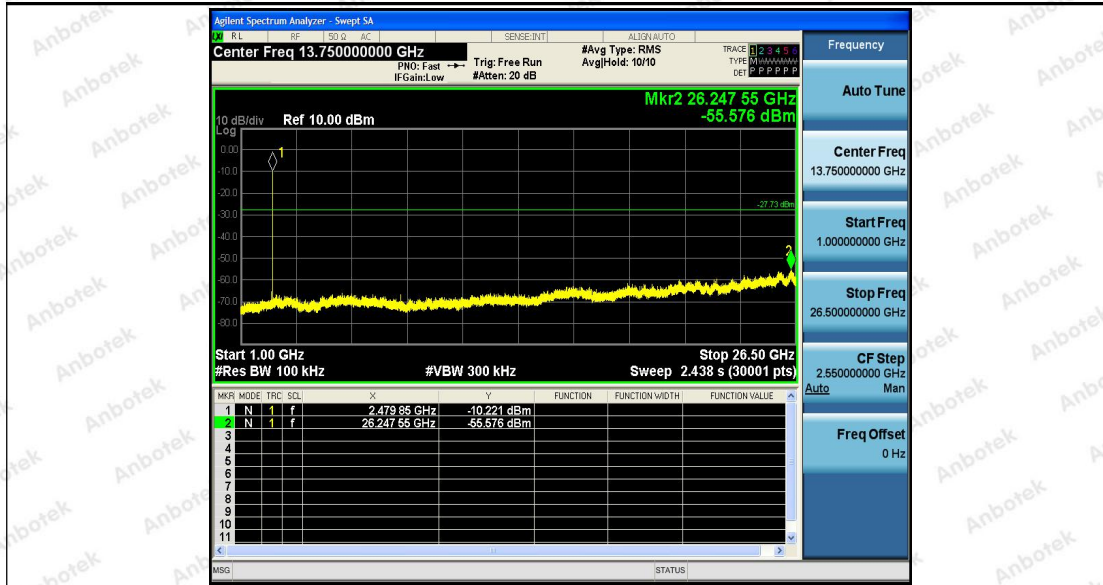
