2. System Test Configuration

2.1 EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

2.2 EUT Exercise

The Transmitter was operated in the normal operating mode. the Tx frequency was fixed which was for the purpose of the measurements.

2.3 Test Procedure

2.3.1 Conducted Emissions

The EUT is placed on a turn table which is 0.8 m above ground plane. According to the requirements in Section 13.1.4.1 of ANSI C63.10-2013. Conducted emissions from the EUT measured in the **frequency range between 0.15 MHz and 30MHz** using **CISPR Quasi-Peak and average detector mode**.

2.3.2 Radiated Emissions

The EUT is placed on a turn table which is 0.8 m above ground plane. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this hand-held transmitter(EUT) was rotated through three orthogonal axes according to the requirements in Section 13.1.4.1 of ANSI C63.10-2013

2.4 Limitation

(1) Conducted Emission

According to section 15.207(a) Conducted Emission Limits is as following.

(2) Radiated Emission

- a. The field strength of any emission within this band (section 15.235 frequency between 49.82MHz -49.90MHz) shall not exceed 10000 micro volts/meter at 3 meters. (80dB μ V at 3m) The emission limit in this paragraph is based on measurement instrumentation employing an average detector. The provisions in section 15.35 for limiting peak emissions apply.
- b. The field strength of any emissions which appear outside of this band shall not exceed the general radiated emission limits in section 15.209(Intentional Radiators general limit).as below.

Fig. 2-1 Configuration of Tested System

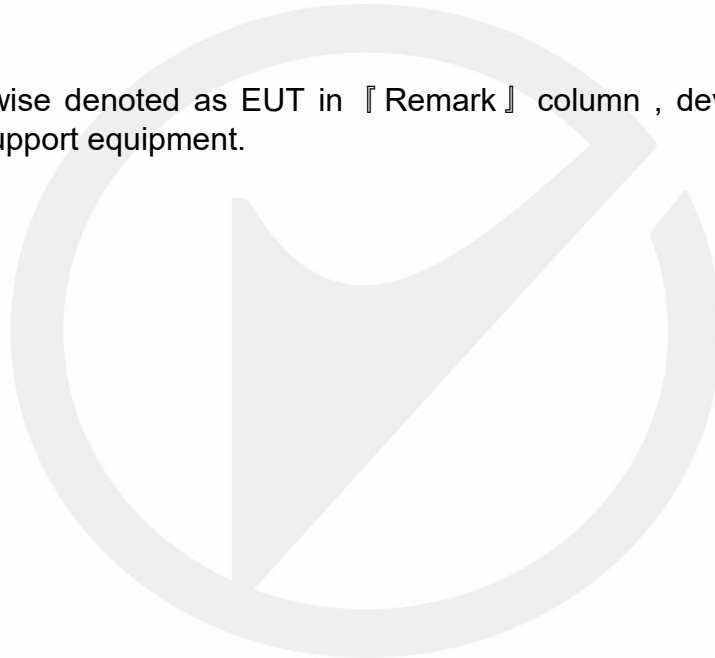

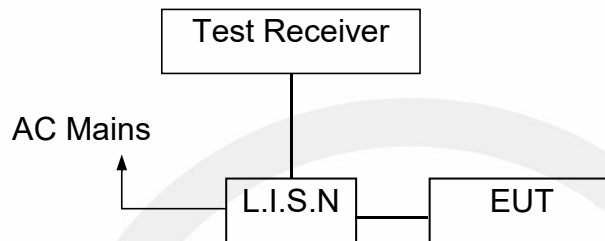

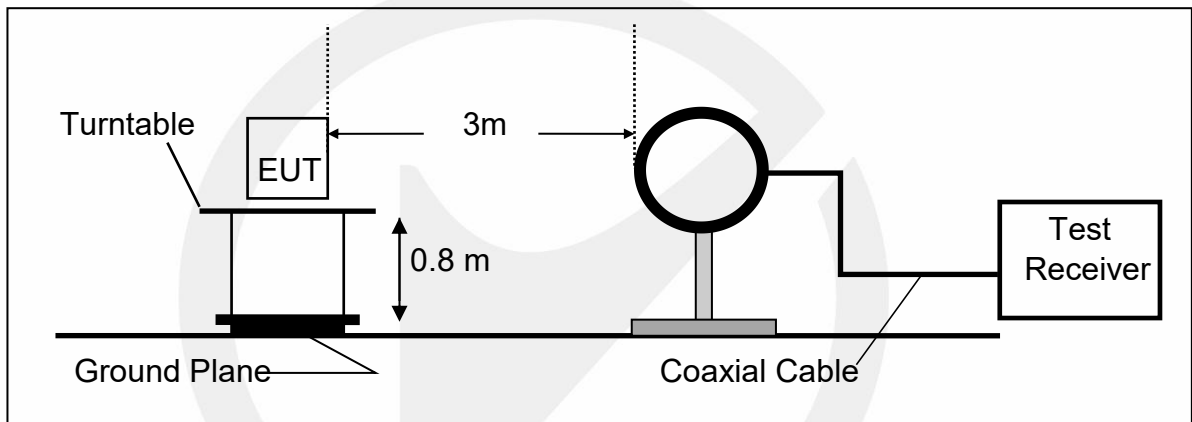

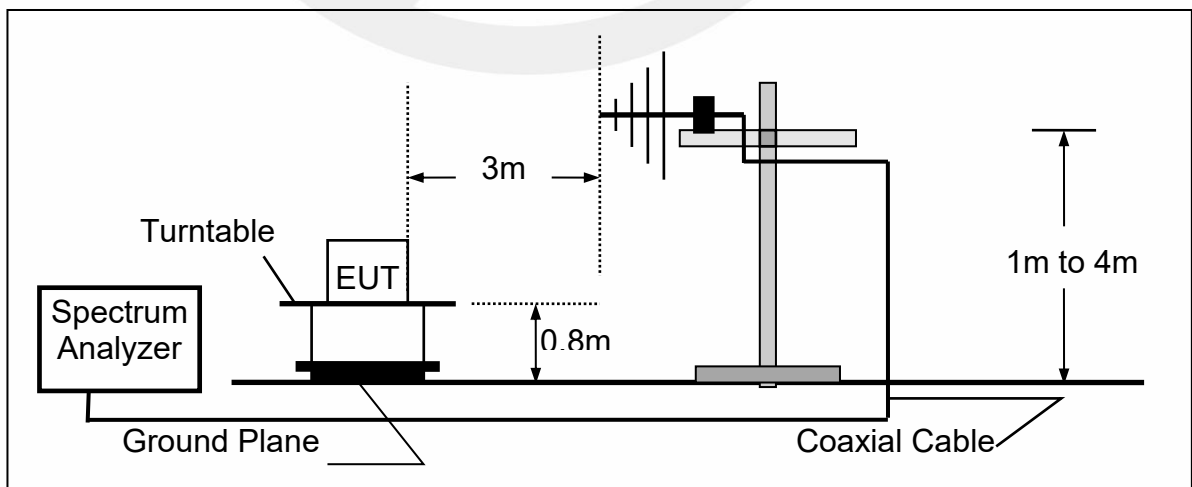
1. The EUT was placed on a turntable which is 0.8m above ground plane.

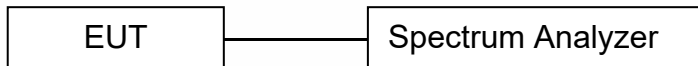

10. Antenna Application

10.1 Antenna requirement

The EUT'S antenna is met the requirement of FCC part 15C section 15.203.

Systems operating in the 49.86MHz that are used exclusively for fixed, point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi provided the maximum peak output power of the intentional radiator is reduced by 1dB for every 3dB that the directional gain of the antenna exceeds 6dBi.

10.2 Result

The EUT's antenna is permanent attached antenna, external antenna. The antenna is not replaceable or user serviceable. The requirement of FCC part 15C section 15.203 is met.
