TROUBLESHOOTING

To connect Fable to the ViziaMe Store, share Projects and Photos and update software:

Select **SETTINGS** and confirm there is a successful WiFi connection.

In the event that the tablet fails to function:

Hold the **POWER** button down until the screen shuts off.

Wait 10 seconds and **POWER ON** the device.

If the problem persists it may be necessary to RESTORE the tablet to the original factory settings:

Select the **SETTINGS** icon on the carousel menu.

Select **ABOUT FABLE** from the menu bar.

Select the **RESTORE** button. This will reset the tablet back to factory settings AND erase all data downloaded and stored on the device. You will need to reload content from your account on ViziaMe.com.

- Periodically check the device for proper and safe conditions. Note, if any damage, or broken parts exist, remove the tablet from use
- If the screen display is fractured or cracked, immediately stop using the product and contact an authorized service provider or repair center
