1) Measurement System Information

1.1 General Information

ETS-Lindgren's AMS-8813 Antenna Measurement System is a distributed axis positioning system consisting of an azimuth rotator for rotating the DUT about the phi axis. A separate Theta Arm Positioning System elevates the measurement antenna around the DUT. The measurement antenna allows testing in both polarizations. The system antenna support testing between 400 MHz and 10 GHz.

An integrated laser alignment system assists with DUT positioning. The arm moves in an arc over a low dielectric foam column that supports the DUT. This scanning system provides a quick, convenient, and accurate test method for wireless devices.. The system configuration supports easy maintenance and superior reliability.

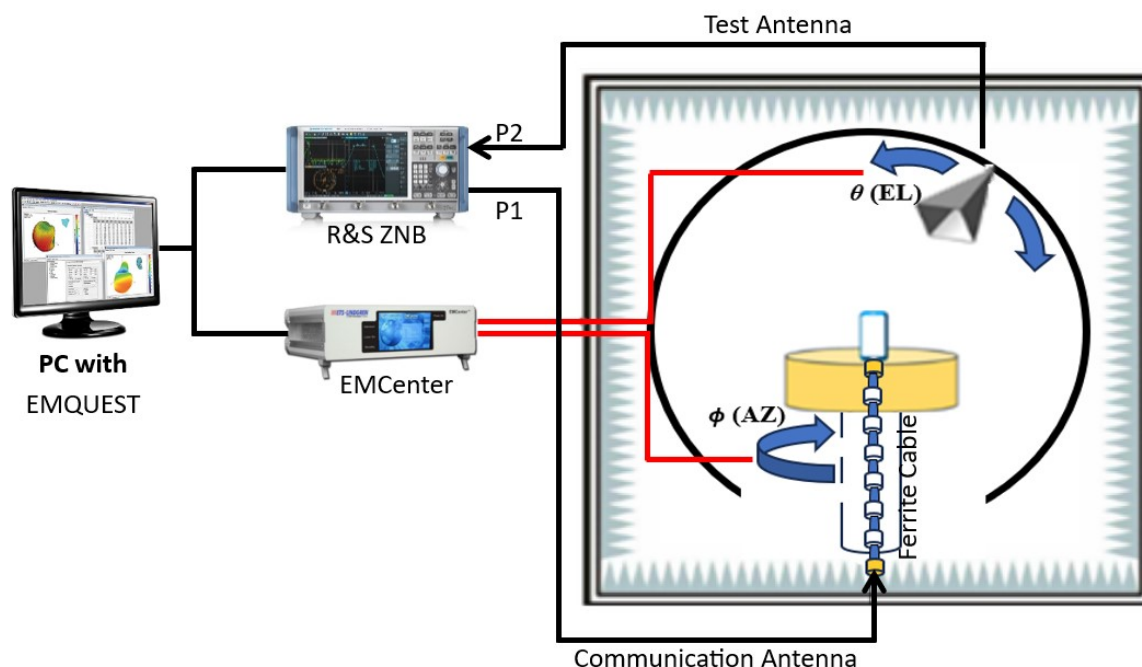
