1.1 Related Submittal(s) / Grant (s)

2 SYSTEM TEST CONFIGURATION

2.1 EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

2.2 EUT Exercise

The EUT (Transmitter) was operated in the engineering mode to fix the Tx frequency that was for the purpose of the measurements.

2.3 Test Procedure

2.3.1 Conducted Emissions

The EUT is placed on a turn table which is 0.8 m above ground plane. According to the requirements in Section 6 of C63.10: 2013, conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30 MHz using CISPR 16-1-1 Quasi-Peak and Average detector mode.

2.3.2 Radiated Emissions

The EUT is placed on a turn table which is 0.8/1.5 m above ground plane. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this hand-held transmitter (EUT) was rotated through three orthogonal axes and measurement procedures for electric field radiated emissions above 1 GHz the EUT measurement is to be made “while keeping the antenna in the ‘cone of radiation’ from that area and pointed at the area both in azimuth and elevation, with polarization oriented for maximum response.” Is still within the 3dB illumination BW of the measurement antenna. According to the requirements in Section 8 and 13 and Subclause 8.3.1.2 of ANSI C63.10: 2013.

Fig. 1 Configuration of Tested System (Fixed channel)

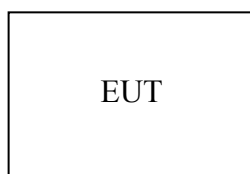

4 DESCRIPTION OF TEST MODES

The EUT has been tested under engineering operating condition.

Test program used to control the EUT for staying in continuous transmitting mode is programmed.

BT mode: Channel low (2402MHz), mid (2442MHz) and high (2480MHz) are chosen for full testing.

5.3 EUT Setup:

1. The conducted emission tests were performed in the test site, using the setup in accordance with the ANSI C63.4-2014.
2. The EUT was plug-in LISN. The EUT was placed flushed with the rear of the table.
3. The LISN was connected with 120Vac/60Hz power source.

5.4 Measurement Procedure:

1. The EUT was placed on a table which is 0.8m above ground plane.
2. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
3. Repeat above procedures until all frequency measured were complete.

6 PEAK OUTPUT POWER MEASUREMENT

6.1 Standard Applicable:

According to §15.247(b)(3),(4)(b)

(3) For systems using digital modulation in the 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power. Maximum Conducted Output Power is defined as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. Power must be summed across all antennas and antenna elements. The average must not include any time intervals during which the transmitter is off or is transmitting at a reduced power level. If multiple modes of operation are possible (e.g., alternative modulation methods), the maximum conducted output power is the highest total transmit power occurring in any mode.

(4) The conducted output power limit specified in paragraph (b) of this section is based on the use of antennas with directional gains that do not exceed 6 dBi. Except as shown in paragraph (c) of this section, if transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1), (b)(2), and (b)(3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

(c) Operation with directional antenna gains greater than 6 dBi.

(1) Fixed point-to-point operation:

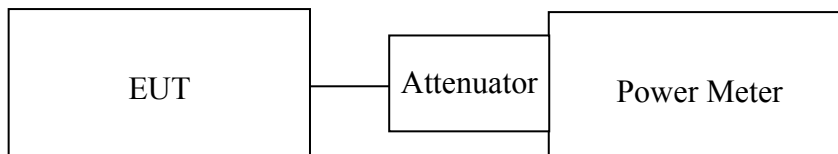
(i) Systems operating in the 2400-2483.5 MHz band that are used exclusively for fixed, point-to-point operations may employ transmitting antennas with directional gain greater than 6 dBi provided the maximum conducted output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6 dBi.

(ii) Systems operating in the 5725-5850 MHz band that are used exclusively for fixed, point-to-point operations may employ transmitting antennas with directional gain greater than 6 dBi without any corresponding reduction in transmitter conducted output power.

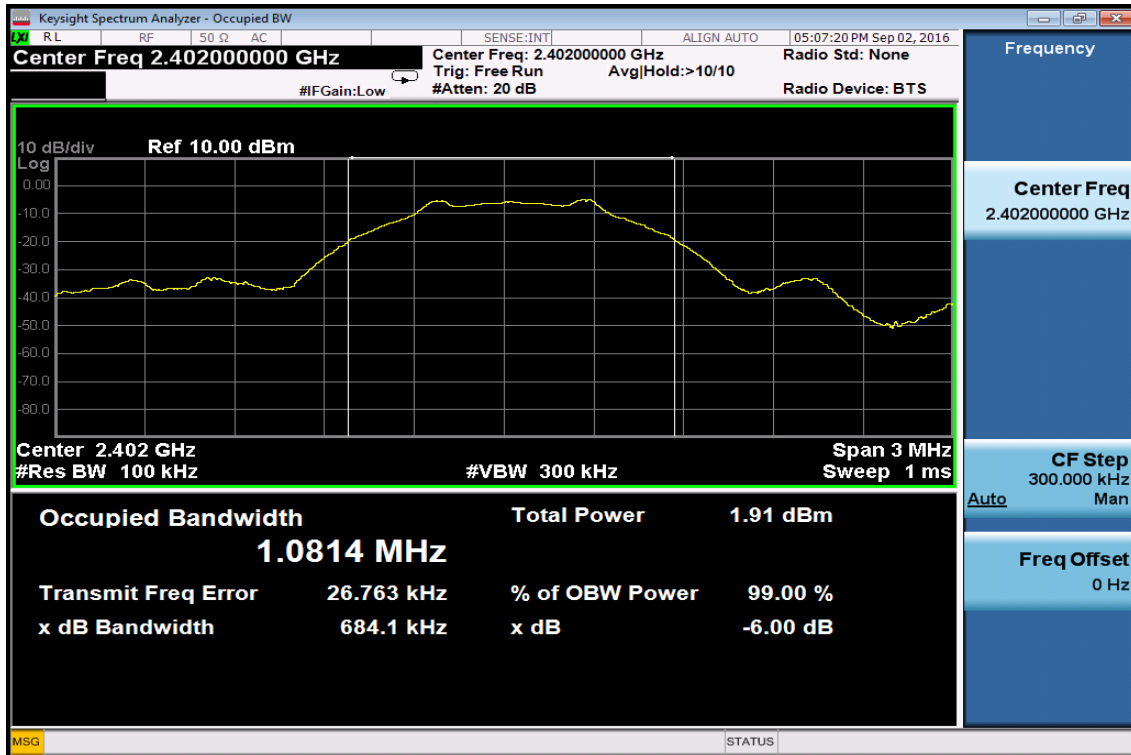
1. Set resolution bandwidth (RBW) = 100KHz.
2. Set the video bandwidth (VBW) = 300KHz.
3. Detector = Peak.
4. Trace mode = max hold.
5. Sweep = auto couple.
6. Allow the trace to stabilize.
7. Measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission. Compare the resultant bandwidth with the RBW setting of the analyzer. Readjust RBW and repeat measurement as needed until the RBW/EBW ratio is 1-5 %.

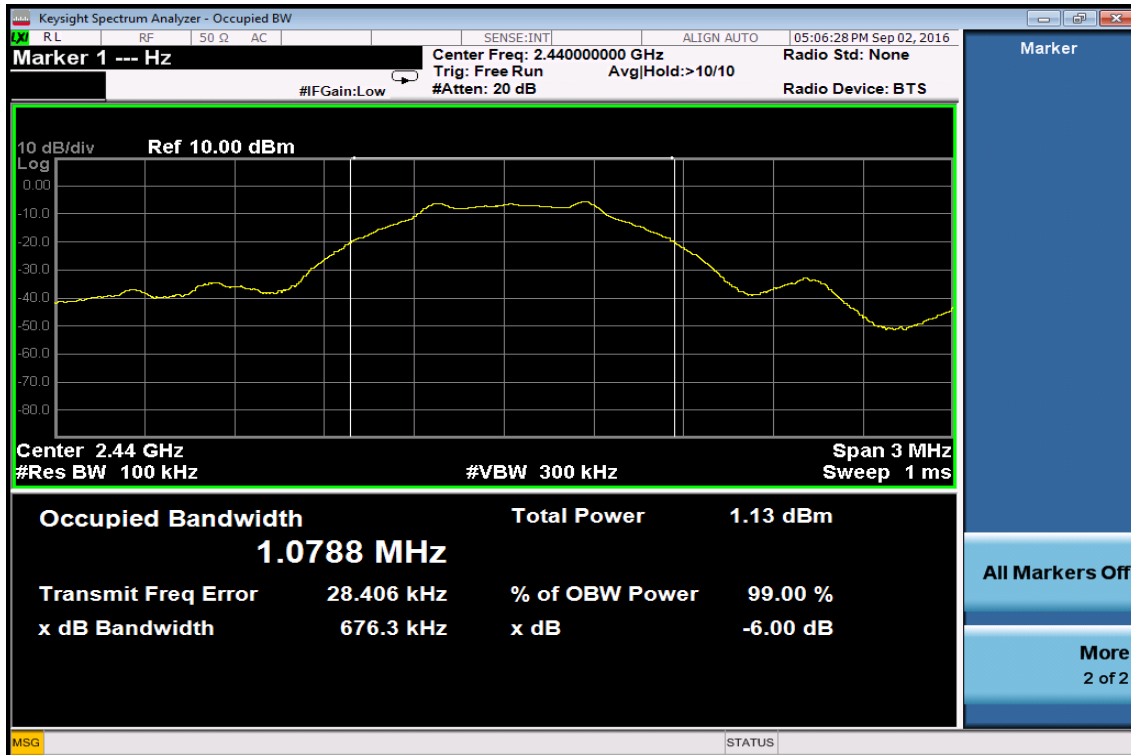

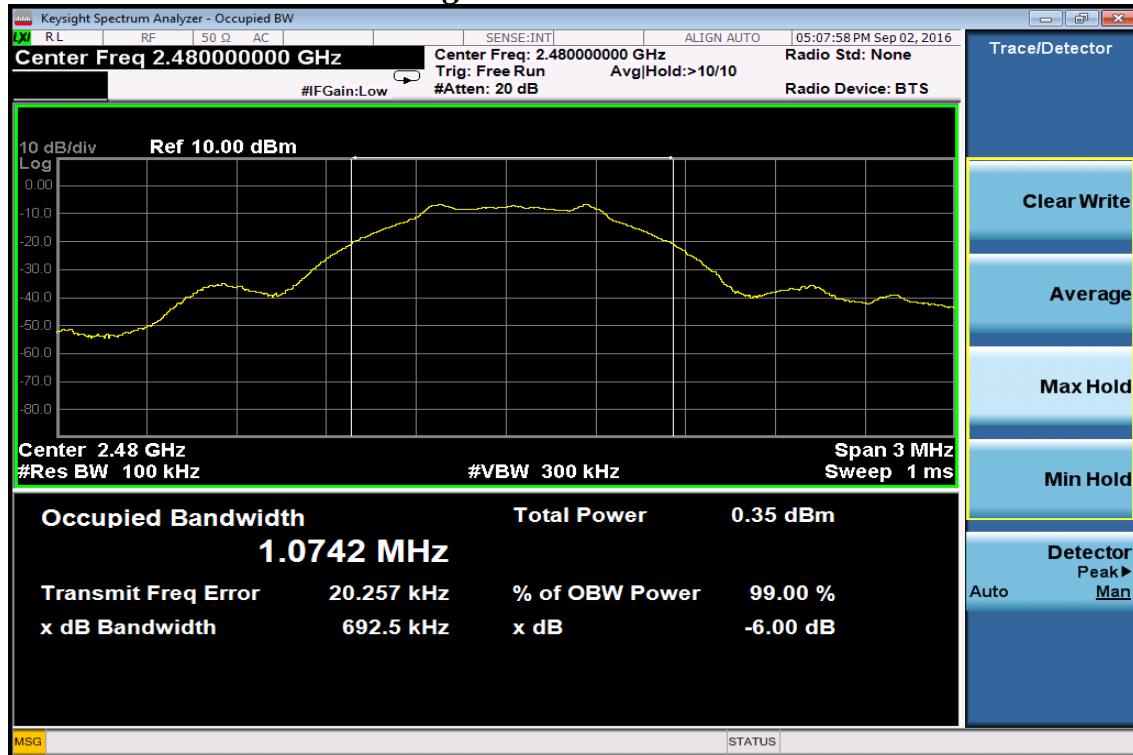
6dB Bandwidth Test Data CH-Low

8 100KHz BANDWIDTH OF BAND EDGES MEASUREMENT

8.1 Standard Applicable:

According to §15.247(c), in any 100 KHz bandwidth outside the frequency bands in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100KHz bandwidth within the band that contains the highest level of the desired power, In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a).

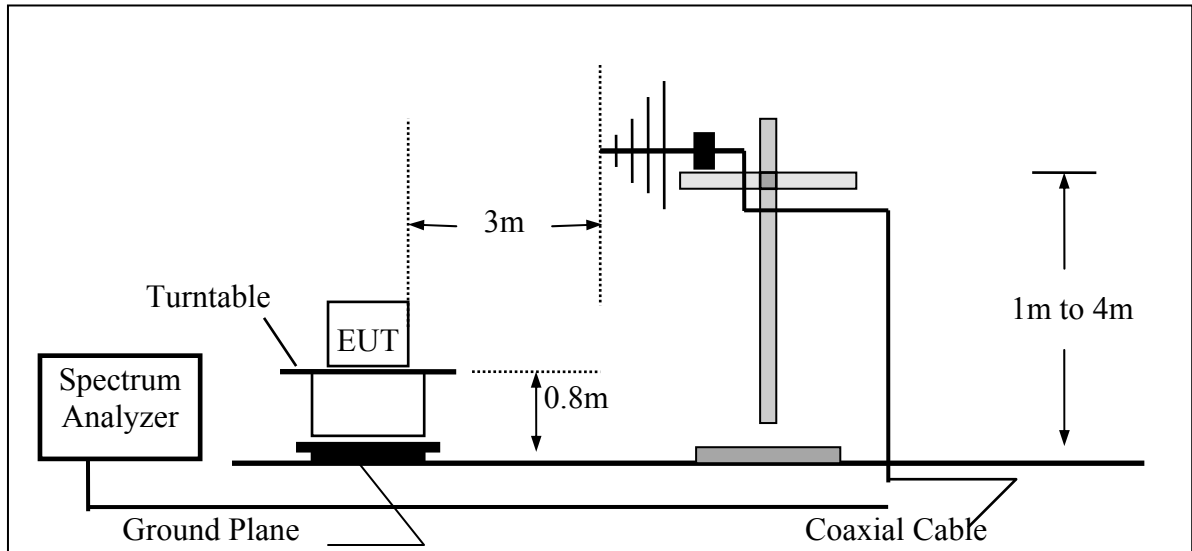

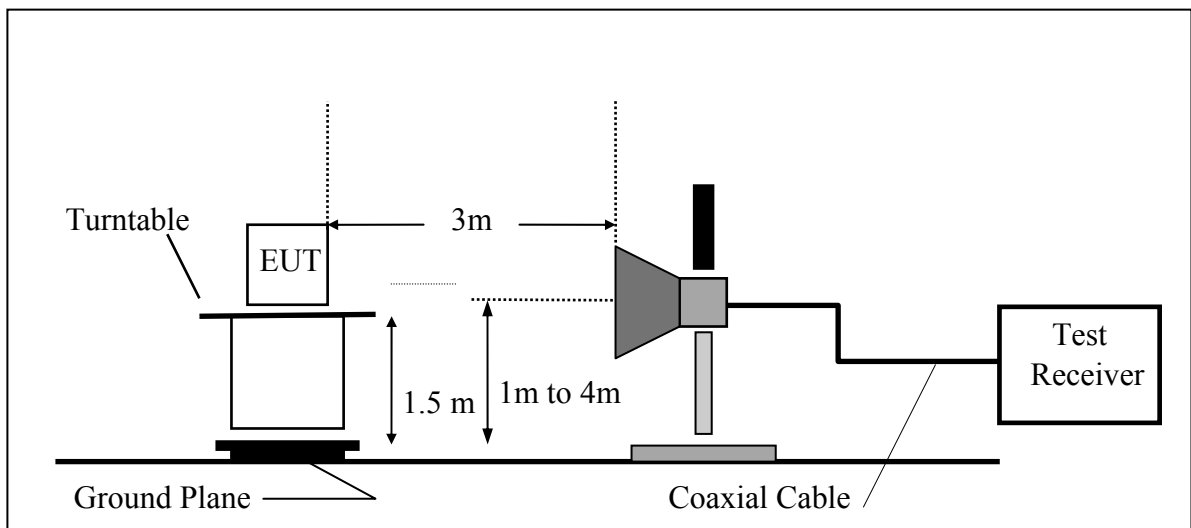

8.4 Measurement Procedure:

1. Place the EUT on the table and set it in transmitting mode.
2. Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the spectrum analyzer.
3. Set center frequency of spectrum analyzer = operating frequency.
4. Set the spectrum analyzer as RBW, VBW=100KHz, Span=25MHz, Sweep = auto
5. Mark Peak, 2.390GHz and 2.4835GHz and record the max. level.
6. Repeat above procedures until all frequency measured were complete.

The measurement of unwanted emissions at the edge of the authorized frequency bands can be complicated by the leakage of RF energy from the fundamental emission into the RBW pass band. Thus, for measurements at the band edges, a narrower resolution bandwidth (no less than 10 kHz) can be used within the first 1 MHz beyond the fundamental emission, provided that that measured energy is subsequently integrated over the appropriate reference bandwidth (i.e., 100 kHz or 1 MHz). This integration can be performed using the band power function of the spectrum analyzer or by summing the spectral levels (in linear power units) over the appropriate reference bandwidth.

8.5 Field Strength Calculation:

The field strength is calculated by adding the Antenna Factor and Cable Factor and subtracting the Amplifier Gain and EUTy Cycle Correction Factor(if any) from the measured reading. The basic equation with a sample calculation is as follows:

$$FS = RA + AF + CL - AG$$

According to §15.247(c), all other emissions outside these bands shall not exceed the general radiated emission limits specified in §15.209(a). And according to §15.33(a)(1), for an intentional radiator operates below 10GHz, the frequency range of measurements: to the tenth harmonic of the highest fundamental frequency or to 40GHz, whichever is lower.

9.4 Measurement Procedure:

1. The EUT was placed on a turn table which is 0.8m above ground plane.
2. The turn table shall rotate 360 degrees to determine the position of maximum emission level.
3. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emissions.
4. When measurement procedures for electric field radiated emissions above 1 GHz the EUT measurement is to be made “while keeping the antenna in the ‘cone of radiation’ from that area and pointed at the area both in azimuth and elevation, with polarization oriented for maximum response.” is still within the 3dB illumination BW of the measurement antenna.
5. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
6. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
7. Repeat above procedures until all frequency measured were complete.

9.5 Field Strength Calculation

10 Peak Power Spectral Density

10.1 Standard Applicable:

According to §15.247(e) For digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission. This power spectral density shall be determined in accordance with the provisions of paragraph (b) of this section. The same method of determining the conducted output power shall be used to determine the power spectral density.

- 1 Use this procedure when the maximum peak conducted output power in the fundamental emission is used to demonstrate compliance.
- 2 Set the RBW = 3 kHz.
- 3 Set the VBW \geq 10 kHz.
- 4 Set the span to 5-30 % greater than the EBW.
- 5 Detector = peak.
- 6 Sweep time = auto couple.
- 7 Trace mode = max hold.
- 8 Allow trace to fully stabilize.
- 9 Use the peak marker function to determine the maximum power level in any 100 kHz band segment within the fundamental EBW.
- 10 Scale the observed power level to an equivalent value in 3 kHz by adjusting (reducing) the measured power by a bandwidth correction factor (BWCF) where $BWCF = 10\log(3 \text{ kHz}/100\text{kHz}) = -15.2 \text{ dB}$.
- 11 The resulting peak PSD level must be $\leq 8 \text{ dBm}$.

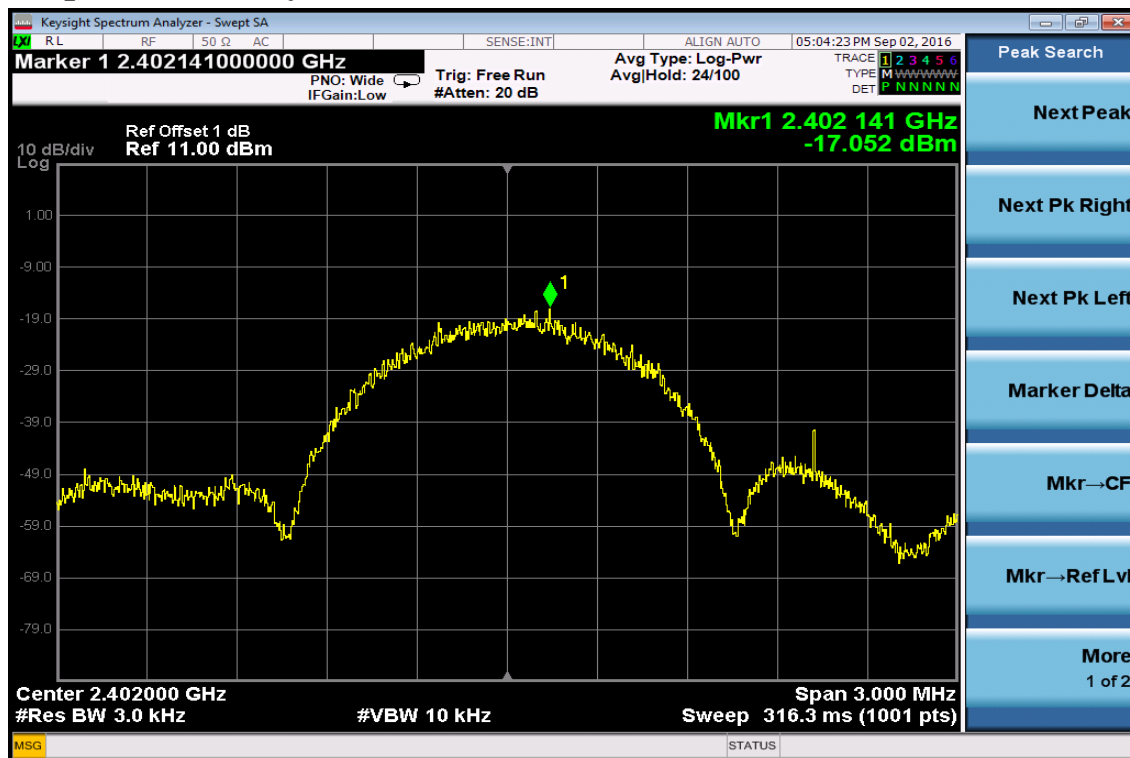

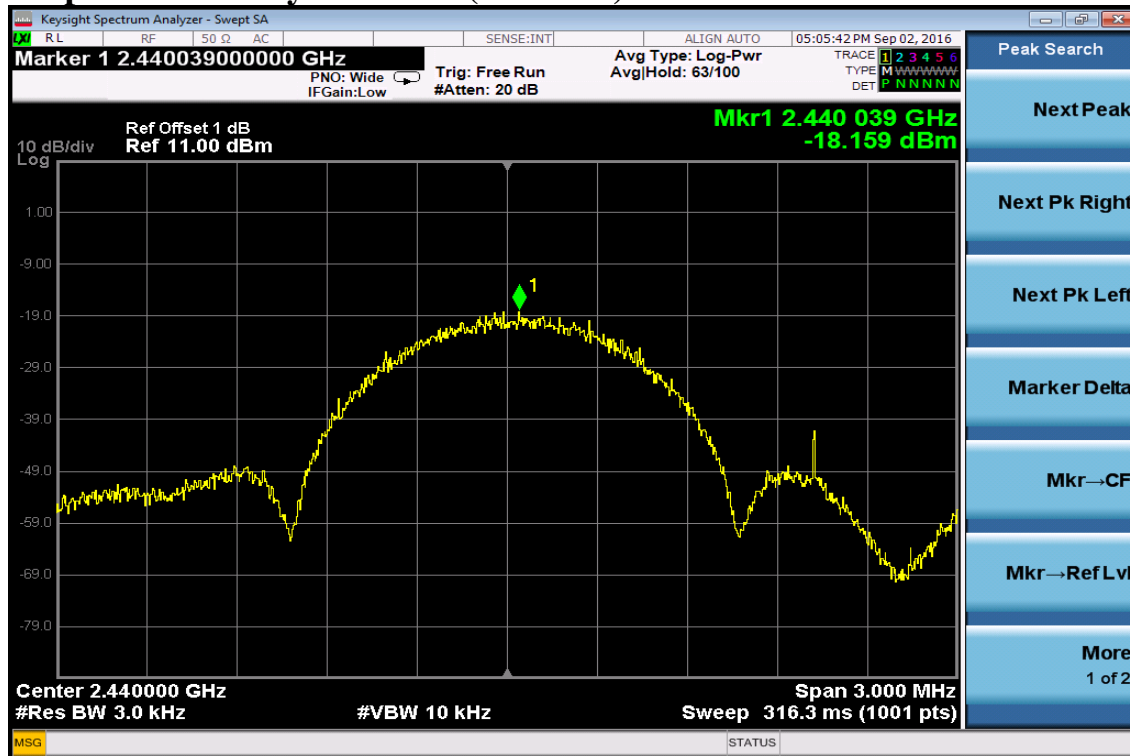

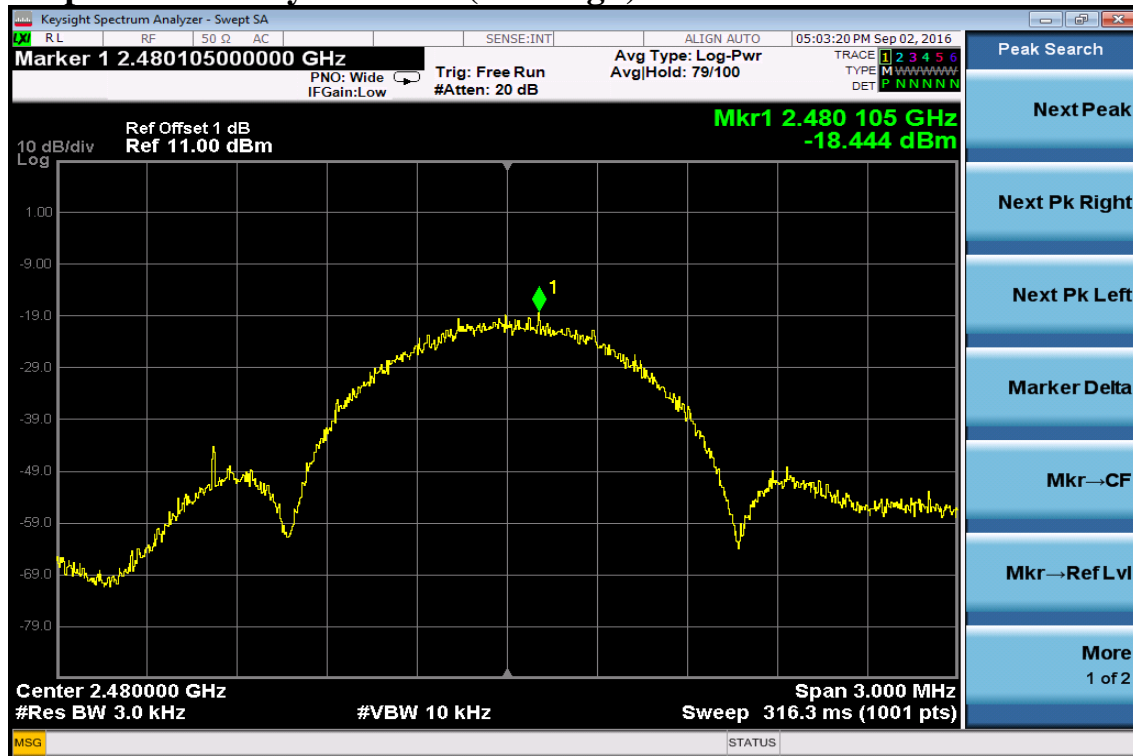
Power Spectral Density Test Plot (CH-Low)

11 ANTENNA REQUIREMENT

11.1 Standard Applicable:

According to §15.203, Antenna requirement.

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of Sections 15.211, 15.213, 15.217, 15.219, or 15.221. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with Section 15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this Part are not exceeded.
