

## How to use ?

### Bluetooth Operation:

1, Turn on the speaker with ON/OFF switch. Wait for the Bluetooth indicator light (blue/green) alternately flash.

2, Perform the pairing procedure on the Bluetooth device to detect the speaker.

When the list of detected devices appears on the display of the Bluetooth Devices, select **A8-B**.

Paring code is 0000 if needed.

### How to play music ?

Power on and connected with your Bluetooth device, the speaker can play music wireless.

You can adjust the volume / song with speaker button or use your Bluetooth device.

### How to answer the phone ?

When an incoming call arrives. the indicator light in **Green** color.

Short Press the answering button to answer.

If you want to reject the call, long press the answering button in 2 seconds
