Please read the information guide carefully before using the product.

#### Getting started

1. Please long press the button for 3 seconds for first use. The boot is succeeded when “H.TANG” LOGO shows up on the screen.
2. Scan the two-dimensional code, or download the APP at [www.hetangsmart.com](http://www.hetangsmart.com).
3. Open the App and follow the instructions to register a new account or login your account to complete the account bound.

#### Operation Steps

1. Press the button to activate the screen once it is in power saving mode.
2. The screen automatically goes into power-saving state without any action for 15 seconds.
3. When the screen is activated, press buttons to show different contents.
4. To speed up the process of “searching for the watch”, please activate the screen of watch.
5. The screen will be activated automatically under the following three situations.
  - 1) An incoming call
  - 2) Receive a new message
  - 3) Ultraviolet alarm
