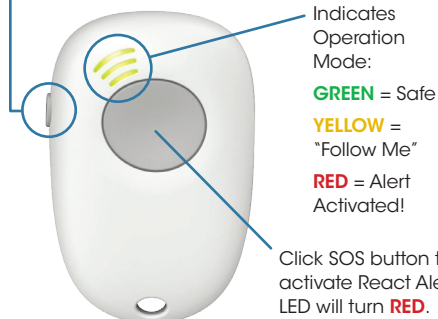
## 2 INVITE FRIENDS TO PROTECT YOU

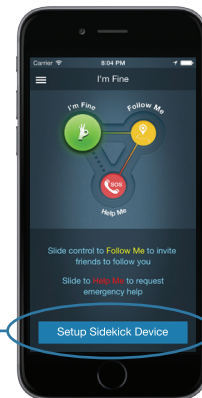

*Make sure your Bluetooth is enabled on your smart device!*

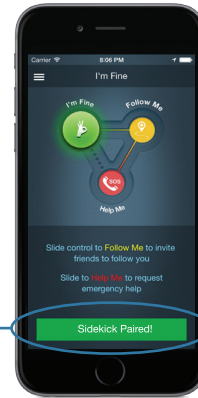
