5.2 MPE Calculation

For WiFi:

According to the formula $S=P/4\pi R^2$, we can calculate S which is MPE.

Note:

- 1) P (mW)
- 2) R = distance to the center of radiation of antenna (in meter) = 20cm
- 3) MPE limit = 1mW/cm²

For 13.56MHz: 57.49dBuV/m=0.0007 V/m< 60.77 V/m.

13.56MHz and WiFi modules can simultaneous transmitting, so the maximum rate of MPE is 0.0007/60.77+0.01666/1.0 = 0.017 <= 1.0. according to the KDB447498 section 7.2 determine the device is exclusion from SAR test.
